



## Tribe's Petition on NY Land Claim Denied by U.S. Supreme Court

The U.S. Supreme Court issued an order on March 2, 2015 in which it declined to hear the Tribe's appeal in its New York land-claim case. The Tribe had filed a petition for a writ of certiorari on November 7, 2014 where it asked that the U.S. Supreme Court to accept jurisdiction and hear the New York land claim case. The case was filed in 1986 seeking the return of the Tribe's treaty reservation in central New York State. It was dismissed by the federal district court in 2013 and court of appeals in 2014 without the Tribe having an opportunity to even present the merits of its case.

The Tribe's central New York State reservation was a 6-mile-square reservation. It was guaranteed by treaties in 1788 and 1794 and subsequently lost in a series of illegal purchases by New York State from 1818-1842. In 1971, the U.S. Indian Claims Commission determined that the Tribe had a valid property interest in its New York reservation under the 1794 Treaty of Canandaigua. Beginning in 2005, the federal courts in New York began dismissing the remaining New York land-claim cases. The courts dismissed the cases because the injustices happened so long ago and the claims were just too disruptive to non-Indians' settled expectations.

## Clinic now Open to Native Veterans

Dignitaries from state and federal veteran's agencies and Stockbridge-Munsee Tribal Council gathered at the Stockbridge-Munsee Health and Wellness Center to sign a Memorandum of Understanding which will allow Native American veterans to use clinic services and be covered by the VA. Those in attendance were Stockbridge-Munsee Vice President, Greg Miller, and Council Members, Joe Miller, Jeremy Mohawk, and JoAnn

Schedler; Tribal Lobbyist, Buck Martin; Joseph Zimmerman and Tim Deacy from VISN 12 Regional Office; Peter Vicaire from the Federal Office of Veterans Affairs; Michael Trepanier from the State Department of Veterans Affairs; and Mohican Veterans, Robert Little, Roger Miller, Harold Bowman.

Stockbridge-Munsee Vice President, Greg Miller, said tribes have had a long history of veterans. "Our people have fought in many wars all the way back to the Hudson River and we also have an MOU

with West Point. If you've ever seen the country there, no one would ever trade it for what we have now. It leads us to ponder, why would we participate when we don't always get treated the best, but we are very proud of our vets. Now we have the opportunity to make our dollar go farther," Miller said. He thanked those from the Veterans Administration and staff from the Stockbridge-Munsee Health and Wellness Center for all of their work in making clinic services available to Native American veterans. **MOU continued on page Six:**

## Stockbridge-Munsee Police Department Gains State of Wisconsin Certification

The Stockbridge-Munsee Police Department recently became certified by the state of Wisconsin so that it is now recognized as a Tribal Police Department with state authorized powers to enforce state laws.

According to Stockbridge-Munsee

Chief of Police, Jim Hoffman, the lengthy process started back in 2011 and has now come full circle. State certification of the Tribe's Police Department means our Tribal Officers are not required to be deputized under Shawano County—which in the past was the only way SMPD Officers could enforce state laws. Now, SMPD Officers are able to enforce state laws because the SMPD is


a state certified and recognized entity. Currently, Tribal Officers are still deputized under the Shawano County Sheriff through a mutual aid agreement. Yet, this arrangement is the culmination of the County and Tribe wanting to work together rather than having to work together.

# Do you contribute to pollution?

I promised in the last issue of Mohican News that I would suggest ways that community members can, individually and collectively, improve their role as "keepers of the earth". Most folks would never think of littering, they recycle and they follow our grandparents advice: waste not – want not! So, you believe that you do not pollute! We all contribute to pollution and if you do not believe that, you are not asking the right questions. The measure of a person is not in the answers they give, rather in the questions that they ask!

A very basic question is: Do you know your farmer?

Where did this food come from? For simplicity sake, let's consider only one aspect of our life – a few food items. For a simple banana, let's ask what the environmental demand is for this to reach your kitchen from the tropics? They are produced on large scale – Up to 40 square mile plantations, there is deforestation, the soil is quickly depleted, there is no natural leaf litter, more land is needed for expansion, thus more soil erosion, runoff and frequent flooding. Despite there being over 300 species we get only one. Bananas are grown as a monoculture. All these are genetically identical which increases susceptibility to a single pest, fungi or disease. This increases pesticide use to 27 pounds per acre, and 400 types of agrochemicals are used, more chemicals than any other crop except cotton. Insect pests become resistant, stronger and then more toxic pesticides are needed. This affects mammals, birds, and plants, the biodiversity disappears and forest systems become unstable.

Bananas have to be "pretty" for the consumer, therefore the waste in the banana industry is up to two tons of waste per ton of bananas, which including plastic bags, containers, banana "trees" where 30 to 40 percent are discarded, and all this waste is contaminated

with pesticides.

What can you do about not contributing to the waste of energy and resources in the food chain? Purchase as much local produced food as possible, purchase produce in season, and try to buy as much unprocessed food as possible. Find a local farmer through the Wisconsin Farm Fresh Atlas (on the internet

under that name) and get to know your farmer.

And please keep in mind that everything you use, either food or materials, started out as a natural resource from mother earth, and the fewer steps it takes to get from earth to you, the better and healthier it is for both you and the earth you depend upon.

## Earthrise



Earthrise is the name given to the photograph of the Earth taken by astronaut William Anders in 1968, during the Apollo 8 mission. Nature photographer Galen Rowell declared it "the most influential environmental photograph ever taken."

This picture is considered to be one of the most profound pictures ever taken. The first earthrise photo ever to be taken by astronauts was from Apollo 8, 1968, on Christmas Eve of 1968. The first picture was in black and white, and the moon horizon apparently looked vertical to them in relation to the spacecraft, etc. In reality there was no up and down.

The power that this picture had to make people realize just how small the earth is and how it must be taken care of is the real message taken from the photo.

## Spring Is Coming! [Logging Road Closure]

As I write this it is snowing like cats and dogs outside, but I assure you spring IS coming. As the snow melts there are a few things we all should remember:

The forest road system is valuable and in an effort to protect access for everyone, spring breakup road restrictions will be going into effect soon. Most years the road closure date is around March 15<sup>th</sup> and restrictions run for a few weeks, however to keep the roads open to tribal use as long as reasonably possible this date fluctuates. Watch for a posting of this year's closing date at any tribal posting location.

This road closure often coincides with the timeless tradition of

collecting maple sap. If any enrolled members wish to use motor vehicles on logging roads during the closure remember to contact the Forestry Department for your permit.

As the forest starts to green up remember that the restrictions to cutting/trimming of oak trees go into effect April 1<sup>st</sup>. The last few years a lot of effort has been done to reduce the prevalence of the oak wilt disease and we all need to do our part to protect this great resource.

Finally, free-use firewood permits expired at the end of the year, so please contact the Forestry Department if you need a new one for this year.

## Introduction to the Lenni Lenape, or Delaware Indians

(From Penn Treaty Museum website)

Along the creeks and streams across the Mid - Atlantic States, particularly the Delaware River, lived the Lenni Lenapes (a group of Algonquin-speaking Native Americans). From northern Delaware to southeastern New York and from the Atlantic Ocean to the forests of eastern Pennsylvania, the Lenni Lenapes made their home.

The Lenapes are also known as the Delaware Indians. They acquired this name from the English colonists of the Delaware River Valley. Captain Samuel Argall is credited to be the first European to discover a large bay of water in the year 1610.

Argall named this large bay of water the "Delaware Bay" in honor of Sir Thomas West, Third Lord de la Warr, who at that time was the governor of the colony of Virginia.

The name Delaware was then used for the river that fed the bay and given to the Lenni Lenape Indians that inhabited the Delaware Valley.

The Lenni Lenapes were not one single tribe, but made up of three groups. In the northern areas of their territory were the Munsee, "the people of the stoney country." In the middle, or central area

where Philadelphia came to be located was the Unami, or the "people down river." South of the Unami were the Unalactgio, or the "people near the ocean," who were also known as the Nanticokes.

The Unami tribe, or "people down river" as the name translates, is the group that lived at Shackamaxon, this location being just one of the settlements that they occupied, but apparently one of the more important.

The full boundaries of the Unami homeland were the northern two-thirds of New Jersey (including what was later know as Staten Island) and the adjoining parts of eastern Pennsylvania woodland, down to just below the future city of Philadelphia.

Besides the three territorial groups with their three lingual dialects that comprised the Lenni Lenapes, there were also three different matrilineal clans that were present in the groups; the Turtle, Wolf, and Turkey.

The Turtle Clan was the most important and usually the sachem, or chief of the tribal councils was from this clan.

Motion by Shannon Holsey to adopt resolution 023-15, whereas, the Tribal Council has determined that it is in the best interests of the Tribe to enter into a Software Maintenance and Support Agreement for ProgenyES-Membership Data Management Software with Tribal Data Resources, so that the Tribe can receive software maintenance services in relation to its enrollment software; and whereas, the Software Maintenance and Support Agreement contains language that constitutes a waiver of sovereign immunity, now therefore be it resolved, that the Tribal Council hereby authorizes the Tribal President or, in his absence, the Vice-President to execute the Software Maintenance and Support Agreement with Tribal Data Resources; and be it further resolved, that the Tribal Council hereby grants and approves a limited waiver of the Tribe's sovereign immunity solely for the limited purpose of enforcement of the Software Maintenance and Support Agreement with Tribal Data Resources, in the state or federal courts in the State of Wisconsin; and be it finally resolved, that the waiver of sovereign immunity for the Tribe

is also limited to the terms and conditions set forth below:

1. The limited waiver of the Tribe's sovereign immunity is granted only to and for the benefit of the parties identified as part of the Software Maintenance and Support Agreement that the Tribe has executed and shall not extend to any other entity or person.

2. The limited waiver of the Tribe's sovereign immunity contained in this Resolution shall be effective only after the parties' officially designated representatives have executed the agreements and shall only be for the term of the agreements.

3. Nothing contained in this Resolution shall be deemed consent to levy of any judgment, lien, or attachment upon any property or interest in property of the Stockbridge-Munsee Community, in excess of the amount of the agreement.

4. The limited waiver of sovereign immunity granted and approved through this Resolution does not waive the sovereign immunity of any official, employee, member or agent of the Tribe.

5. Any dispute resolution action against the Tribe, as consented to through this limited waiver of sovereign immunity, shall be brought as identified in Section 10 of the Software Maintenance and Support Agreement. Seconded by Jeremy Mohawk. Motion carried.

**PURCHASE OF SEWER CAM-Stacey Schreiber, Public Works Department**

Motion by Joe Miller to authorize the purchase of a sewer cam and have the monies come out of unallocated funds for that purchase. Seconded by Jeremy Mohawk.

certified Police Department enables SMPD to operate throughout the entire service area (and if necessary, throughout the rest of the State) and not just on tribal lands. "If tribal lands are on one side of the road and non-tribal lands across the road, we can answer a call in our service area regardless of which side of the road we are called to within our service area," Hoffman explained. In addition, state certification of the SMPD enables the Tribe to exercise full control over employment matters involving Officers. It also enables the SMPD to be eligible for state training and standards funding. Essentially, the Tribe is not operating through the County to have its police department, instead is working directly with the State of Wisconsin and directly with the County under

a Memorandum of Understanding with the Shawano County Sheriff by mutual choice.

Hoffman talked a bit about the swearing in process; he indicated SMPD Officers must be sworn in annually with the Shawano County Sheriff after each election, even if the incumbent Sheriff wins. In addition, the BIA requires SMPD Officers to be sworn in annually. "They also have to train and go through a physical assessment and written test once a year under the BIA requirements," Hoffman added.


"This [state certification] is good for the tribe; it respects the Tribe's exercise of sovereignty, while still maintaining a good working relationship with the County," Hoffman concluded.

### Claim cont from page One:

Claimants petition to the U.S. Supreme Court in hopes that recent precedent in another case signaled a change in the Court's view of land claims. However, the Tribe's appeal was denied the same way that it had previously denied the land claims of the Cayuga, Oneida and Onondaga tribes.

Tribal President Wallace Miller noted that the "Tribal Council is disappointed in the Supreme

Court's decision to deny the case" and would continue to look at its options. The Tribe has been working for almost two centuries to resolve the loss of its central New York State reservation and strengthen its connection with its homelands. "While this denial is a major blow, the Tribe may have options other than the courts, such as working with Congress on legislation to address the injustice done to land claim tribes by the Court" said President Miller.

**Mou cont from page One:** are very glad to sign this MOU," Miller stated.

Deputy Secretary of the Wisconsin Department of Veteran's Affairs, Michael Trepanier, said one of the main priorities of the state is to educate what the State Veteran's Affairs Office does. He said they run services; four cemeteries, four homeless centers, and seven nursing homes. He said there are 1,300 employees. Trepanier said they take veterans services and consolidate them to make sure veterans are not left behind.

Trepanier said he was there in place of Secretary Scocos who could not make it. He read some of the comments Secretary Scocos planned to make. He said Secretary Scocos visited here and has made efforts to learn more about Native Americans and has developed relationships with various tribes. Secretary Scocos said he learned that Tribal veterans services were small budget and he has worked on it and, partly due to his efforts, the funding has tripled. Secretary Scocos said Tribal college funding has also increased. Scocos said it was also learned that tribal clinics were not recognized and this is a deficit because more Native American's serve in the military than any other ethnic group.

Peter Vicaire from the Federal Office of Veteran's Affairs talked briefly about the Federal Grants program that helps tribes. He said the tribe would have to pay out ten percent initially but they would reimburse that amount when funds are received. He said there is also a Veteran Justice Outreach and a monthly newsletter that is available to all veterans.

Tim Deacy, spoke about the new clinic in Green Bay. He said they

are now up to 7800 patients. They have great services and are continuing to grow. He indicated they have a full range of services including dental, cardiology, and dialysis. "We are going to be part of the Medical College of Wisconsin; we have some psychology majors at our site and we're looking into providing other services like acupuncture and audiology. The Chicago area is the delivery system for the Wisconsin network so, we're excited to be here, we're enthusiastic to share the top services we have and always look forward to improving those services and ways to offer them more widely," Deacy said.

JoAnn Schedler thanked everyone and recognized all the veterans in attendance. "This is why we do this, for you and for your service. We need to get veterans here and get the benefits they deserve," she stated.

Bob Little thanked everyone for their hard work in making the agreement happen and said the next thing that is needing work on is PTSD (Post Traumatic Stress Disorder).

Buck Martin indicated work needs to be done on how elected officials are made aware of what is happening here. He said the Stockbridge-Munsee are one of the first tribes in Wisconsin to sit down with Veterans Affairs to make an agreement like this.

Council Member Joe Miller said, "There is a protocol in Indian country and recognizing our vets is right up there. I agree we need to work on PTSD. It's a disqualifier for many career paths. PTSD should not be a scarlet letter; a barrier for vets." He thanked everyone on behalf of the Tribal Council and said, "It's an honor for all of us."



Congratulations for the SM EMS responders and Casino Staff who saved a life. There is no doubt the first links in the "chain of survival" start with these groups through quick actions, response, and quality of care being provided.

We are seeing more Cardiac arrest "SAVES" by this group due to the chain of survival and quality of care. Bill has had several saves, while Craig and Roberta are fairly new with the group and following the great care and expectations from their EMS group, they too find that in their area bystanders, security, as in this case have started the survival chain, without delay as the chain of survival is as follows:

- \* Immediate recognition of cardiac arrest, and activation of the emergency response team
- \* Early CPR, with emphasis on chest compressions
- \* Rapid defibrillation

- \* Rapid advanced Life support
- \* Integrated post-cardiac arrest care

Early, quality CPR is key. This is shown by the dedication of Public Safety and EMS coordinator, local businesses and the Stockbridge-Munsee Health and Wellness Center who all promote training and support by having AED's available to public and staff as well as continued support of a ne Emergency Response Team.

There are several AED's placed throughout the area, and also carried by responders. With volume of workers and customers at North Star Casino, as well, are able to provide early access and actions within moments of occurrence as well, will well trained staff and access to AED's to create many great results in serious incidents. In this incident had deployed AED and delivered a shock.

So congratulations to this group and many times are out in the night and never seen, with very humble personalities who have someone in the group respond 24/7. These cases are not easily over once a pulse returns, care must continue to support the patient in event another heart attack would occur and rapid transport to a ER or cardiac center for intervention.



## Kidney Disease Basics

In honor of March being National Kidney Disease month, we are highlighting an important but often overlooked set of organs– the kidneys! We have two kidneys, each about the size of our fist. Their main job is to filter waste and extra water from the blood to make urine. When the kidneys are damaged, waste builds up in the body. Other important jobs of the kidneys include regulating blood pressure, red blood cell production, and calcium and other mineral levels.

For most people, kidney damage comes on slowly over many years and is due to diabetes or high blood pressure. This is called chronic kidney disease. If someone has a sudden change in kidney function– due to illness, injury, or from medications– this is called acute kidney injury. Kidney disease is a growing problem and can affect anyone, regardless of age or race.

### It's important to know:

- Early kidney disease has no signs or symptoms. The only way to know if you have kidney disease is to have lab work done.
- Kidney disease often does not go away. It tends to get worse over time and can lead to kidney failure, which may require dialysis or a kidney transplant.
- Kidney disease can be treated.

The sooner you know you have kidney disease, the sooner you can get treatment to help prevent or delay kidney failure.

The main risk factors for developing kidney disease are:

- Cardiovascular disease
- High Blood Pressure
- Diabetes
- Family history of kidney disease

### How do you check for kidney disease?

- A blood test can check your glomerular filtration rate (GFR), which tells how well the kidneys are filtering.
- A urine test checks for albumin, which is a protein that can pass into the urine if there is kidney damage.


### Steps you can take to keep your kidneys healthier longer:

- Be physically active
- Keep blood pressure below 140/90
- Limit alcohol intake
- Keep your blood glucose in the target ranges
- Take medications as directed
- If you smoke, quit!



**KEY BANK RESOLUTION/ AGREEMENT-Rob Orcutt, Lead Attorney**

Motion by Shannon Holsey to approve resolution 026-15, whereas, the Tribe has determined that it is in the best interests of the Tribe to hedge the risk of variable interest rate volatility or fluctuations of interest rates in connection with the Loan; whereas, the Tribe desires to enter

into an interest rate swap, hedge, cap, collar, option or other hedging transaction in a notional amount not to exceed a set amount under the terms of an International Swaps and Derivatives Association, Inc. (ISDA) Master Agreement (together with the Schedule to the Master Agreement and any other related documents (collectively, the "ISDA Agreement")), between the Tribe and KeyBank National Association, in its capacity as swap provider ("KeyBank"); now therefore be it resolved, Findings. The Tribal Council hereby determines and finds that (a) the whereas clauses in this Resolution are true and correct in all material respects; (b) the Tribal Council is the duly elected and governing body of the Tribe, with full power and authority to adopt this Resolution; and (c) the Tribal Council's adoption of this Resolution is in the best interest of the Tribe and the members of the Tribe.

**Section 1. Approval of Documents and Certain Provisions of such Documents.** The Tribal Council hereby acknowledges that the proposed forms of each of the Swap Documents have been presented or made available to the Tribal Council, and the Tribal Council hereby authorizes and approves the execution, delivery and performance thereof by the Tribe, including, without limitation, the entry into of Swap Confirmations and securing the payment and performance obligations thereunder with the liens granted pursuant to the Loan Documents. The Tribal Council hereby authorizes and approves that the Swap Documents include certain provisions related to the Tribe's (a) limited waiver of sovereign immunity; (b) waiver of rights to require that disputes be heard before the Tribe's tribal court or other tribal tribunal; (c) consent to arbitration or other forums for resolution of disputes arising out of the Loan and proceedings for the enforcement of remedies; and (d) consent to the application of the laws of the State of New York. Such provisions are unconditionally and irrevocably approved, and constitute the law of the Tribe, so long as the applicable documents in which such provisions appear or are referenced are in effect.

**Section 2. Authorization of Tribal Representative.** The Tribal Council hereby grants to the President of the Tribe (the "President"), such other person permitted by the law of the Tribe to act in such person's stead (the President and any such other persons being each, an "Authorized Representative"), all requisite authority and power for and on behalf of the Tribe to execute and deliver the Swap Documents and all other documents necessary to effectuate the transactions described therein,

in the form presented, or with such changes as the President or Authorized Representative may approve, that approval to be conclusively demonstrated by an Authorized Representative's decision to execute the same, and to deliver the same to KeyBank. Each Authorized Representative is further authorized, empowered and directed to take such further and additional action as such Authorized Representative reasonably determines to be necessary or appropriate and in the interest of the Tribe to complete the transactions contemplated in this Resolution including amendments or modifications of the Swap Documents necessary to obtain KeyBank's approval of the same. All acts and deeds previously undertaken by any Authorized Representative for and on behalf of the Tribe in carrying out the terms, purposes and intentions of this Resolution are hereby ratified and confirmed.

**Section 3. Authorization to Utilize the End-User Exception.** The Tribal Council hereby authorizes the Tribe to elect to claim the End-User Exception and to enter into Swap Confirmations with respect to swap transactions under the Swap Documents that are not centrally cleared; *provided, however,* that the Authorized Representative executing the Swap Confirmation may in his or her discretion elect to not invoke the End-User Exception where consistent with the Tribe's hedging policy.

**Section 4. Certification, Reliance.** The Secretary of the Tribe shall certify to KeyBank the name and signature of the Authorized Representatives, and KeyBank shall be fully protected in relying on the signature or other authority (whether or not properly used) of the person whose name and signature is so certified, or refusing to honor any signature or authority not so certified.

**Section 5. Determination.** The Tribal Council hereby determines that no law, ordinances, rules, regulations, resolutions or other actions of the Tribal Council or any of the agencies or instrumentalities of the Tribe, either written or established by custom or tradition: (a) prohibit the Tribal Council from approving the matters herein approved, the execution, delivery or performance of any Swap Documents or the consummation of the transactions contemplated therein (including any Swap Confirmations); or (b) create any obligation of the Tribal Council to submit these matters for approval of or consent from any officer, body, agency or instrumentality of the Tribe, or any vote by members of the Tribe, except from such approvals and consents that have already been obtained and are in full force and effect.

**Section 6. Limited Waiver of**

**Sovereign Immunity.** The Tribal Council hereby grants and approves a limited waiver of the Tribe's sovereign immunity to KeyBank and each Person (as defined in the Swap Documents) entitled to such waiver under the Swap Documents in accordance with the Swap Documents.

**Section 7. Granting of Security Interest.** The Tribal Council hereby confirms that payment and performance of the Tribe's obligations under the Swap Documents are and shall be secured by the security interests created by the Loan Documents.

**Section 8. Continuation of Gaming Business.** The Tribal Council hereby covenants that so long as the Swap Documents are in force and effect, and to the extent permitted by United States law, (i) it will continue to own and operate directly or through an instrumentality or agency of the Tribe, gaming facilities on the Stockbridge-Munsee Indian Reservation on trust lands, and (ii) it will continue to conduct class III gaming (as defined in the Indian Gaming Regulatory Act, Public Law 100-497, and federal regulations promulgated pursuant thereto) at such gaming facilities.

**Section 9. Repeal.** Any law, ordinances, judgments, decisions, orders, resolutions, rules, regulations or other action, of the Tribe, any instrumentality or agency of the Tribe, or any of the officers, employees, or agents, of the foregoing, whether written, unwritten or established by tradition that are in effect and are in conflict with or inconsistent with the terms of this Resolution, the transactions contemplated herein, or any provision set forth in a Swap Document, are hereby repealed and annulled to the extent of such conflict or inconsistency, and this Resolution shall supersede the same.

**Section 10. Miscellaneous.** (a) The foregoing resolutions are in addition to, and shall not be limited by, any resolutions heretofore or hereafter adopted by the Tribe and the foregoing resolutions shall continue in full force and effect and shall not be rescinded or modified without the written consent of KeyBank.

(b) If any provision of this Resolution or the application of any provision of this Resolution is held to be invalid, the remainder of the Resolution shall not be affected with respect to the same.

(c) This Resolution shall become effective as of the date and time of its passage and approval by the Tribal Council. Seconded by JoAnn Schedler. Motion carried.


