



Local Responders Attend Homeland Security Training

Stockbridge-Munsee Emergency Preparedness Coordinator Roger Miller and Fire Coordinator Molly Welch, recently completed training offered by the Center for Domestic Preparedness (CDP), in Anniston, Alabama that was specifically held for the Native American Tribes. There were 50 tribes represented in the training. The CDP is operated by the United States Department of Homeland Security's Federal Emergency Management Agency and is the only federally chartered Weapons of Mass Destruction (WMD) training facility in the nation.

Miller is a key player in the community's emergency preparedness coordinating with surrounding communities for responses from natural disasters to terrorist attacks. He said the training center in Alabama was pretty amazing. It had real streets and buildings, with real and fake people. According to Miller, the case they trained on was a terrorist attack using sulfur mustard (mustard gas). They used the real gas and all participants had to "suit up." They had participants wearing suits where some of them had special buttons on them that when pressed expressed blood or gas. "This was a very realistic training," Miller said.

ITTF Elects Vice Chair

The WisDOT Inter-Tribal Task Force elected a new Vice Chair at the March 8th meeting, held at the Ho-Chunk Casino and Hotel in Baraboo, Wisconsin.

Russell (Rusty) Barber (Lac Courte Oreilles) is the elected Chair, and Stacey Schreiber (Stockbridge-Munsee) was elected the new Vice Chair on March 8th. "The ITTF Board is looking forward to continued strong leadership from Mr. Barber and Ms. Schreiber. We have an aggressive work plan for the coming fiscal year, and our leaders are focused on continuing to articulate and facilitate a clear direction in joint transportation systems between each of Wisconsin's 11 federally recognized Indian Tribes and the Wisconsin Department of Transportation," said Agnes Fleming, WisDOT ITTF Coordinator.

The Chair and Vice Chair will serve for a term of one year. The Chair shall preside over the ITTF meetings, have signatory authority, act as the spokesperson for the ITTF, and appoint chairs for subcommittees and work teams. Additionally, the Chair shall provide regular reporting to the Tribes, agencies and the Great Lakes Inter-Tribal Council (GLITC) at their quarterly meetings.

The Vice Chair shall perform the duties of the Chair in the event the Chair is absent, and after one year of service, the Vice Chair shall succeed to the position of Chair. Congratulations to Mr. Barber and Ms. Schreiber!

State of Wisconsin Indian Tribes Address



MADISON (AP) — The Lac Courte Oreilles Chippewa band's chairman is using the annual State of the Tribes address to dispel American Indian stereotypes.

Mic Isham told a joint session of

the state Senate and Assembly on Tuesday that people still ask him if American Indians live in teepees and question why they don't know their own language. He said he tells people they live in houses and Chippewa youth know their native language well.

He said Wisconsin schools must do a better job educating children about tribal life.

He called on legislators to recognize tribal contributions to the state and erase perceptions that Wisconsin's tribes are a burden. He also implored legislators to protect the environment, ripping a water body development bill and lack of action to slow chronic wasting disease.

New Cell Phone Law in Effect for WI Drivers

MADISON, Wis. - If a law enforcement officer sees you talking on a handheld cell phone while driving in a construction zone, you could be pulled over and fined.

Gov. Scott Walker has signed into law a bill that imposes a fine of \$20 to \$40 for drivers who get caught violating the new law. A second violation within one year would bring a fine up to \$100. An exception is made for a driver using a handheld cell phone in a construction zone if there is an emergency.

Nick Jarmusz, a spokesman for AAA-Wisconsin, said it's more important now than ever to be fully alert while driving in construction zones.

"There are people - construction workers - that are right there on the roadways and very vulnerable," he said, "so, it's critically important that motorists are alert and watching out for them as much as possible."

Major construction zones involve the Zoo Interchange on Interstate 94 in Milwaukee and another huge

construction project involving the Highway 18-151 interchange on the Beltline Freeway in Madison. Jarmusz said that with spring here, there will be highway construction projects all over the state. He said he hoped the new law will help protect the men and women who work on these projects.

Many drivers are under the impression that hands-free cell phone use is safer, Jarmusz said, but added that it's absolutely not true.

"There's a large body of research out there, some of which Triple-A itself has done," he said, "that demonstrates that even hands-free distraction such as talking on a Bluetooth or using voice commands to compose text messages can also be dangerously distracting."

According to AAA research, more than 80 percent of drivers view distracted driving as a bigger problem now than just three years ago. It's estimated that distracted driving is a factor in at least 3,000 highway deaths each year.

Veterans of the Menominee Nation Gathering of Warriors Powwow 2016

The Veterans of the Menominee Nation (VMN) are proud to announce their 27th Annual Gathering of Warriors Powwow to be held May 19 to 22, 2016 at the Woodland Bowl in Keshena, Wisconsin.

This year all Viet Nam and Viet Nam Era veterans will be recognized and honored. Veterans from all branches of military service, male and female, are invited to attend a weekend of special ceremonies to honor all veterans, make new and enjoy old friendships and visit the vendor craft and food stands on the powwow grounds.

On Thursday, May 19 VMN in partnership with the Menominee Tribal Clinic, the Menominee veteran's association is sponsoring a "Run/Walk" at Veterans Park in downtown Keshena beginning with registration at 5:00 p.m. Participant prizes and awards will be given. Refreshments will be served.

On Friday May 20 at 6:00 p.m. the opening ceremony begins with a prayer and other ceremonial activities followed by the raising of twenty-one family flags of deceased Menominee veterans at the base of the Woodland Bowl. The family flags along with "Big John" and a large POW/MIA flag will be flown throughout the weekend powwow.

That ceremony will be followed by the awarding of a special VMN "red" jacket to outstanding community members for their service to the Menominee community.

The evening will end with several local musical groups performing for the enjoyment of attendee's.

Saturday, May 21, is Armed Forces day and begins the powwow activities with a Grand Entry at 1:00 p.m.

There will be honor guard units from several Wisconsin tribal communities as well as honor guard units from Upper Michigan, Washington State, Illinois, South Dakota, Arizona and Minnesota.

Throughout the afternoon there will be special honor dances, a powwow princess contest and other special presentations.

Saturday evening begins with a

7:00 p.m. Grand Entry. A highlight of the evening is the retiring of the colors when the flags are taken out of the Woodland Bowl with the Veterans Snake Dance. The veterans carry the flags out in single file similar to a combat patrol with other veterans firing their rifles until all the flags have returned to base.

The rest of the evening features exhibition dances as powwow dancers get to show their style of dance and other honor dances requested by families to honor their family, fellow veterans and community members.

Sunday May 22 begins with a 12:00 p.m. Grand Entry which precedes the honoring ceremonies for all Viet Nam and Viet Nam Era veterans. The honoring ceremony features a drum group singing songs recognizing each branch of the military whereby veterans dance to the song of their respective branch of service.

The afternoon activities include a special presentation by Rolling Thunder, Chapter 3 from Green Bay who do their "Table Ceremony" to honor and to remind people of our POW/MIA's. The powwow concludes with the VMN give-away and a raffle drawing.

Each powwow Grand Entry will be led by a male and female veteran in their traditional dance regalia followed by the honor guards units, powwow royalty and all the dancers.

Two veterans serve as the master of ceremonies who along with the veteran arena director keep the powwow activities moving along. The host drum and other invited drums provide the dancers with powwow songs for their dancing.

All veterans, veteran honor guard units, elders 55 years of age and older, children under 5 years are admitted free. Weekend buttons are \$8.00 each and single day passes are \$5.00 each.

April is National Safe Digging Month

(MADISON) - Spring has arrived and so has Safe Digging Month. April is recognized by underground utility damage prevention stakeholders as National Safe Digging Month. The Public Service Commission of Wisconsin (PSC) reminds residents and professional excavators to always call 811 before they dig.


«Safety is our top priority and April marks the start of spring digging season,» explained PSC Chair Ellen Nowak. «A free call to Wisconsin's Diggers Hotline, at 8-1-1, will notify the appropriate utility companies to mark the underground lines at the excavation location so you can work safely around them.»

The PSC is asking Wisconsin residents to participate in the 811 promise:

1. Make a free call to 811 a few days before digging.
2. Wait the required time.
3. Locate accurately.

4. Respect the marks.
 5. Dig with care.
- National Safe Digging Month promotes awareness of safe digging practices across the country and is meant to serve as a reminder to always call 811 before every digging project, large or small, to prevent employee injuries, repair costs, and costly fines, which can occur when an underground gas, electric, communications, water or sewer line is unintentionally hit.

811 is a free, FCC-designated national number that connects callers from anywhere in the country to their local one call center. The one call center will then alert the appropriate underground facility owners so they can dispatch locators to mark the approximate location of their lines with paint or flags, after which professionals and homeowners can dig safely around the marks.



Thank You from the Arvid E. Memorial Library/ Museum

MacDougall, at the age of 83, stated to the Library/Museum Manager, I am anxious to place the materials on the Mohican Nation that I have accumulated over the past few decades where they can do the most good, and the Arvid E. Miller Library/Museum seems to me to be the most likely place.



A word about myself: I graduated from Harvard College and Columbia Law School, and then in 1958 joined the United States Foreign Service where I remained for 28 years—mostly in tropical countries—before retiring home to Cooperstown in 1987. I became interested in the Mohican people when I began studying the life and works of James Fenimore Cooper, and quickly learned how his most famous novel, “The Last of the Mohicans” (1826) had literally killed off a people who were, and are, still very much alive, despite centuries of mistreatment. I founded the James Fenimore Cooper Society in 1989, and am currently its Correspondence Secretary and webmaster (see: <http://external.oneonta.edu/cooper/>)

I also began to study the Mohican Nation, and in 2003 gave a paper on “James Fenimore Cooper and the Mohicans” at the 4th Annual Algonquian Peoples Conference of March 8-9, 2003 in Albany, NY. Later, with the aid of Steve Comer, I developed the signage at the overlook of “Cooper’s Cave” (named for incidents in “The Last of the Mohicans” novel), to make sure that they gave full credit to the Mohican Nation as a living people.

In 2006 I gave a six-hour course on “The Survival of the Mohicans” as a volunteer for the Center for Continuing Adult Learning in Oneonta, New York, an institution with which I have been connected for over 20 years and have given

some 30 volunteer courses. I attach the text of these lectures. For over a decade I have subscribed to the Mohican News to keep abreast with what is happening in the Mohican world of today.

I have also acquired, over the years, just about every book available concerning the Mohican people, as well as many scholarly papers on the subject, and attach a bibliography of what I have got.

I should like to donate to the Miller Library/Museum any or all the books listed in this bibliography, as well as a file box of papers, newspaper items, and other material about the Mohican people which I have come across.

The Historical Committee requested to accept the entire collection and Mr. MacDougall agreed.

<http://science.howstuffworks.com/mustard-gas1.htm>, mustard gas or mustard agent is a poisonous gas that falls in the first group, along with even more lethal chemical agents such as chlorine gas and sarin. Tear gas, for example, is a non-poisonous gas that falls in the second category. Although tear gas is an effective weapon against advancing soldiers, it has no deadly effects. The same can’t be said about mustard gas.

Mustard gas, also called sulfur mustard, gets its name from its sometimes yellow appearance and mustard like smell. It’s referred to as a blister agent or a vesicant, and comes in vapor, solid or liquid form. Other blister agents include nitrogen mustard, lewisite and phosgene oxime.

Blister agents are no fun. Once in contact with an unsuspecting victim, they damage skin and internal areas such as mucous membranes inside your nose and throat. Mustard gas is an alkylating agent, meaning its chemicals destroy [DNA](#) and [cells](#) and liquefy tissue. In essence, mustard gas kills tissue and membranes in the areas it touches. Alkylating agents also are often used in cancer drugs.

As you might have picked up, mustard gas is very dangerous, especially compared to tear gas. If you measured mustard gas on a scale of one to 10, with 10 being the scariest, mustard gas would come in around a seven. Compared to Zyklon-B, the gas pellets used in gas chambers during the Holocaust, mustard gas seems tame. But that doesn’t mean it hasn’t caused its fair share of fatalities. A little bit later on, we’ll



look at some of the devastation mustard gas brought on during warfare.

The CDP develops and delivers advanced training for emergency response providers, emergency managers, and other government officials from state, local, and tribal governments. The advanced hands-on training enables responders to effectively prevent, respond to, and recover from real-world incidents involving acts of terrorism and other hazardous materials.

Health Center Telephone System

The Health Center has undergone a change in the telephone system that it uses. Many patients may have noticed this change and we would like to explain how this change may affect you as a caller. Because of this change more patients may experience some type of automated message or voicemail.

All of the extensions at the Health Center now have two lines. While this enables two calls to come in at the same time, it still only allows us to speak to one person at a time. The new phone system will not inform you that we are on another line assisting a patient.

All telephone extensions have voicemail, so it is very important that you leave a message when you call so that our staff may return your call. Please leave a message as to what your needs are and we will be happy to return your call.

This is especially true when calling the triage line for **same day appointments**. If you do not leave a message as to what your concerns are the staff will not know the importance of your call. If you let them know what your concerns are they can address the crucial calls first, all other calls will be returned in the order in which they are received.

If you call either the pharmacy or the triage line and do not wish to listen to the message, you have the option of pressing 2 to skip the message. This will take you directly to the voicemail, at which time you will need to leave a message.

Think Before You Drink

April Alcohol Awareness Month is a time to evaluate drinking habits. The Wisconsin Department of Health Services (DHS) urges all state residents to take time to self-examine their drinking habits. April is Alcohol Awareness Month, a national observance to increase understanding of alcohol use problems, treatment, and recovery. “Alcohol is the most commonly abused drug in Wisconsin,” said DHS Secretary Kitty Rhoades. “This is a good time to take a minute and think about the effect alcohol has on your life – on your relationships, your job, and your health. If you decide it’s time to change, there is help available.”

One way to identify usage patterns that may reflect problems with alcohol is to take this quiz, known as the CAGE Questionnaire. There are four questions.

1. Have you ever felt you could cut down on your drinking?
2. Have people annoyed you by criticizing your drinking?
3. Have you ever felt bad or guilty about your drinking?
4. Have you ever had a drink first thing in the morning (“eye-opener”) to steady nerves or get rid of a hangover?

Individuals who answer yes to one or more of these questions should

assess the impact alcohol use is having on their life. Talk to a health professional if you have questions or concerns, or if you want to quit, and need help.

The federal government’s *Dietary Guidelines for Americans* state if alcohol is consumed, it should be in moderation – up to one drink per day for women and up to two drinks per day for men. Individuals under the age of 21, and those who are or may be pregnant, should not drink at all. People using prescription medication or under the care of a physician should check with their doctor about any use of alcohol.




