pull it out of the receptacle. So, they cut that down by 1/4th and now have a 36" trash bag and put a false bottom in the receptacle to raise the height to make it easier to pull out when it needs changing. This in turn is less waste by using less product and more efficient for the employees to change out a trash bag.

Switching from rolled paper towel to individual fold towel has greatly reduced waste. The individual fold is more absorbent and compresses more in the trash bag. The cost of the fold towel is \$1.50 more per case than rolled towel but use 2 cases less per week of trash bags at \$45.00 per case.

Standard urinal and toilet flushes were about 4-4.5 gallons per flush

cycle. The low flow units that are used now have flush cycles of 1-1.5 gallons.

Food composting waste is going to be greatly reduced by using a food grinding machine that squeezes all the moisture out of the food. It reduces the weight of the food 8:1. There was already a solid foundation to get to the level the Northstar Mohican Casino and Resort is now at and that foundation was created by Brett Duffek. What Brett created pathed the way for the rest of the team to accomplish these necessities to provide a greener and more efficient business. Thanks to all Brett's hard work and dedication the Northstar Mohican Casino and Resort is now a Travel Green Certified Wisconsin Business.

Stockbridge-Munsee Community Water Resources Program Volunteer Information

The Stockbridge-Munsee Water Resources Program ("Program") is inviting our tribal community to become involved in field work activities to learn and become active in water resources management in our tribal community. The field work is conducted between April and November every year. Field work can include water quality sampling, fish shocking or wetland restoration project maintenance.

Volunteers assisting with the Program's field work can be members of the tribal community or tribal employees. Volunteers are unpaid, except that tribal employees who "volunteer" with approval from the Program and their supervisors can have the time worked for the Program charged to our funding. The Program will provide waders and equipment for volunteers to use.

The volunteer should be able to easily navigate a half mile on foot and able to carry up to 75lbs. In addition, the volunteer will need to wear neoprene waders and feel comfortable walking in-stream in water depths up to 3.5 to 4.0 ft. In-stream terrain can vary from flat sandy bottom to very large boulders. Volunteers must be able to swim. Volunteers who work with minors must hold a valid elder/youth license.

Minors who can meet these requirements are welcome to participate with their parents' approval.

Those interested in volunteering will need to sign a participation agreement. There will be agreements for community volunteers and for employee volunteers at the training. Training will be held from 11AM to 1PM on March 19th, 20th, 21st. Training will be held at the Clinic and lunch will be provided.

STOCKBRIDGE-MUNSEE COMMUNITY WATER RESOURCES PROGRAM

COMMUNITY VOLUNTEER PARTICIPATION AGREEMENT I, the undersigned, wish to volunteer time to assist with the Stockbridge-Munsee Community's Water Resources Program ("Program") with field work.

I understand this field work can include water quality sampling, fish shocking or wetland restoration project maintenance. Field work is conducted by the Program between April and November every year. In-stream terrain where field work is conducted can vary from flat sandy bottom to very large boulders and have occasional deep spots.

I understand that I will need to wear neoprene waders and be able to walk through water with in-stream in depths up to 3.5 to 4.0 feet. I must be able to easily navigate a half mile on foot and able to carry up to 75 pounds. While swimming is not anticipated to be required for this field work, I must be able to swim in order to be eligible to participate as a safety precaution.

I understand the Program will provided any required training and equipment required to do the field work. I also understand that the Program may take pictures of field work and I grant the Program all rights to such photographs or recordings, including the right to use of my image.

I also understand that I will not be paid for my time training for or assisting the Program with field work.

I understand that I will be performing field work in an outdoor environment and that there are risks associated with doing this field work. In this space we will be capturing data regarding growing conditions, labor needs, and harvest Documentation weights. these data points is critical, and all information will be

recorded by the agriculture department staff and shared with the community at the end of the growing season. Another part of this project focuses on collecting a market analysis for products grown, and we are excited to distribute this produce to the community in a new way for 2019. Community members will find this produce available through use in meals at the Elderly Center, for sale through the C-store, and through new market program called Community Supported Agriculture, look for more information on this program shortly. It is our hope that through this new program we

will be able to better gauge the local market and community's interest in investing in small scale agriculture and better determine how we can continue to grow this program.

We are also excited to grow our traditional seed saving program. The agriculture department will be teaming up with Warren Miller to expand on some of the great work he has started with traditional foods. We will be growing varieties of corn, beans, and squash in a couple of areas out in Red Springs. Through this partnership we hope to grow our traditional seed bank and provide the community with more traditional food options. We will also have educational events around this program and will share dates

with the community throughout the growing season.

This winter we have also been working on a feasibility study that is assessing the viability of a small-scale agriculture venture for the tribe. Thank you to everyone who participated in the community survey last fall, we are using the survey results to guide further research on this project. We are planning on wrapping up this study in April and will share the results with the community.


