As the forest starts to green up, remember that the restrictions to cutting/trimming of oak trees go into effect April 1st. The last few years a lot of effort has been done to reduce the prevalence of the oak wilt disease and we all need to do our part to protect this great resource.

Finally, free-use firewood permits expire March 15th, so please contact the Forestry Department if you need a new one for this coming year.

Congress enacted the Indian Child Welfare Act (ICWA) in response to alarmingly high numbers of Indian children being removed from their families and communities, many unnecessarily. Years of extensive research and testimony by Congress and others demonstrated that state courts, state agencies, and private adoption agencies often worked counter to the best interests of Indian children. In enacting ICWA, Congress created minimum federal standards for the removal of Indian children from their families, and it established procedural safeguards to ensure that state courts fully consider the best interests of Indian children when deciding Indian child custody cases.

The Fifth Circuit Court of Appeals will review the lower federal court decision in Brackeen v. Bernhardt that ignored centuries of Supreme Court precedent to strike down the Indian Child Welfare Act (ICWA), a law that protects the best interests of American Indian and Alaska Native children. The threejudge appeals panel will hear oral arguments in the case this morning on behalf of two federal agencies—the Departments of the Interior and of Health and Human Services—and five tribal nations— Cherokee Nation, Morongo Band of Mission Indians, Navajo Nation, Oneida Nation, and Quinault Indian Nation.




## of Menominee Restoration Day

In recognition and celebration of the date the College of the Menominee Nation held a Reader's Theatre entitled, "Menominee Restoration Day: Reader's Theatre That Helps Us Remember". The talents of one Stockbridge-Munsee Community member, namely Shawn Stevens, were prominently displayed in the event, as Shawn portrayed a total of six characters in the reading.

Writer and director Ryan Winn said, "The production's success reinforces that theater is still the medium for Menominee storytelling. CMN plans to continue to draft scripts that inspire future generations by looking to

## Seed Planting at Family Night

Recently the Mohican Family Center held a Family Night which consisted of planting seeds to grow vegetables. A light dinner of fresh salad and fixings was also

When planting seeds you must begin with getting the supplies ready. You will need seed starting mix. These mixes don't contain any actual soil, but they provide ideal conditions for sprouting seeds. Most importantly, they provide a good balance of drainage and water-holding capacity, and they minimize problems with disease on vulnerable seedlings. You will also need seeds, water, planting containers with drainage holes, and a few good helpers. You will then mix the seed starting mix and just enough water in a bowl to get the mix nice and damp. Do not use so much water you turn the mix into mud. Next, you put the seed mix into the containers and fill them to the top and level off. Check the seed packet for planting depth. The rule of thumb is to plant the seed two-to-three times deep

as the seed is wide. If you sow seeds too deeply, they won't have enough stored energy to make it to the surface. Make sure to plant extra seeds, because not all of them will germinate. Once you are done sowing place the containers in a warm sunny place and you will soon see them sprout.

threats and legislative actions they faced. We hope to get the message to everyone who sees our show to both remind and inspire them to celebrate Menominee past while looking to the future."

"This production is dedicated to the heroes of Menominee Restoration, which includes over 1,000 members of DRUMS. While we couldn't name every one of them in a single script, their unified resistance against unenviable odds is the reason we're all here today. We hope we've honored them in a good way," said Winn.

From CMN specifically, Winn would like to thank Dr. Paul Trebian, Dr. Diana Morris, Coleen Waubanascum, Melinda Cook, CMN's maintenance department, and Quintin Fernandez. He also wanted to thank the Wisconsin Arts Board and the Seventh Generation Fund for Indigenous People for supporting our efforts.

And finally, he thanked Principals Jim Reif at the Menominee Indian High School and Lori Corn at the Menominee Tribal School for bringing their students to our show, and, in Mr. Reif's case, enabling us to use his wonderful auditorium

and Alaska Native children that it serves. A nationwide coalition of 325 tribal nations, 57 Native organizations, 21 states, 31 child welfare organizations, 7 members of Congress, and dozens of scholars of federal Indian law and constitutional law also stood with the parties in court during their amicus briefs supporting Native children and families through the Indian Child Welfare Act.

"We look forward to the appeals court's review today of the lower court's decision," said Dr. Sarah Kastelic, executive director of the National Indian Child Welfare Association. "The district court ruling misapprehends the government-to-government relationship between tribal nations and the federal government for over two hundred years. Never before has a federal court found ICWA unconstitutional-in fact, both federal courts and state high courts have rejected challenges to ICWA's constitutionality time and time again since its enactment in 1978."

President Jefferson Keel of the National Congress of American Indians stated, "Indian Country welcomes the Fifth Circuit Court of Appeals' review in this matter as the district court's clearly erroneous ruling has led to uncertainty

for all American Indian and Alaska Native children and their families. Congress, through its unique relationship with tribal nations, enacted the Indian Child Welfare Act to stop concerted efforts to actively remove Native children from their families. Today ICWA is needed more than ever to ensure that Native children, the future leaders and innovators of Indian Country, are protected and, where possible, can grow up rooted in their cultures, languages, and communities."

"ICWA is vital to the well-being of Native children and the stability and integrity of Native families today. We can't afford to go back to the days when massive numbers of Native children were forcibly removed from their loved ones and were often separated from their families with little hope of ever seeing them again. It's not an option," said the Protect ICWA Campaign. The National Indian Child Welfare Association, the National Congress of American Indians, the Association on American Indian Affairs, and the Native American Rights Fund urge the ruling of the district court to be reversed.

A decision by the Fifth Circuit Court of Appeals is expected within a few months after the oral argument.





#### Bananas

The scientific name for banana is Musa, from the Musaceae family of flowering tropical plants, which distinctively showcases the banana fruit clustered at the top of the plant. Despite some negative attention, bananas are nutritious and may even carry the title of the first "superfood," endorsed by the American Medical Association in the early 20th century as a health food for children and a treatment for celiac disease.

Bananas are a rich source Vitamin B6, Potassium, Vitamin C, Fiber, Magnesium, and Manganese. One serving, or one medium ripe banana, provides about 110 calories, 0 grams fat, 1 gram protein, 28 grams carbohydrate, 15 grams sugar, 3 grams fiber, and 450 mg potassium.

Bananas and Health

Cardiovascular health. Bananas are an excellent source of potassium, a vital mineral and electrolyte in the body that carries a small electrical charge. Potassium is also needed to maintain a healthy balance of water in cells, and offsets the effects of excess dietary sodium.

An imbalance in the diet of too little potassium and too much sodium can lead to high blood pressure. Excessive sodium can lead to a buildup of fluid in the blood, placing pressure on the walls of blood vessels and eventually causing damage. Potassium helps the body to flush out extra sodium in the urine, and eases tension in blood vessel walls.

Digestive health. Not just easy to eat, bananas can help replete electrolytes like potassium that are lost with diarrhea or vomiting and contain resistant (especially starch if using cooked less-ripe green bananas) that may support gut healing. Unripe bananas contain resistant starch, a type of carbohydrate that "resists" digestion in the small intestine. It is absorbed slowly and does not cause sharp rises in blood sugar.

Storage

Store at room temperature away from direct sunlight, do not refrigerate green bananas as this can disrupt normal ripening. To speed up ripening, store in a brown paper bag or place near ripe fruit, which emits ethylene gas that causes ripening.

On the flipside, if you wish to slow ripening, store bananas away from other ripe bananas or fruits. Do not store in plastic bags as this traps



excess moisture and may promote rotting.

Prepare

Slice ripe banana into a fruit salad. Squeeze a bit of acid like apple cider vinegar, orange juice, lime, or lemon onto the bananas to prevent darkening too quickly.

Substitute an equal amount of mashed banana for butter for dense baked goods like muffins, quick breads, and cookies. Using banana may cause the product to bake faster, so check for doneness several minutes earlier than usual or reduce the oven temperature by 25°F. The bananas will also add sweetness, so reduce the amount of added sugar in the recipe by one-quarter to one-half.

For a frozen treat, slice a peeled ripe banana in half (in the middle) and insert a popsicle stick or skewer into the flat end. Dip banana into yogurt and coat evenly; sprinkle with nuts, chopped dried fruit, cinnamon, or other favorite toppings and freeze for several hours.

For an easy dairy-free ice cream alternative, peel, chop, and freeze two medium bananas. Place into a blender or food processor and add a few tablespoons of liquid (water, dairy or plant milk, or coconut water).

Blend until smooth. Add extra liquid if additional creaminess is desired. For a different flavor, add 1-2 tablespoons unsweetened cocoa powder or nut/seed butter, a splash of vanilla extract and cinnamon, or ½ cup frozen berries. Did you know?

In many countries, banana and plantain leaves are recycled as food wrappers, such as to hold tamales and meats. They are also used to cover or wrap various foods while cooking to help seal in flavor.

Banana peeis contain chemicals in the form of antioxidants and have long been used in traditional medicine as an antiseptic and anti-inflammatory to promote wound healing such as for bug bites, minor burns, and sunburns.

As a simple home remedy, the inside of the banana peel is pressed on a wound for several minutes.

Terrio to adopt resolution 038-19, now therefore be it resolved, the Tribal Council hereby authorizes the Tribal President or, if unavailable, the Vice-President to execute the EnterpriseRx®contractdocuments with McKesson; and be it further resolved, that the Tribal Council hereby grants and approves a limited waiver of the Tribe's sovereign immunity solely for the limited purpose of enforcement of these contract documents; and be it finally resolved, that the waiver of sovereign immunity for the Tribe is also limited to the terms and conditions set forth below:

- 1. The limited waiver of the Tribe's sovereign immunity is granted only to and for the benefit of the parties identified as part of the agreement(s) that the Tribe has executed, and properly identified third-parties under such agreement(s) and shall not extend to any other entity or person.
- 2. The limited waiver of the Tribe's sovereign immunity contained in this Resolution shall be effective only after the parties' officially designated representatives have executed the agreement(s) and shall only be for the term of the agreement(s).
- 3. Nothing contained in this Resolution shall be deemed consent to levy of any judgment, lien, or attachment upon any property or interest in property of the Stockbridge-Munsee Community.
- 4. The limited waiver of sovereign immunity granted and approved through this Resolution does not waive the sovereign immunity of any official, employee, member or agent of the Tribe.
- 5. Any dispute resolution action against the Tribe, as consented to through this limited waiver of sovereign immunity, shall be brought in the form and venue identified in the agreement(s). The law to be applied, if no law is otherwise identified, shall be federal law. Seconded by Craig Kroening, Jr. Motion carried.




