



Council visits for Papscanee Island pipeline issue

By Bonney Hartley Vice President Matthew J. Putnam and Councilman Craig Kroening Jr. visited Mohican homelands recently for involvement in historic preservation issues.

The primary purpose of the visit was to participate in the ongoing consultation for the National Grid Pipeline E37 project that would impact sensitive Papscanee Island in the Hudson River near Albany, New York. Their involvement at the meeting along with the Tribe's consulting archaeologist and engineer was an important demonstration of the significance of Papscanee Island and its place in safeguarding Mohican cultural heritage. As a result of the onsite meeting, the developers have been directed by the Army Corps of Engineers to further examine any other alternatives that would avoid impact to this important, National Register-nominated site. I will continue to provide updates as the consultation continues.

While in the area, the Council members also assisted in returning eight buckets full of stone tools back to the earth. They had been a long way to providing leadership collected from a site over several for several cultural heritage decades by a local family, who issues-particularly the current had recently given them to our threat to Papscanee Island.

New York historic preservation office. Thanks to the work of our consulting archaeologists at Morton Archaeological, we had the expertise to identify and assess the range of artifacts and better understand the significance. The artifacts were respectfully bundled with medicine and returned to an area on the site where they had originally come from.

In addition, the Council representatives viewed the location of a mural of Native dancers that will be on a highvisibility new overpass to the Albany International Airport. The dancer mural is one aspect of a federal consultation project that our Tribe's historic preservation office has been involved in for several years as mitigation for the project's impact to an archaeological site. The bridge overpass are currently and under construction, and Council members were able to walk the site with the project engineer and view the mural location in advance of the installation later this year.

It was, as always, a busy trip in the homelands. The on-site visits went

They gave a history of how victims are enticed away to be used to make money. The people that are taken away, never get to see their family again. Those taken may be listed as "missing" but are still alive. Although women and children are mostly enticed, and taken away, men are also victims. Those taken are threatened, beaten, and kept away from the public until they are ready to start working. They may want to leave but threats against family members are made and they stay, to keep their family safe. Those who do try to escape may be killed. It was stated that criminals target vulnerable people on social media sites. Parents at this session were warned to always be aware of, and to watch the social media that your children and teens may be participating in.

Talk to your children about social media and human trafficking. Several persons in the audience had questions and seemed very interested in the topic. Game Warden/Officer Beau Miller even mentioned a trip he took up north and how he learned of so many Native American women that were missing.

After the meal and presentation, there were two (2) games for families to be involved in. The first game was called the Majik Carpet Ride. A team of family members had to stand on each corner of a blanket. They had to flip the blanket over to the other side without stepping off the blanket. If their shoe touched the blacktop at any time, they were disqualified. 1st place went to Diondre Shawano and family. 2nd place went to LeAnthony Pecore family. The second family game was the Balloon Toss. Four team members, with two each holding a bath towel had to toss a balloon back and forth without breaking the balloon. Teams were provided a practice round before starting. 1st place went to the Brandon Merckes family and 2nd place went to Kemawin Dess and family.

There were four (4) large door prizes given out at this event: a shade shelter, with a foldable table, lawn chairs and a small cooler went to Martha Goldsberry. A basket with kitchen items; towels, small rugs, pots n pans, a baker set, hot mitten; went to Mike Penass. Kids fishing poles, a tackle box, kids lawn chairs, a cooler went to Dominek Gourrean. The bean bag chair, candy, a small area shag rug, a tablet, went to Olivia Malone. We also had ten (10) \$10.00 gift cards that were won by various community members.


