

Fish Shocking Study on the Red River



Thomas Kazik II – News Reporter The Stockbridge Munsee Community took part in some fish shocking. Water Recourse Technician Josh Jensen, Hydrologist Alex Brauer, and Wetland Specialist Mike Jones used a barge shocker to do a fish study on the Red River. The three of them were assisted by Belasaire Vele and Logan Blum who both work as summer youth helpers.

Station lengths are determined by multiplying mean wetted stream width by 35. Mean stream width is found by walking a large section of the stream, larger than the estimated station length, and making 10 measurements of wetted stream width. The average of the 10 measurements

2020 Election News

The Caucus is being held on August 15, 2020. For those of you who are running for Tribal Council in the upcoming October 10, 2020 election please put your platform and a picture together and submit them to the Mohican News at mohicannews.submissions@mohican-nsn.gov by **September 4, 2020** at 4:30 pm.

For those of you who decide to run after the Caucus, the Ordinance states: **Section 49.5 Nomination Outside of the Caucus and Close of Nominations**

(A) Any eligible tribal member shall have the privilege of running for tribal council if not nominated during the caucus provided that he/she presents to the Election Board a petition form bearing the name, enrollment number, date of birth and signature of at least fifteen (15) qualified tribal voters prior to the close of nominations.

(B) Nominations shall be closed as of the end of the working day on the Friday before the first (1st) Saturday in September. **This year that will be September 4, 2020 (My emphasis).**

The Primary Election (if needed) will be held on September 19, 2020.

The Election will be held on October 10, 2020.

Election Procedures:

Masks are required for all.

Children under the age of 21 will not be allowed in the voting area.

When you enter the voting room you will be required to sanitize your hands.

You will then proceed to the first Clerk station where you will present your Tribal Identification card. You may be asked for your name and/or Tribal Identification number.

You will then proceed to the next Clerk station where your identity will be verified.

You will then proceed to the Teller station where you will receive your ballot.

You will then be given a pen to use for marking your ballot. The pen is yours to keep, so please take it with you when you leave the voting booth.

After you have made your choices in the voting booth, or at the separate table for those who need or want to use it, you will place your ballot into the tabulation machine.

You will then proceed out of the building via the marked door.

New Solid Waste and Recycling Service

Reimbursement Procedure

There will be a change in the way the garbage fee will be handled starting during the 2020 tax season.

Tribal members will now be responsible to complete and submit a voucher for reimbursement for their garbage fee on their tax bill.

This new process applies to Tribal members living within the historic reservation boundary that don't already receive solid waste collection through the Tribe's current contractor.

Those that qualify will be required to obtain a voucher, which will be mailed this fall, and return the completed form to Tribal finance by April 15th. The individual applying for reimbursement must show proof of property ownership (ex. name on the tax bill). Reimbursement checks will be mailed within 2-4 weeks of submission. Only ONE reimbursement voucher can be submitted per individual no matter how many properties are owned.

In the past, the responsibility fell upon the Tribe to ensure the

garbage and recycling portion of the township taxes was paid on time.

The responsibility will now be on the eligible tribal member to receive reimbursement for their costs. With the old system, a list of qualifying Tribal members living in the township of Red Springs was created by Tribal staff. Inevitably, the list was constantly changing from year to year based on people moving and buying and selling properties.

In addition, the town of Bartelme recently ceased to provide waste and recycling pickup for its residents (not covered by tribal contracted services). This new procedure will help maintain fairness across the two townships and among Tribal members.

Keep an eye out in the mail for complete instructions as well as a voucher to be used for your 2020 garbage bill.

NOTICE TO LAND ASSIGNMENT HOLDERS

The Tribe, in conjunction with Wittenberg Telephone/Cirrinity, is bringing high speed internet to the reservation and surrounding communities in partnership with Wittenberg Telephone. Part of this process involves preparing the route for the high-speed fiber along the roadway and the route to individual homes that sign up for this service. As part of the route preparation, tribal employees and others authorized by the Tribe may be on

various land assignments from the Tribe and along tribal roadways marking the route, designating wetlands and invasive species areas to ensure proper precautions are taken. These activities will largely be occurring from July 2020 to June 2021. If you have any questions about the project or these activities, please feel free to contact broadband@mohican-nsn.gov.

I currently live on my family's dairy farm in Tigerton where I grew up. I'm the sixth generation to live on the family farm, and I'm a 7th generation Shawano County resident. I moved home after law school because I wanted to make a difference in my community and to help the people that gave me so much growing up.

attacking crime and not to be sitting on the sidelines letting others do the work. Our Counties need a DA who is capable of managing an office with the resources we have, not the resources we want.

I strongly believe our community can do better in effectively prosecuting crime. I'm running because I believe that in order to face the challenges of our time, we must be simultaneously tough on crime and smart on crime. We need a DA who can consider the downstream effects of prosecutorial decisions; someone who understands that life is not black and white.

Shawano isn't a "normal" county, and many attorneys refuse to practice here because of how backwards DA's office operates. Over the next few months, I will educate the taxpayers on the practices of current DA's office and talk about what we need to do differently.

Our Counties need a DA who is able to think outside of the box and who is willing to listen to differing opinions and ideas. We deserve a DA who is willing to look to other counties for the best practices in addressing the drug epidemic; someone who is able to work as a team within the County to implement the best practices. This is the time for our District Attorney to be hands on in his approach to

Since 2018, our Counties had seven felony cases dismissed because the DA's office failed to file routine paperwork on time, including two felony cases dismissed the day of Jury Trial because the DA's office failed to file the routine paperwork on time. This isn't normal and frankly, I'm befuddled on how it happened. Waupaca and Langlade Counties had zero cases dismissed like that in the same timeframe.

If you elect me District Attorney, I will bring to the office the work ethic of a farm boy and I will work diligently to protect our community.

Hello Elders!

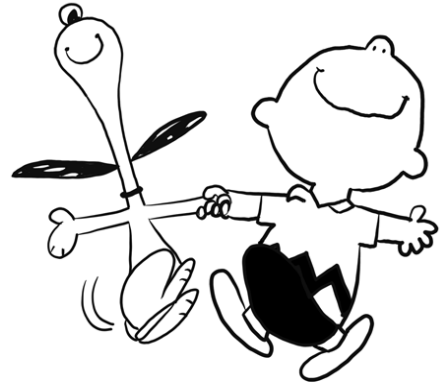
I hope you are all in good spirits and enjoying each new day! We have been experiencing some hot, humid and stormy days with our Wisconsin weather.

State driver licenses and IDs

Wisconsin driver licenses or IDs are the most common forms of identification used for voting purposes. Wisconsin Department of Transportation Division of Motor Vehicles (DMV) encourages voters to check and be sure that they have the proper identification.

The Wisconsin Elections Commission notes there are other forms of identification that are valid for voting purposes, such as military or student ID cards. A federally-compliant REAL ID card, with a star in the upper right corner, is *not* required for voting purposes. There is no separate "voter ID."

Voters can turn to DMV for help. To obtain an official state ID card, certain documents, such as a birth certificate, are required. If all documentation is not readily available, the ID Petition Process (IDPP) can be used to obtain a receipt valid for voting while the remaining documents or verifications are obtained. DMV offers this service and ID cards for voting purposes free of charge. DMV's toll-free Voter ID hotline at (844) 588-1069 is available for questions on obtaining an ID to vote.

SHAWANO, WI—The Shawano County Historical Society, in conjunction with the Shawano Parks and Recreation Department, will present Headstones: Civil War Stories, on September 12, 2020 at 5:30 pm at the Woodlawn Park Cemetery. This event will be free to the public.

The first in a series of cemetery walks over the coming years focusing on veterans, Headstones: Civil War Stories will examine the fascinating lives of 6 of Shawano's own Civil War Veterans buried in the Woodlawn Park Cemetery. Join us as we explore the lives of Julius & Lucius Murray, Stephen Gardner, John Schweers, Theodore Dodge, and Robert Jackson. Stay for a special ceremony commemorating Nathan Lake, the last surviving Civil War veteran in Shawano County. Prepackaged historical snacks and a special civil war exhibit featuring collections from the Shawano County Historical

Society will be available after the event.

About Headstones: Civil War Stories, volunteer Ben Dudzik said "I am excited to be working on this event. Shawano residents have a rich history in making great impacts in their community and country. It's time we honor those individuals who risked their lives and brought their passion for community and country back home. By telling the stories of these individuals, we really get to highlight what is so special about our area."

The Shawano County Historical Society is a 501(c)3, Non-profit organization with a mission to "preserve the culture and history of Shawano County by creating a vibrant learning experience and serving as a repository for current and future generation." They envision a future where they can "enrich people's lives through history."

greenhouse where they sell starter plants, vegetables, herbs and flowers in the spring. Colleen and Joseph utilize approximately four acres for their garden and their home farm stand is located on County Road A, one mile east of the Mohican North Star Resort/Casino. Most local venues such as Rudy's only accept cash, or checks from local residents. However, for a small fee, Colleen and Joe will accept most major credit cards for those who don't carry cash.

The couple love working outside in the garden. If it's plowing, tilling, hoeing or harvesting, you'll see them out in the garden as you drive past.

Over the years they have grown bigger and better, each year adding new vegetables. This year they have over six different varieties of tomatoes, eight different varieties of squash and over five different varieties of pumpkins. Colleen said, "And let's not forget the cucumbers, beans and peppers, just to name a few of the many other vegetables we have available".

Rudy's Garden accomplished one of their goals this year. They are now a certified vendor for the Wisconsin WIC Farmers Market Nutrition Program and Wisconsin Senior Farmers Market Nutrition

Program (FMNP) for the 2020 season. They hope this helps the community to get fresh vegetables without traveling so far; or waiting for a certain day to attend a Certified Market.

In the fall the couple will be working on a 100-foot hoop greenhouse and a store. The greenhouse will be extra storage for plants in the spring. They would also like to start growing vegetables all year round, which is why they will be building the store to replace the outside stand. Other possible ideas they have down the road are adding a pumpkin patch (pick your own) and a corn maze.

Colleen and Joe Rudesill promise to bring families like theirs fresh, local grown produce, free of harmful chemicals. Their seeds are GMO free and they never use chemicals or pesticides on their garden. They promise you will see weeds in their garden, but that is only because they do not use chemicals to get rid of weeds (not because Joe is watching television).

Hours for Rudy's Garden are 9am-6pm daily. And they ask you to like them on FaceBook at Rudy'sGarden@rudesillveggies. They post updates on what they have available and you can also message them to check availability of specific vegetables, herbs or other items you may be looking for.

Against Women’s Task force and a member of the Wisconsin MMIW Task Force, addressing the MMIW crisis requires acknowledging that the crisis exists, understanding the deep and complex roots underlying the crisis, and taking meaningful action to provide justice to the missing and murdered and protect Native women and girls’.

According to the Federal Bureau of Investigation’s National Crime Information Center, there are more than 1,400 unresolved American Indian and Alaska Native missing person cases in the U.S. To address this crisis, President Trump signed **Executive Order 13898** on November 26, 2019. Holsey added, “While there is so much that needs to be done to stop the violence perpetrated on Native women and girls, I appreciate the Administration for taking an important first step in this important initiative. As a Tribal leader, I look forward to continued engagement on this issue and identifying meaningful actions the Federal Government and Tribes can take to turn the tide on this tragic, ongoing crisis to improve prevention and intervene for those in crisis, and support individuals, families, and communities in need of healing”.

President Trump’s Executive Order established the Operation Lady Justice Task Force, a multi-agency effort co-chaired by Secretary Bernhardt and U.S. Attorney General William P. Barr. Its purpose is to enhance the operation of the criminal justice system and address the staggering number of missing and murdered American Indian and Alaska Natives in Tribal communities.

Holsey said, “Addressing these challenges issues requires strategies which demonstrate a respect for Tribal sovereignty and employ a collaborative approach with inclusion of Tribal Nations and Native organizations dedicated to providing support and resources to Indian Country. Native American communities, particularly indigenous women, face much higher rates of violence versus the national average. Indigenous women will experience some form of violence in their lifetime, and Native women are 10 times more likely than other women to be murdered”.

The Cold Case Task Forces are in accordance with the President’s Executive Order and will be staffed with law enforcement personnel and newly appointed special agents from the Bureau of Indian Affairs Office of Justice Services (BIA-OJS), along with personnel from other Operation Lady Justice Task Force partners including tribal law enforcement, the Federal Bureau of Investigation and Offices of the U.S. Attorneys. A way for top federal officials to

engage, coordinate and work with tribal governments on developing strategies to address the crisis, the Operation Lady Justice Task Force is working to collect and manage data across jurisdictions; establish protocols for new and unsolved cases; establish multi-jurisdictional cold case teams; improve the response to investigative challenges; and provide clarity on the roles, authorities and jurisdiction for those involved. It is also charged with providing a report to the President of its work and accomplishments in meeting the executive order’s mandate.

Since 2019, the Department of the Interior and Bureau of Indian Affairs (BIA) have undertaken a number of efforts to address the crisis, conducting criminal investigations, stopping illicit drug activity and solving missing and murdered cases.

Preventing further violence against American Indians and Alaska Natives is largely predicated on ending illicit drug activities and sex trafficking.

The BIA-OJS’s partnership with the Department of Justice’s Missing and Unidentified Persons System, known as NamUs, has led to the development and implementation of new Tribal-affiliation data fields to assist law enforcement with capturing information to track missing and murdered persons in Indian Country. Since the addition of these new data fields last year, there has been a 60 percent increase in Native-person entries into the system.

President Shannon Holsey ended by saying, “Alarmingly, law enforcement officials in tribal community’s often lack access to the data and resources necessary to prosecute and prevent these crimes. We must do more to ensure public safety in our Native communities. The goal should be to provide tribal law enforcement the tools they need by expanding access to federal criminal data bases, streamlining recruitment and retention procedures, and supporting best practices for investigating and prosecuting cases in Indian country, and advocating for restoring local control to tribal criminal justice systems, which frequently lack jurisdiction to prosecute non-Native perpetrators of violent crime, rather than increasing federal involvement”.

station length. Station length is automatically set for streams with a mean stream width less than 10ft.. Station lengths do not have an upper length limit. Fish sampling will be accomplished using a backpack or barge shocker. General guidelines for the determination of barge versus backpack shocking gear can be made by assessing mean stream width and substrate composition. Streams that are greater than 15 ft. in width and that lack a predominance of large boulders or fallen trees will be surveyed with the barge shocker. The backpack shocking gear will be used on streams that are less than 15ft in width or that contain a large amount of boulders or fallen trees that obstruct the use of the barge. The backpack shocker requires at least a two person crew. The primary responsibility of the crewmember wearing the backpack shocker is to cover all habitats thoroughly and efficiently, be aware of the location of the anode and cathode at all time, and suggest the modification of settings based on the condition of the shocked fish. The second crew member will carry a five gallon bucket, use a dipnet to capture fish, and transfer fish to the 5 gallon bucket. The second crew member is responsible for the requested modification of gear, the reporting and maintenance of the condition of fish in the 5 gallon bucket, the monitoring of the cathodes placement, and the safety of the shocker. General settings for the backpack shocker are: pulse rate set of 60 Hz, duty cycle of 12.5%, and a Voltage set at least 1 Amp 100 Volt output.

The barge shocker requires at least a three person crew and can utilize up to five crew members. The three person crew consists of two wings and a mule. The stream is divided into three sections, which each member is responsible for

covering. The distance between crewmembers should not exceed 8 ft., which is equivalent to the sweeping distance of the anode. Streams with mean widths that are greater than 50 ft. should be shocked with multiple barges. The wings are responsible for completely surveying all habitat, netting and transplanting fish into the mules net or the live well, monitoring the condition of fish, ensuring that the reels are not damaged by excessive removal of cord, and the safety of other crew members. The wing on the right side of the boat is responsible for the maintenance of the generator. The wing on the left is responsible for water replenishment of the live well. The mule is responsible for the transmitting power to the anodes, ensuring that all safety precautions are occurring, monitoring the condition of captured fish, monitoring the health of fish in the live well, transporting fish from the wings into the live well, monitoring voltage and amperage, and monitoring the amount of cord the wings are extracting from reels (excess cord removal will damage the cord reels). General settings for the barge shocker are 5 A and 200 V output. The mule can select between a low and high voltage setting. The low voltage selection should be used as often as possible. The generator will trip a circuit breaker if power is drawn at a greater rate than the generator can safely produce. The throttle on the generator can be adjusted to increase output by using a screwdriver to tighten the throttle screw. A single electroshocking run is made from the downstream to upstream end of the station. The species count (length and weight of all game species optional) should be recorded on the Stream Fishery Datasheet. Counts of all non-game species should also be recorded. The Stream Fishery Datasheet should be completely filled out at each sampling location.

How can I stop the spread of COVID-19?

Wash your hands often with soap and water for at least 20 seconds especially after you have been in a public place, or after blowing your nose, coughing, or sneezing.

Outside your home: Put 6 feet of distance between yourself and people who don't live in your household. Remember that some people without symptoms may be able to spread virus.

Inside your home: Avoid close contact with people who are sick. If possible, maintain 6 feet between the person who is sick and other household members.

Cover your mouth and nose with a mask when around others. You could spread COVID-19 to others even if you do not feel sick. The mask is meant to protect other people in case you are infected. (Masks should not be placed on young children under age 2, anyone who has trouble breathing, or is unconscious, incapacitated or otherwise unable to remove the mask without assistance.)

Always cover your mouth and nose with a tissue when you cough or sneeze or use the inside of your elbow and do not spit.

Clean AND disinfect frequently touched surfaces daily. This includes tables, doorknobs, light switches, countertops, handles, desks, phones, keyboards, toilets, faucets, and sinks.

Monitor Your Health Daily. Be alert for symptoms. Watch for fever, cough, shortness of breath, or other symptoms of COVID-19. Especially important if you are running essential errands, going into the office or workplace, and in settings where it may be difficult to keep a physical distance of 6 feet.

Report your symptoms to the Stockbridge-Munsee Health and Wellness Center and your employer.

If I touch something at work, where a person with COVID-19 was working, am I considered a close contact?

Studies show that COVID-19 viruses can live up to 72 hours on surfaces, that is why it is important to disinfect surfaces. It may be possible that a person can get COVID-19 by touching a surface or object that has the virus on it and then touching their own mouth, nose, or possibly their eyes. This is not thought to be the main way the virus spreads, but we are still learning more about how this virus spreads. In general, the more closely a person interacts with others and the longer that

interaction, the higher the risk of COVID-19 spread.

Surfaces in the work place or home should be cleaned and disinfected with an EPA approved disinfectant to kill the viruses. As an employer, the Stockbridge-Munsee Community conducts frequent disinfecting of surfaces, including regular deep cleaning/disinfecting.

Everyone should also wash their hands frequently to reduce further spreading of Covid-19.

Why must everyone wear a mask if it does not allow the wearer to be considered safe from close contact?

Masks are recommended as a simple barrier to help prevent respiratory droplets from traveling into the air and onto other people when the person wearing the mask coughs, sneezes, talks, or raises their voice. This is called source control. This recommendation is based on what we know about the role respiratory droplets play in the spread of the virus that causes COVID-19, paired with emerging evidence from clinical and laboratory studies that shows masks reduce the spray of droplets when worn over the nose and mouth. COVID-19 spreads mainly among people who are in close contact with one another (within about 6 feet), so the use of masks is particularly important in settings where people are close to each other or where social distancing is difficult to maintain.

While masks offer a level of protection, the exact effectiveness is not known and close contact is the most common way for COVID-19 to be spread. To take precautions in stopping the spread of COVID-19, contact tracers are used to track close contact.

What do you do if you are in a house with a sick person?

Isolate at home and do not have others over. You will need to isolate for 14 days after the sick person is off of quarantine or your last contact with the sick person. If possible, maintain 6 feet between the person who is sick and other household members.

Always cover your mouth and nose with a tissue when you cough or sneeze or use the inside of your elbow and do not spit.

Wash your hands often with soap and water for at least 20 seconds especially after you have been in a public place, or after blowing your nose, coughing, or sneezing. Avoid touching your eyes, nose, and mouth with unwashed hands. Clean AND disinfect frequently touched surfaces

Testing

Can I get tested for COVID-19 at the SMHWC

Yes, if you receive care from



the SMHWC, or if you are a community member, or if you are an employee of the Stockbridge-Munsee Community and North Star, or if you are referred by SMHWC contact tracers.

What do I need to be tested?

Call triage at 715-793-5087 to schedule the test

What Tests are available?

The SMHWC frequently uses a nasal swab collection that is sent out to the reference lab. The clinic also has an in-house rapid test.

Are Rapid Tests Effective/Accurate?

Yes, the clinic offers rapid tests through Abbot ID Now testing

platform. These tests can be completed in approximately 20-30 minutes. These tests are as effective as the send out lab tests in detecting COVID-19, but they return a higher level of false positives.

Why doesn't the clinic use only Rapid Tests since the results are available quicker?

The clinic has a limited number of in-house analyzers, which limits the number of quick tests that can be completed each day. The clinic has a large capacity to test via the send out lab. Send out tests generally take 2-5 days for results to be returned.

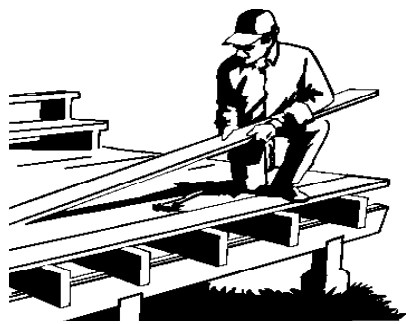
