Limited Shutdown to Essential Services due to COVID-19



In order to best protect their employees while maintaining needed services, the Stockbridge-Munsee Tribal Council made the difficult decision to implement a limited shutdown of tribal operations to critical services in response to the CO-VID-19 outbreak.

This shutdown will begin as of Thursday September 24, 2020 (9/24/2020) at the close of the business day for approximately two (2) weeks.

Tribal Council hopes to resume more operations after October 13, 2020, but the Council may need to reassess this approach depending on public health conditions.

Also, all employees will be required to take a COVID test and receive a negative result before returning to the workplace.

Please keep monitoring the Tribe's COVID-19 website, which can be reached from www.mohican.com , for updates on the required COVID testing procedure and return to work guidance as it gets closer to October 13, 2020.

Employees are expected to shelter in place in compliance with the Tribe's Health Order during the shutdown.

The Tribal Council understands the financial burden that this shutdown will place on employees who are temporarily furloughed. Therefore, the Tribal Council is authorizing special paid leave for employees who are not working during this ini-

tial shutdown. Employees will be paid their regular average weekly wage during this period and normal group health plan benefits remain in place.

The Tribal Council intends to keep tribal government and businesses, other than the Casino (which will be closed), functioning in a more limited capacity during this time.

The managers and directors will be working with the employees over the next day to identify employees who will continue to provide services and how such services will be handled.

The tribe wants to operate as safely as possible, so additional limits may be put in place if needed.

The Tribal Council will be bringing employees back from furlough in their same jobs once it can resume normal operations. However, if the shutdown

continues beyond October 13, 2020, they will be reevaluating their operational path forward. The Tribal Council understands that employees will need to explore other options if the shutdown last longer than the anticipated two (2) weeks.

The Tribal Council is working hard to plan a way forward that looks out for the physical and financial well-being of its employees and community. Tribal Council recognizes this is an extraordinary situation and are trying to responsibly manage tribal resources in a way that recognizes short term and long-term tribal goals as well as the needs of its members and employees.

Thank you for your understanding, be kind to one another, and stay healthy and safe.

From the Desk of the President

We are a resilient people who overcome difficulty every day. Throughout our history, we've been counted out more times than we can remember. No matter the difficulty, however, we survive by working together. When we need each other most, we stand together; this is one of those times. We have authorized a number of measures to be implemented to help place limits on opportunities for virus transmission while maintaining essential but limited operations and services with closure of most of the Tribal Government, North Star Casino, Little Star C-store and other areas of operation beginning September 24, 2020 until October 13, 2020, and will continue access on an ongoing basis. You can find information regarding open operations and hours of service that are listed in this Mohican News edition as well as at our Mohican. com webpage.

We ask for your cooperation patience and understanding during this critical time of COVID-19 viral resurgence. Wisconsin has experienced one of the highest percentage increases of the coronavirus over the past two weeks and has the second-highest rate of positive coronavirus tests in the nation according to Reuters tally.

The Stockbridge-Munsee Tribal Council recognizes this tribal community is also seeing a surge



in positive COVID-19 infections as well as our surrounding areas. The recent public health conditions caused by the COVID-19 virus, a communicable disease, require this Community to implement stricter protective measures until infection rates are better controlled.

The closeness of our tribal community and employees presents many challenges regarding socially distancing and the need to want to be together while keeping one another safe. But those ties also strengthen our ability to support one another during times of great need and truly defines what is so special about our Tribe. That is why the current requirements are so hard to follow.

However, with the thresholds of our matrix and in counsel of our Medical Director, Dr. Lundin and with the guidance of GLITC Epidemiology Director, Dr. Gonzalez, we have exceeded safe numbers to continue operations. And most importantly for the safety and wellbeing of our Community we made the decision to close.

The high number of positive COVID-19 case epitomizes the urgent importance of continued diligence. Masks, social distancing, frequent hand-washing and limited group contact are the best way to show your Mohican pride and protect the community, especially our most vulnerable members.

To that end, the Tribal Council issued a new Order directing people who live on tribal lands, as well as tribal employees who are on leave from work, to isolate and shelter in place at their home to limit opportunities for infection and to transmit the COVID-19 virus to others. People are permitted to travel to the extent necessary for medical care, for essential work, or to purchase necessary supplies.

The October 10, 2020 tribal election remains scheduled and tribal members are permitted to travel as necessary to vote in the election.

This week will conclude our second mandatory all employee testing and will continue to test our employees and community on a frequent basis to curve and manage the spread or the coronavirus.

We are implementing serious measures to protect our Nation especially our Elders, children, and the most vulnerable members of our community – the residents

at the Ella Besaw Center. We are implementing a ban on inperson visitors and residents leaving the facility other than for necessary medical appointments. We recognize the terrible consequences the virus had throughout the Country and are taking these drastic measures in hopes of reducing the virus outbreak in our Community.

We anticipate that we will need to implement additional measures as conditions develop in our area. We are restricting operations to essential services. We hope the situation does not require a total shutdown of operations for a period of time, but it is something we will consider if it is necessary for the health, safety and well-being of our community and employees.

For now, we encourage you to comply with public health guidance and directions since the virus has yet to be contained. The Tribal Council is working proactively to provide necessary resources and support. We all need to do our part to control the spread of this disease.

Last, but certainly not least, we applaud the people working so hard to keep our Community safe during this crisis. We understand it mentally exhausting and there is fear, no doubt. Your dedication is proven by your presence at work and in our Community by consistently fostering a safe environment for all, by following the safety protocols the tribe has instituted. Everyone, please remain safe and healthy; we will get through this. "Alone we can do so little; together we can do so much."- Helen Keller.

SMC COVID-19 \$1,000 EMERGENCY ASSISTANCE PROGRAM

Tribal Council approved a one-time reimbursement of eligible expenses or direct payment to a vendor for eligible expenses up to \$1,000.

Very similar to the COVID-19 General Assistance Program for \$500, the SMC COVID-19 Emergency Assistance program will provide financial assistance to SMC Tribal members 18 and over who have been affected by the COVID-19 pandemic.

This program is made possible through funding from the Federal Coronavirus Aid Relief and Economic Security (CARES) Act.

In addition to being a SMC Tribal member 18 and over, the applicant must have a hardship due to COVID-19 and provide evidence of eligible expenses, such as paid receipts and invoices that include the vendor information. Expenses must be incurred between March 15, 2020 and December 1, 2020. Eligible expenses that would be considered are:

- 1. Housing/Shelter (House payment, Rent, Security Deposit)
- 2. Utilities (Electric, Water/Sewer, Heating)
- 3. Groceries, Cleaning Supplies, PPE
- 4. Elder/Disabled Care
- Child Care
- 6. Career Services (Vehicle Payment, Vehicle Insurance, Vehicle Repairs, Uniform/Work Boots, Licenses, Laptop/Computer)
- 7. Repairs (Heating, Electrical, Plumbing)
- 8. Appliances (Stove, Refrigerator, Washer/Dryer)
- 9. Generator

Paid receipts and/or invoices that include vendor information MUST accompany the completed application for payment to be processed.

Reimbursement can be made by check or direct deposit to the applicant's bank. Payment may also be made directly to a vendor on their behalf by submitting an invoice showing their account number.

Completed applications along with the required receipt/invoice documentation must be submitted by the deadline of December 1, 2020 by 4:00 p.m. via mail, electronically or in person.


Target Data Response (Contact Tracer Data)

-If Contact Tracing Data suggest certain activities or locations are the point of COVID-19 spread, targeted measures shall be taken to address and special concern.

-If outside community traffic/ visitors are bringing the virus into the community, a stricter curfew may be instituted to limit outside visitors.

-If a certain building is the point of transmission, that building will be shut down and deep cleaned for a period based on medical advice.

-If a certain activity is the point of transmission, that activity will be shut down until additional safety practices can be put in place with the assistance of medical advice.

Magnificent Mohicans by Yvette Malone



David Besaw. was born on May 4, 1944.and he was a bachelor.

Dave was the epitome of a community helper. He was considered the medicine man of the community for his knowledge of natural medicines from the land. He collected medicine and dried them at his own home and would help folks out that came to him. Tobacco was all that was needed for his knowledge. He passed this on to Misty Davids Cook so it would not be lost.

Indian health has been the major focus for over 40 years of Dave's life as he was instrumental in

starting up the Stockbridge-Munsee tribe's first health care center in the early 1970's. He was the first Community Health Representative (CHR) for the Tribe in 1970. Dave then worked for the Indian Health Service in education for two years. In 1974, Dave became the first health care employee for the Tribe, eventually being hired as the director of the clinic for 191/2 years. Dave held that position until his retirement, due to health reasons, in November 1992. He served on numerous boards and was a tribal council member.

He continued his work in the health field even in retirement as the Activities Director for the Ella Besaw Center for a while and collected medicines, following in the footsteps of his mother Ella Besaw, a tribal medicine woman, for whom the Center is named.

Dave loved to sing and lead his friends in song, he loved his community. His community loved him. He was known as a medicine man. He was definitely a Magnificent Mohican. passed at the age of 67.

Status of Membership Ordinance Amendments

Stockbridge-Munsee Constitution addresses the process for promulgating membership ordinances in Article III, Section 4, which provides that the Tribal Council can adopt such ordinances subject to the approval of the Secretary of Interior.

SEC. 4. The Tribal Council shall have authority to promulgate ordinances, subject to the approval of the Secretary of the Interior, governing the adoption of new members and loss of membership in the Community.

The amendments to Chapter 44, the Tribe's Membership Ordinance, that the Tribal Council adopted on December 3, 2019 were adopted under this section of the Tribe's Constitution. This means the amendments to Chapter 44 cannot become effective without federal approval in accordance with this constitutional requirement.

The central feature of these 2019 amendments is a change in the way that blood quantum is calculated when people apply to be new members into the Tribe. The amendments establish that all persons identified as Stockbridge-Munsee on the January 1, 1940 Indian Census Roll of Stockbridge-Munsee Indians as well as on prior rolls, including the 1910 roll, back to the 1871 roll are treated as having full (4/4) Stockbridge-Munsee blood when calculating the blood quantum for new members. Additionally, full biological siblings to people on the 1940 roll, even if born after 1940, are also treated as having full Stockbridge-Munsee blood.

While the amendments to Chapter 44 do change the methodology for calculating blood

quantum in order to be eligible to be adopted as a new member of the Tribe, the amendments do not change the criteria used to determine eligibility. People who want to be adopted as a new member still need to show that they are of Stockbridge-Munsee descent and have a blood quantum of at least 1/4.

The Tribal Council shares the Community's interest in resolving these ordinance changes and continues to pressure the Bureau of Indian Affairs to complete their review with calls and letters. The Great Lakes Agency Office provided their comments and recommendations to the Midwest Region Office in January 2020. The Tribal Council has made a number of calls and sent two certified letters on the status of the approval process.

Most recently, the Tribal Council participated in a call with the Midwest Region, Tammy Poitra, Regional Director, on September 14, 2020. They were informed that the ordinance was still under legal review and that the Midwest Region hoped to provide the Tribe with a response within a month. They apologized for the delay and explained that their offices were operating with reduced staff and at limited operations due to the pandemic and they without a Director lead for a short time.

As the Tribe's Constitution requires federal approval for ordinances addressing membership, the Tribe cannot move forward with changes to Chapter 44 without federal action. The Tribal Council will keep you updated as to any developments.

Essential Employee Stickers During DOVID-19 **Curfew Are Required**



With the latest Public Health order Due to Covid-19- safety precautions were put in place.

One of the requirements was to establish a curfew between the hours of 12:00 AM to 5:00 AM. requiring persons to shelter at home during these hours.

But we have essential employee's, who still need to go to work.

President Holsey had curfew stickers made to easily allow Law Enforcement to identify employees traveling to and from their job during the curfew hours.

How do I receive my sticker?

On the tribal side:

Curfew stickers are available at public Safety building between the hours of 8:00-4:30 Monday through Friday. When you pick up your sticker, we will need the make, model and license plate



number and you will need you to initial by your name. On the Casino side:

Casino essential workers will work with Gerald Miller to receive their sticker. The same informationmake, model and plate number, and initials will be needed.

What happens if I am driving during the Curfew hours without a sticker?

Persons who are away from their homes during curfew hours are considered to be trespassing on tribal lands and subject to enforcement actions(s). curfew does not apply to law enforcement, emergency responders, persons traveling for medical care, or persons permitted to travel for legitimate work and business purposes. Providing Food Resources

The Stockbridge-Munsee Tribal Council has allocated CARES funding to provide food boxes to Tribal Member Households, living within Shawano County. Earlier this year, the Stockbridge-Munsee Community networked with the Hunger Task Force on initiatives to provide relief to the growing numbers of underfed and unemployed families. To date two very positive programs have been successful in providing food resource; Wisconsin Dairy Recovery Program and USDA Farmers to Families Food Box

Hunger Task Force joined with the Dairy Farmers of Wisconsin and the Wisconsin Department of Agriculture, Trade and Consumer Protection to create the Wisconsin Recovery Program. Wisconsin dairy farmers were paid to supply milk to farmer-owned diary cooperative Kemps, who processes milk at a Cedarburg facility.

Hunger Task Force distributed milk to Free & local partner food banks and pantries through the Hunger Relief Federation of Wisconsin. Jill Duffek, FDP Supervisor and Crystal Malone, Economic Support Assistant Director, were instrumental in bringing this food resource to the Stockbridge-Munsee Community. The first delivery of milk and cheese was May 4, 2020. On average 192 gallons of milk has been distributed weekly. Other dairy items distributed were yogurt and cheese.

The second food resource that was brought to the Stockbridge-Munsee Community was the Farmers to Families Food Box

Program. Secretary of Agriculture Sonny Perdue announced that the USDA was exercising authority under the Families Coronavirus Response Act to purchase and distribute agricultural products to those in need. The program supplied food boxes with fresh fruits and vegetables, meat products, dairy products, and combination boxes with a mixture of all the products. Tribal Members greatly relied on these products to supplement their household resources, with up 810 boxes being distributed at its peak. Unfortunately, it in round three of funding, no distribution vendors in Wisconsin so that the vendor was chosen in the State of Farmers to Families Food Boxes

Wisconsin thus the food boxes will cease. The Stockbridge-Munsee there was no new development.

Tribal Council noted the significant number of Tribal Members who were utilizing this food resource and decided to work with a local merchant to provide food boxes of protein for Tribal Member households.

Tribal Council has allocated CARES funds to be used to provide food boxes for the months of September, October, November, and December. Charlies County Market of Shawano will work with the Tribe to arrange for distribution of protein boxes.

Hunger Task Force continues to advocate to USDA, to approve will return. At the time of this article





Covid-19 General Assistance Program

The Tribal Council approved a one-time reimbursement of expenses up to \$500 directly **or** a payment to a vendor for expenses. This general assistance program is made available through the CARES funding the Tribe received from the US Treasury.

To be eligible to participate in this general assistance program you must be an adult enrolled member age 18 and over at the time of application and demonstrate a need for assistance directly related to the Covid-19 pandemic. The following list would be considered direct impact:

- 1. Furloughed/Layoff from Employment
- 2. Unemployed during the pandemic (March 1st, 2020- December 1st, 2020)
- 3. Suspension of Medical Insurance
- 4. Reduction in work hours/pay
- Expenses for Children home from school
- 6. Educational supplies needed or internet services
- 7. Increased food costs
- 8. Relatives living with you
- 9. COVID-related quarantine cost
- 10. Difficulty making rent/ housing payment(s)
- 11. Difficulty making utility payments(s)
- 12. Increased cleaning, PPE, or in-home care and/or medical supplies due to age or medical condition
- 13. Underlying medical condition, requiring staying home to prevent exposure

For items 1-4, you should have a letter from your employer. For items 5-6, you should have a letter from your dependent children's school or college. For items 7-13, the Tribal Council's isolation order

or the Stay at Home or Safer at Home order the Governor of your state declared.

You need to submit receipts to be directly reimbursed. Acceptable receipts would be for payment of rent, mortgage, electric, water, sewer, LP gas, fuel oil, internet, cellphone, groceries, personal protective equipment and supplies, and cleaning supplies,

Reimbursement can be made by check to applicant or by direct deposit to the applicant's bank. The applicant will need to provide their banking information on their application. If the applicant is requesting a payment be made to a vendor on their behalf, they need to provide an invoice showing their account number.

Everyone has been impacted one way or another by this pandemic, and there should be no reason why they wouldn't qualify for this general assistance program. So far, the program has assisted over 329 tribal members. Fill out the application and provide your documentation and receipts (or invoice) and apply before the deadline of **December 1, 2020 at 4:00 pm**.

Washington, D.C. - September We must be loud and proud, yet 14, 2020

As the nation nears the upcoming 2020 elections, on November 3rd, National Indian Gaming Association Chairman Ernie Stevens, Jr., has been working on outreach to tribal communities to promote the importance of the Native American vote.

To promote the Indian Gaming "My Vote Will Count" initiative, Stevens visited with Shannon Holsey, President of the Stockbridge-Munsee Community Band of Mohican Indian tribal council at the tribal headquarters in Bowler, Wisconsin.

During this visit, both Stevens and Holsey shared the importance of the Indian Country vote, sharing that native issues' prevalence during this election goes well beyond one setting and one story.

Holsey shared, "With the heightened political participation of Native people, Indian Country has become an increasingly powerful voting bloc. In recent years, the Native vote has been publicly acknowledged as making a pivotal difference in national, state, and local elections. Voting is a right which was not always afforded Native American's and something that is not only our civic responsibility but should be considered a sacred exercise of democracy."

"Representation matters. I believe this is going to be one of the most critical elections in our lifetimes long-standing, systemic issues that underpin differences in our communities." Holsey added, "Native American voters and communities now form a vital part of the demographic forces reshaping American politics and discourse in key areas. We need representation and allies to ensure that we can advance Indian Country's most pressing priorities.

Chairman Ernie Stevens, Jr., said, "I am inspired by the urgency of Native America to educate and ensure a clear understanding of tribal government gaming and tribal sovereignty overall. I believe the leadership and the communities they represent are the true educators. Before, during and immediately after the 2020 election will be key educational opportunities.

respectful and diligent in our educational endeavors."

Stevens added, "These outreach events are a golden opportunity to educate our young citizens about the importance of becoming involved in the voting process. It also helps them understand and appreciate more about our Indian Country history, democracy and outreach. Our young vote has the potential to be extremely influential in this country."

In October 2019, the National Indian Gaming Association announced the creation of the gaming organizations Get Out the Vote campaign - "My Vote Will Count," leading up to the 2020 General Elections in November of 2020.

The National Indian Gaming Association developed this grassroots effort with partners, including Member Tribes, sister tribal organizations, and prominent events throughout Indian Country to educate, empower, and encourage all Native Americans to register to vote and commit to getting to the

The grassroots efforts were forced to take a different path, with the impacts of COVID-19. Because many of our Indian country events and confabs were canceled, the "My Vote Will Count" initiative will look to all aspects of social media platforms as well as some outreach options with limited travel to encourage our young voters to vote.

Stevens shared, "Right now, we are sticking mostly to traveling to local areas of Wisconsin and are slowly expanding our travel to surrounding States." Chairman Stevens emphasized that all social distancing and safety precautions prioritize his travels to promote the

One of the popular Native Vote give away items provided by the National Indian Gaming Association is the "United Vote 2020 Tshirts." Stevens said, "We've been able to deliver a limited number of t-shirts. They are delivered in sanitized and sealed boxes to tribes who are hosting their get out the vote initiatives."

The Stockbridge-Munsee Tribal Court enacts revised rules establishing an electronic filing (e: filing) system and setting forth rules of procedure thereof. The revised rules are effective June 15, 2020 and replace the (d) If the document is acceptrules enacted on April 24, 2020. The revised rules will remain effective indefinitely, or until amended by further order of the Court.

Civil Procedure Rules of (e) The Court Clerk will file-E-Filing

- Purpose
 - tronic filing are hereby established and set forth for the purpose of providing parties electronic remote access to the Stockbridge-Munsee Tribal Court system.
- Authority
- (a) Under Stockbridge-Munsee Tribal Law, Chapter 5 Sec. 1.12 - Rule Making Power, "[t]he Tribal Court System may from time to time prescribe Rules of Procedure for the conduct of Tribal Court System business." This rule making power provides the Chief Judge with vested authority to implement Rules of Procedure for the Court.
- 3. User Agreement
- (a) By submitting filing(s) electronically, the signor of such documents (i.e., legal representative or unrepresented party) impliedly consents to abide by the rules of procedures provided herein, and recognizes that unless explicitly stated otherwise, all other rules of civil procedure and rules of practice before the Court remain effective.
- 4. E-Filing Domain
- (a) All electronic filings shall be sent to court.efile@mohican-nsn.gov and must contain the Name of filing party, signature of the party, and date of submission.
- 5. Time and Effect of ElectronicFiling
- (a) The filing system is a mechanism of the Stockbridge-Munsee Tribal Court for the purposes of submitting electronic filings.
- (b) When a document is submitted, the electronic filing shall be transmitted to the Tribal Court Clerk through the designated e-filing address. The Tribal Court Clerk shall issue confirmation that submission of the electronic filing has 7. Notice. Service, and Probeen received by sending an official confirmation form and assigning

- a case number to the delivering party.
- (c) In order for the filing to be accepted it must meet all electronic filing requirements.
- ed for filing, it shall be considered filed with the Court on the day of receipt and at the time provided by the electronic time-stamp within the Court's system.
- stamp and process the filing as normally practiced.
- The Rules for elec- (f) The Court will accept electronic filings received on that business day between the hours of 8:00 AM. -4:29 P.M. (Central Standard Time) in accord with regular business hours. A filing must be complete and meet the legal requirements of such document; incomplete or partial filings will not be accepted. If a document is electronically filed after 4:29 P.M. it will be considered filed on the following business day.
 - (g) Parties that are unable to access the electronic filing system may send documents to the Court using general mail.
 - 6. Filing Fee
 - (a) The initial filing fees required under Chapter 1 Sec. 1.15 shall be paid through the Court's electronic payment system found on the Tribal Court website. Payment and proof of payment due before the Court will process any filing. If a party fails to pay the applicable filing fee, the matter will be deemed not filed and no further action taken.
 - (b) Alternatively, a party filing an initiating document may' submit payment to the Stockbridge-Munsee Tribal Finance Department. The payment must be submitted in the form of money order or cashier's check for the full amount due. The transmittal slip (receipt) of payment must be submitted to the Court via general mail, in-person delivery, or preferably by use of the electronic filing system. The transmittal slip must identify the filing party's name, amount paid, and date of payment.

 - (a) The general rules of notice, service, and process

- of service under Stockbridge-Munsee Tribal Law remain controlling. However, service by mail, or by email if the parties involved have an official user email on record, or by substitute service are recommended if the Tribe is under currently under emergency order or restrictions regarding cir**cumstances** such as the COVID-10 pandemic.
- 8. Format for Electronic Filings
- (a) All documents, unless being submitted as evidence, must be provided in electronic format and typed into word pressing software using common business font (e.g., Times New Roman, Times, Calibri, Arial).

Getting a Flu Vaccine Now is Critical During Ongoing COVID-19 Pandemic

DHS Encourages State Residents to Get Flu Vaccinations by Halloween

Annual flu vaccines are always important, but reducing illness and hospitalization from flu is critical this year to protect our frontline health care workers and hospital systems who will continue to care for people with COVID-19.

Last flu season, 42% Wisconsinites received at least one dose of flu vaccine, leaving nearly two-thirds of people at higher risk of getting the flu. During Wisconsin's 2019-2020 influenza season, there were 36,175 flu cases reported, 4,425 flu-related hospitalizations, and tragically, 183 deaths, including three children. Last year, we saw the highest number of pregnant women hospitalized for influenza.

Flu season is right around the corner in Wisconsin and it takes about two weeks for the flu vaccine to protect you against the virus. Make a plan today to get yourself and your family vaccinated by contacting your health care provider to schedule an appointment, or checking with your local pharmacy. You can also use vaccinefinder.gov(link is external) or call 211 to find a provider near you. If cost is a concern, your children may be eligible for the Wisconsin Vaccines for Children program.

"Both influenza and COVID-19 are respiratory illnesses, but until we have a vaccine against COVID-19. the way to help prevent these two viruses from circulating at the same time is to get your flu vaccine now," Palm said. "We all need to do everything possible to make a difference this flu season, so let's keep people flu-free while we focus on ending COVID-19."

Providers are being creative this year to help make vaccinations easy and convenient, from holding vaccination drives at churches and grocery store parking lots, to providing them curbside at clinics. Safety precautions related to COVID-19 are in place, including social distancing and sanitizing at clinics, temperature checks, and special scheduling.

Simple steps we're already following to stop the spread of COVID-19 are also successful for warding off the flu. In addition to the flu vaccine, people should also:

- Stay home when they're sick.
- Cover coughs and sneezes.
- Wash their hands frequently and thoroughly.

To help increase flu vaccine rates statewide, the Department just announced new funding for community organizations to reach out to underserved communities. DHS will award \$950,000, provided by the Centers for Disease Control and Prevention (CDC), to 5-10 organizations, each receiving up to \$200,000.
