SMC COVID-19 \$1,000 EMERGENCY ASSISTANCE PROGRAM

Recently, Tribal Council approved a one-time reimbursement of eligible expenses or direct payment to a vendor for eligible expenses up to \$1,000. Very similar to the COVID-19 General Assistance Program for \$500, the SMC COVID-19 Emergency Assistance program will provide financial assistance to SMC Tribal members 18 and over who have been affected by the COVID-19 pandemic.

This program is made possible through funding from the Federal Coronavirus Aid Relief and Economic Security (CARES) Act.

In addition to being a SMC Tribal member 18 and over, the applicant must have a hardship due to COVID-19 and provide evidence of eligible expenses, such as paid receipts and invoices that include the vendor information. Expenses must be incurred between March 15, 2020 and December 1, 2020. Eligible expenses that would be considered are:

1. Housing/Shelter (House payment, Rent, Security Deposit)
2. Utilities (Electric, Water/Sewer, Heating)
3. Groceries, Cleaning Supplies, PPE
4. Elder/Disabled Care
5. Child Care
6. Career Services (Vehicle Payment, Vehicle Insurance, Vehicle Repairs, Uniform/Work Boots, Licenses, Laptop/Computer)
7. Repairs (Heating, Electrical, Plumbing)
8. Appliances (Stove, Refrigerator, Washer/Dryer)
9. Generator

Get Out and Vote

This time of year is filled with our own tribal elections but on a larger scale we see the Presidential election is coming around the corner as well. The next four years will be decided here in the coming months.

To be able to vote you must be a citizen of the U.S., be at least 18 years of age or older on Election Day. Have lived at your address at least 28 days before election day and be off papers from any felony conviction. There are two ways you can vote either at your polling place on election day or to request an absentee ballot.

In order to vote, you must first register to vote. Everyone in Wisconsin must prove they live in the state. To do this, you must provide a proof of residency document. Acceptable documents are listed below. You can register online at wcv.votewisconsin.com until October 14th. You can also register to vote by mail or at your polling place on Election Day. A proof of residency document must contain your current address. You must be living at this residence at least 28 days before Election Day. For acceptable proof of residency documents, refer to the list below or visit the link conservation.

- A current and valid State of Wisconsin Driver License or State ID card
- Any other official identification card or license issued by a Wisconsin governmental body or unit with current address
- A real estate tax bill or receipt for the current year or the

Dr. Sandra Barton was named the Training and Continuous Improvement Coordinator. Under the general supervision of the Human Resources Executive Director, the primary purpose of the position is to coordinate and facilitate Tribal training initiatives, work towards organizational continuous improvement, assist with employee onboarding, facilitate formal training programs, and assist with employee focused communications.



Sandee's job is to perform a strategic needs assessment. This will include determining and prioritizing the various training that may be needed in the different Tribal entities. This assessment needs input from all employees, therefore, Dr. Barton will be sending out surveys, periodically, to get accurate feedback and then gauge whether specific training programs are indeed effective. She encourages all employees to make their opinions and comments known on those surveys. If you prefer to chat

over the phone, she's available. As a curriculum developer and instructional designer, Sandee will also be helping to develop and facilitate any needed training and help establish training on a continuous basis.

Enrollment Updates

Beginning October 1, 2020, the Enrollment Department will be using a new application for enrollment. The application will be available online or it can be picked up from the Enrollment Department.

In addition, there has been a change to the Enrollment Application Submission policy, the Enrollment Department now requires:

Individuals over the age of eighteen (18) wishing to apply for enrollment either have their enrollment form notarized or bring their application to Enrollment in person for staff to witness.

If the individual has a Power of Attorney (POA) or guardian the POA or guardian may apply on the persons behalf. Parents or legal

guardians of minor children under the age of eighteen (18) may apply for their minor children following the same guidelines for notary or staff drop-off.

Currently there are approximately 170 applications waiting to be reviewed.

The Enrollment Department is working diligently to catch up on work that has fallen behind due to being short staffed, new staff training on the data system, and process 2020 per capita forms.

The Enrollment Committee, Enrollment Department, and Tribal Council have been working cooperatively to get caught up; please be patient.

Did you know that Blackfeet is an Algonquin language just like us!

Our languages continue to be taught on Mondays and Wednesdays via Zoom. If you are interested in registering (an email is needed to invite you to the link) please email heather.bruegl@mohican-nsn.gov.

A link is sent to you prior to each class and the lessons also. The link is sent within 15 minutes prior. Monday are Munsee language and Wednesdays are Mohican. 5:30 has been our time. Any changes will be announced in class. We have been teaching through progressive review but understand

some of you want to start from the beginning. The October 5 - Nov 6 week classes will be introduction classes. Then Nov 30 (Dec break) and January 25 - 6 week sessions will be review.

We will proceed over the next year to teach this way so new members can join and feel comfortable with instruction. So six weeks – intro; six weeks – advanced review; six weeks -intro; six weeks advanced review, etc. All students are welcome to do intro over if needed. It never hurts to continue learning at a slower pace and participating in constant review.

We have very few youth learning with us and we want to get them to join.

Nikole Webster will be teaching a short Munsee lesson for K-3 students at least 2 – 3 times per week via virtual learning. Schedules are being worked out. Anushik to the administrator at Bowler, Todd Carlson and grade school principal Wade Turner for fitting us in.

We will keep on learning together!!

Emmeretta Miller, our sister, mother, aunt and friend died unexpectedly due to complications of Covid 19 at 2:20 pm on September 12, 2020 at ThedaCare in Appleton, WI. The unrelenting rain on September 12 was symbolic of the tears and devastation felt by all upon news of her passing.

Emmeretta was born on October 24, 1956 to the late Leonard E. "Jack" and Glenore T. "Betty" (Boivin) Miller. Emmeretta was a graduate of Bowler High School and the University of Wisconsin Oshkosh campus. Emmeretta's major in college was physical education, which she took to Bowler High school and taught for 20 years. She was not finished, when she retired from teaching she went on to work for the Stockbridge Munsee Tribe in their payroll department where she managed staff until retirement. Along with her late husband they owned and operated the convenience store in Neopit, Kenah Mecem. In her youth she was the proud representative of Polaris snowmobiles.

Emmeretta, her late husband, Norbert Miller, their daughter Dory and family dog, Presley lived both

on the Stockbridge Munsee and Menominee Indian Tribe reservations.

Emmeretta was a generous native soul carrying on the traditions of hospitality, love, generosity and encouragement. To one loving nephew she was called, "Retta". Family enjoyed her cooking lessons (bread, rolls baked in Grandma Leoris's historic bread pans) and heritage recipes created with love. She was an avid QVC shopper; they're going to miss her! She belonged to a food group on Facebook and loved her conversations with them. One niece best described her important role in our family, "she taught us how to be strong, how to take care of others, how to cook and how to bring the family together." Either by purpose or design she became our family's Matriarch after our mother passed away.

Emmeretta is survived by: her daughter, Dory Miller; her siblings, Linda (David) Boundy of New York, Trilby Beauprey (Glen) McIntosh of Shawano, John (Cindy) Miller of Gresham, Terry (Debbie) Miller of Bowler and Mary (Wally) Miller of Bowler. She is further survived by her pet dog, Presley. Nieces, nephews, aunts and uncle also share in her heritage.

Emmeretta was proceeded in death by her parents and her brother, Luke E. Beauprey III; sister, Jacqueline Miller, grandparents, Jack and Leoris Miller; and Julius and Geraldine Boivin.

Tribe Awarded Funding for Archaeology in the Town of Stockbridge

Efforts will document and preserve local cultural heritage sites of 1739 Meetinghouse and 1783 Ox Roast feast site

The Stockbridge-Munsee Mohican Nation of Wisconsin, with origins in the Hudson and Housatonic River Valleys, announced its plan to conduct two archaeological survey projects in the Town of Stockbridge, Massachusetts funded through a Federal and a local grant. Both projects investigate colonial-era Mohican history of the Town.

One is a project to survey and document the 1739 Meetinghouse on Stockbridge Main Street. The Meetinghouse is the location of where religious services and political meetings were held when the Town of Stockbridge, originally called "Indiantown," was founded as a missionary town for the Mohican people and English to co-exist and co-govern. The Tribe will document the location of the site and, based on this information, submit an amendment to the Stockbridge Main Street Historic District National Register listing.

The Meetinghouse survey project was awarded an Underrepresented Community grant, funded by the Historic Preservation Fund, and administered by the National Park Service, Department of Interior. "These competitive grants will help diversify the nominations submitted to the National Register of Historic Places," said National Park Service Deputy Director David Vela, exercising the authority of the Director.

The second project the Tribe plans to conduct is continuing archaeological testing at the site of a 1783 Ox Roast feast that was sponsored by George Washington as thank you to the Stockbridge Mohicans for their service in the Revolutionary War. This location is also the homesite of Mohican "King" Solomon Uhhaunaunawunmut. A first phase of survey work took place last summer, and this second phase will further provide information to document and

preserve this location important to Mohican, local, and American history. The Ox Roast/King Solomon project was recently awarded funding from the Town of Stockbridge's Community Preservation Commission.

Both of these cultural heritage projects will occur on lands owned by the Town of Stockbridge and with the Town's support: "The Town of Stockbridge is honored to partner with the Stockbridge Munsee Community to investigate both the 1783 Ox Roast and 1739 Meeting House archaeological sites," said Patrick White, Town of Stockbridge Selectman. "Our citizens overwhelmingly supported the funding of the Ox Roast project at our annual Town Meeting in July.

We are grateful that the National Park Service has recognized the historical importance of these efforts by funding the Meetinghouse project."

Heather Bruegl, the Cultural Affairs Director for Stockbridge-Munsee Community similarly stated: "Our time spent in Stockbridge, Massachusetts was extremely significant. It is wonderful that we are able to keep that history alive and discover more. We are honored and humbled to receive these grants."

The Stockbridge-Munsee Community's Historic Preservation Office will be managing the projects and expects the work to take place in spring 2021.

NOTICE TO LAND ASSIGNMENT HOLDERS

The Tribe, in conjunction with Wittenberg Telephone/Cirrinity, is bringing high speed internet to the reservation and surrounding communities in partnership with Wittenberg Telephone. Part of this process involves preparing the route for the high-speed fiber along the roadway and the route to individual homes that sign up for this service.

As part of the route preparation, tribal employees and others

authorized by the Tribe may be on various land assignments from the Tribe and along tribal roadways marking the route, designating wetlands and invasive species areas to ensure proper precautions are taken. These activities will largely be occurring from July 2020 to June 2021.

More American Indian people live in poverty than any other race/ethnicity group in America and this is a serious challenge for American Indian people. Poverty influences access to quality performance opportunities and success in education and careers. For many Indigenous communities, tearing down the walls of poverty enhances opportunities to cultivate education, employment, and training within tribal communities. In turn, Stockbridge-Munsee follows a model of cultivating academic and career mindsets that illuminates

pathways to educational and career opportunities that serve and lift families out of poverty and ultimately helping to build a strong sustainable Tribal Nation in an ever changing world.

The Stockbridge-Munsee Community has a rich history of Education and Career Services as a legacy. Many Stockbridge-Munsee people continue to honor the legacies of past leaders and Dr. Bowman said, "We follow these legacies by crafting culturally responsive programs and services that honor these legacies to shape the future."

- A university, college, or technical college ID card if accompanied by a fee statement for the current semester
- A letter from your tribal government

by the clerk at this deadline. However, we strongly encourage you to request your absentee ballot as soon as possible to allow for time in the postal system. If this is your first time requesting an absentee ballot, you will need to upload a picture of your photo ID when making the request.

Once you fill out your absentee ballot, you will place it in the envelope provided. You will need to sign the envelope and write your address below your signature. You will also need a witness to sign the envelope and write their address on the envelope. You can see detailed instructions for filling out your ballot at elections.wi.gov under the Uniform Instructions for Absentee Voters section. Absentee ballots must be received by Tuesday, Nov 3, 2020 before 8:00pm.

The easiest way to request an absentee ballot is by going to wcv.votewisconsin.com/absentee. Once you are registered to vote, you can request an absentee ballot. This allows you to safely vote by mail so that you don't have to wait in line at the polling station. The deadline to request an absentee ballot is October 29th at 5p.m. Your application must be received

Paid receipts and/or invoices that include vendor information MUST accompany the completed application for payment to be processed.

Reimbursement can be made by check or direct deposit to the applicant's bank. Payment may also be made directly to a vendor on their behalf by submitting an invoice showing their account number.

Completed applications along with the required receipt/invoice documentation must be submitted by the deadline of December 1, 2020 by 4:00 p.m. via mail, electronically or in person.

BE IT FURTHER RESOLVED, that the Stockbridge-Munsee Tribal Council hereby grants and approves a limited waiver of the Tribe's sovereign immunity specifically for the enforcement of the terms of the Lease of Land. This waiver of sovereign immunity is limited to the terms and conditions set forth below and shall be incorporated as written into the Lease of Land.

The limited waiver of the Tribe's sovereign immunity is granted only to and for the benefit of the tribal member and shall not extend to any other entity or person, except for such successors or assigns that are appointed through the operation of the Lease of Land. The limited waiver of the Tribe's sovereign immunity is granted only for the following remedies: actual damages, a writ of mandamus, or an injunction.

Any action against the Tribe under the limited waiver of sovereign immunity may only be held exclusively within the courts of the Stockbridge-Munsee Community and the law to be applied in any such action shall be Stockbridge-Munsee tribal law.

The limited waiver of sovereign immunity contained in this resolution shall be effective only after the full execution of the Lease of Land between the Tribe and the tribal member and the closing of a loan with a federal lending agency or a private lender in accordance with the Lease of Land.

The limited waiver of the Tribe's sovereign immunity is not a waiver of the sovereign immunity of any tribal official, employee or agent.

Any dispute resolution action against the Tribe, as consented to through this limited waiver of sovereign immunity, shall be brought in Stockbridge-Munsee Tribal Court. Seconded Marv Malone. Motion carried.

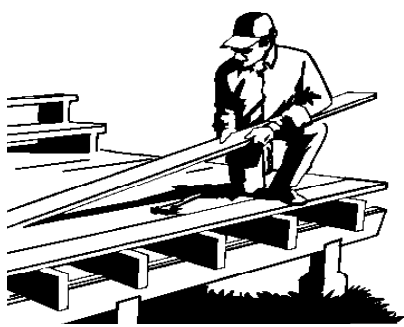
