#### Geothermal at the SMHWC



The clinic is replacing the heating/ cooling system in the building. They are switching to Geothermal, a more energy efficient and less expensive way to heat ang cool buildings. The contractor drilling is the geothermal wells. The contractor is installing 39 loops of hoses that go deep into the ground where ground temperatures are more constant. These wells will either heat up or cool down water inside the hoses that will be fed into the building. Specialized equipment (geothermal heat pumps) will use the constant

temperature water to either heat or cool the clinic.

A geothermal heat pump (GHP) or ground source heat pump (GSHP) is a central heating and/or cooling system that transfers heat to or from the ground, often through a vapor-compression refrigeration cycle. It uses the earth all the time, without any intermittency, as a heat source (in the winter) or a heat sink (in the summer). This design takes advantage of the moderate temperatures in the ground to boost efficiency and reduce the operational costs of heating and cooling systems. They are also known by other names, including geoexchange, earthcoupled, earth energy systems. The engineering and scientific communities prefer the terms "geoexchange" or "ground source heat pumps" to avoid confusion with traditional geothermal power, which uses a high temperature heat source to generate electricity. #### The First Vaccine is in!

The first vaccines are in people's arms! On December 13, 2020 the Stockbridge-Munsee Health and Wellness Center (SMHWC) was advised that all their hard work paid off and they were receiving 75 doses of the Pfizer Covid19 vaccination in less than 48 hours. Tribal Council, along with clinic administrators, began working closely with Pharmacy and the Medical teams to plan for pick up, transportation, and vaccine administration.

It was decided that the Director of Pharmacy Dr. Christian Bialk would be transported to the Green Bay airport by Councilmember Joé Miller and a police escort to receive the vaccine, monitor temperatures, and ensure overall vaccine integrity. They arrived to take delivery from IHS commissioned corps via a coast guard helicopter. An important consideration is vaccine stability, temperature monitoring, and storage. When they received this



vaccine, the ultra-cold chain was broken so a 120-hour countdown began before it even arrived. This had to be a highly coordinated effort to ensure this life saving vaccine was not contaminated or wasted.

Once they arrived back to the clinic, Dr. Bialk held one final readiness meeting with clinic director, Andy Miller, and Nurse Sabrina Miller who would be administering the

#### How the Electoral College works in Wisconsin

The Electoral College was established in the U.S. Constitution and later modified by the 12th and 23rd Amendments. Wisconsin has 10 electors in the Electoral College. That number is determined from the state's eight members in the House of Representatives and two members in the Senate. Our own President Shannon Holsey is the representative for District Eight

On Nov. 30, 2020, Gov. Evers signed the Certificate Ascertainment, which certified Wisconsin's election results for President-elect Joe Biden and President-elect Kamala Harris. The members of the Wisconsin Electoral College met on December 14, 2020 and cast their votes for the 2020 presidential election and the electoral college will officially assign Wisconsin's 10 electoral college votes to President-elect Biden and Vice President-elect Harris. the candidates who received the most

#### Mohican Family Center

Adjusting to a "new normal" has not been an easy feat for the Mohican Family Center (MFC). On any given afternoon the lobby was filled with the voices of our community youth, the cardio/weight rooms were bustling with client and staff chatter and from time to time you could see elders walking together in the gym.

The After-School Program (ASP) Staff were distributing the daily snack, and the ASP/MFC Staff were coordinating a daily fitness activity. The tutor was working quietly with the youth that needed assistance with their homework, while others were shooting hoops or playing volleyball in the gym. Once a month the ASP/MFC hosted a number of different events including family nights, prevention lessons and youth, tween and teen nights and occasionally took the youth on field trips.

My how this pandemic has changed the way programming is carried out. Planning, coordinating and carrying out these virtual program activities has been a daunting task to say the least. Ensuring that the community's elders, youth and families are still receiving the services they need and working to make sure the recommended safety guidelines as set forth by the Tribe are followed is at times extremely difficult. But as they say in show business, the show must go on.

Keeping the programming going in a virtual manner has sparked monthly themed youth activity boxes, that have been distributed by the ASP Staff, you can view the crafts and activities the youth are participating in by searching for the MFC/ASP Facebook Page. The MFC started the Summer out with weekly activity bags and once the youth returned to school, monthly activity bags have been

distributed, along with a coordinated effort between ASP and MFC to host "On the Go" Family Nights.

During these trying times the Tribe had to make some difficult decisions, one being the cancellation of traditional trick or treating. The Council called upon the ASP/MFC, who worked together on a Drive-Thru Halloween Event, that took place on October 30th, 2020. The facility was decorated and families were able to drive through and receive a community candy bag.

The ASP/MFC sends out a big thank you to those departments within the organization that donated candy and other items for the bags. Members of the Division of Community Housing and Public Safety were on hand to distribute their Safety Bags, as unfortunately their annual event was also cancelled.

For Thanksgiving, the MFC hosted a Be Thankful Be Kind Incentive Program, where families participated in events to earn tickets for gift cards to assist with a safe holiday meal. The Annual Community Christmas Party also looked a little different this year, the Drive-Thru Event was held on Saturday, December 18, 2020.

The facility was decked out in holiday décor, the ASP/MFC Staff were all dressed to impress and families were able to wave at Mr. and Mrs. Claus as they drove through to receive their candy bags and holiday gifts. Through the coordination efforts of the Family Services Manager the Toys for Tots gifts were picked up in two different locations and ASP/ MFC Staff helped sort these donations by age group. #### Request for Proposals Mini Farm Business Grants

The Native American Agriculture Fund has provided the Stockbridge-Munsee Community with \$6,500 for grants to Tribal Member Farmers. Approximately six grants will be awarded, and an applicant may request \$500 to \$1500 for qualified expenses.

To be eligible, an applicant must operate a "Farm" type business that produced, sold, or distributed any agricultural products during 2020 and incurred expenses of over \$500 or in the case of a beginning farmer must submit a detailed business plan. Funds may be used for: equipment, soil amendments, supplies to add value to a farm business or that create efficiencies within the business. Funds may not be used for: general utilities including animal feed and fuel and where tribal law prohibits the sale of communal resources.

Applications are due to the Tribal Secretary, by 4:00 pm January 15<sup>th</sup>, 2021. Applications may be

submitted in person or by mail:





vaccine to go over time considerations, how they would vaccinate, management of anaphylaxis, proper aseptic technique, safety, getting EMS on sight, and getting patients scheduled for the vaccine so they could began vaccinating.

The team administered 25 doses on December 16th with precision and no adverse reactions. After doing some research, the Pharmacists noted that they could potentially get one more dose from the multi dose vial of vaccine. Originally the vial was approved for five doses; however, it appeared that they could extract more.

After meeting with Health center director, Andy Miller, first thing on December 17th to discuss the issue, he immediately contacted IHS where they were advised the FDA approved the extra doses to be extracted and administered. By the end of the day on the 17th the vaccine team composed of administration, Pharmacy, and

Medical executed flawlessly and administered 85 of their 75 original doses without any incidence of adverse effects.

There is a criterion set up to determine who receives the vaccination. Along those lines, our own reporter Thomas Kazik volunteers to hand out food in the food program and he qualifies to receive the shot. Thomas said, I have not felt any adverse effects from the vaccine and I look forward to the protection it provides as I work serving the Community". He received his vaccination on December 17, 2020.

This evolution was a highly coordinated, precise event with multiple departments in the clinic collaborating. It was truly a team effort to ensure safety, no waste, and to minimize adverse events for the Community. The SMHWC made history vaccinating against Covid-19 and will mark the beginning of the end of this devastating virus.

In Wisconsin, each of the state's political parties with a candidate on the ballot — in 2020, the Democratic, Republican and Constitution Party — chooses an elector from each of the state's eight congressional districts. They also select two electors from the state at large.

Wisconsin goes by the winnertakes-all system, so the winner of the state's popular vote receives all the state's Electoral College votes. The party of the winner determines whose electors cast their votes in the college. So, with Biden certified as the winner of Wisconsin all the 10 Democratic Party electors were the ones casting ballots in the college.

The electors vote on an individual ballot and sign it. On January 6, 2021 Congress meets in a joint session to count the electoral ballots. And on January 20, the president-elect is inaugurated as president of the United States.

Earth's surface from solar energy. Ground source heat pumps are recognized as one of the most efficient heating and cooling systems on the market. GSHPs offer numerous advantages for space heating and cooling applications as well as heating domestic hot water and are therefore growing in popularity. The type and capacity of the GSHP and heating loop employed for a given application depends on the type of building(s), land availability and legal, and other requirements of relevant government bodies. GSHPs offer potential to reduce greenhouse gasses emissions for heating and cooling applications. compared to fossil fuel-based space heating systems as well as air-source heat pump systems.

Because of their stellar efficiency and the fact that they, unlike other comfort systems, do not emit carbon dioxide or greenhouse gases, geothermal systems are recognized by both the EPA and U.S. Department of Energy as the most environmentally friendly way to heat and cool your home or business. Additionally, they do not emit carbon monoxide, as they do not operate via combustion, offering the opportunity for enhanced indoor air quality. Compared to the typical furnace, which is capable of lasting 10-15 years with regular HVAC maintenance, geothermal systems usually last 15 years or more, with their ground-based components, or 'ground loops,' holding an incomparable 50 year warranty. Housed underground by vour home or business where they are protected from rain, snow, ice, and vandalism, they suffer far less wear and tear, enjoying added reliability compared to traditional heating and cooling systems. This is huge step moving forward in a going green environment.


