Historic Preservation Office Moves to Massachusetts

Our Historic Preservation Extension Office has a new home! The office has recently moved from Troy, New York to Williamstown Massachusetts, thanks to an agreement that our Tribal Council approved with Williams College in October.

The office space is at no cost to the Tribe and is in a visible location at 86 Spring Street, along the main business district in town. The agreement also holds the commitment for more support through the college community such as internships or other partnerships.

Williamstown is within Mohican homelands in the corner of northwest Massachusetts, bordering New York and Vermont. In addition to documented Mohican cultural sites in the area, including a healing spring, the location is historically significant as well because the Williams family that founded the Town of Williamstown and Williams College were the major grabbers of our tribal land in the 1700s when we were in Stockbridge. It is therefore a "full circle" moment to be reclaiming space there.

New Natural Resource Technician

Chris Rosenthal is the new Natural Resource Technician. He will be continuing the work and programs Alex Brauer had managed: including solid waste management, recycling, composting, unsightly yard issues and assisting with weed/invasive species control, environmental surveys and sampling, and environmental site assessments.

Chris completed his Bachelor of Science degree from UW-Stevens Point in 2014 with a major in Fisheries and a minor in Biology.

After college, he worked for Hickey Brothers Research, LLC in Yellowstone National Park as a Fisheries Technician. The park service contracted with Hickey Brothers Research, LLC to aid in suppressing the invasive lake trout found in Yellowstone Lake to protect and improve the native Yellowstone cutthroat trout population. When the field season concluded in Yellowstone, Chris came back to Wisconsin and spent the next six years working for Cason & Associates, LLC, a family-owned land and water management contractor, as their Pond Division Manager and Aquatic Ecologist. Konkapot Transformation

On August 24th, 2020, the Tribe closed on the purchase of The Konkapot Lodge from the Merton Vele family. The purchase came at an opportune time, with the need for social distancing due to the COVID-19 Pandemic, 27 hotel rooms have been transformed to offices. Shawano Highway Dept worked to add a new driveway into the Konkapot parking lot. The expected move in date is scheduled for Wednesday, December 2, 2020, pending the completion of all renovations and the assembly of all new workspaces.

This move will allow entire departments to be brought together under one roof, such as the Tribal and Casino Human Resource Departments. Along with the entire Human Resource staff, the Mohican News and the Education Offices. All employees will receive their own offices and there will be a conference room and meeting room, which will be a great fit for the Tribe's long-term strategic plan for office space needs, as well as, brings the opportunity for continued growth. The Executive Director and his Property and Equipment crew have been working diligently on the renovations needed to bring this plan to fruition. The Tribes purchase of Konkapot allows the Tribe to eliminate employees from shared office spaces and move them into individual office spaces which is critical in order to mitigate the spread of COVID 19, an

airborne virus. In addition, it allows greater efficiencies while reducing logistical challenges.

In preparation to convert the Konkapot lodge building to safe office spaces, the following COVID renovations took place:

- P&E painted and patched the entire interior
- Floors Unlimited converted the flooring from carpet to commercial grade laminate
- Filbrandt Plumbing removed the jacuzzies and the associated plumbing
- Kallies Electric installed LED ceiling lighting in each room
- We converted the building entry system to card entry
- Martin Systems converted the room entry system from cards to keys
- MIS Installed IT infrastructure
- MIS installed a "Smart" meeting room for conferences and virtual meetings

Work began on September 21, 2020 and is scheduled to be completed on November 27, 2020. Brian McDonald, CIO and Charles Gardner, Facilities Manager have done an exceptional job of coordinating internal work and external contractors to have the project completed in just over 2 months.

The move to Konkapot is scheduled to begin December 2, 2020. Entire departments moving to Konkapot are Human Resources, Education and Mohican news. In addition, our Administrative Assistant and 4 IT staff will be moving as well.

Nathan Allison Magnificent Mohicans Dorothy "Dot" Davids

From Great Depression to associate professor. A life of humble beginnings and lofty heights. Dorothy Winona Davids was an educator, feminist, and community leader and advocate. In speaking to her development through the years, she proudly stated she had grown from "colonized American Indian to an increasingly aware and resistant Native woman."

Dorothy was born in 1923 on a small farm in Red Springs,

Wisconsin. Her parents were Eureka Jourdan Davids and Elmer Davids. Like others at the time, the Davids family lost their farm to the financial crisis the Great Depression brought about. As a young child, Dorothy spent time at the Lutheran Indian Mission School in nearby Gresham. Of her contemporaries from the Reservation, Dorothy was the only to graduate from Bowler High School that year. She soon enrolled in college at Wisconsin State Teacher's College Steven's Point. By the end of WWII, she had become the first Native American to earn her undergraduate degree in education from the school.

In the early 1960s

Dorothy became involved with the National Congress of American Indians spending a summer on staff in Washington DC. She graduated with an MA in education from University of Wisconsin Milwaukee. These were formative years as she pointed out in an interview, "after all these years of alienation....of burying who I really was-all of this new activity put me back together." She spent over 16 years teaching at elementary and junior high schools in her community. She later served as associate professor of education and community development at University of Wisconsin-Extension in Madison. As educator and activist Dorothy was ahead of her time. She frequented protests and spoke at conferences. She advocated for more inclusive curriculums focusing on Native American peoples, particularly

drawing attention to the biases in contemporary education and lack of focus on Native American women. In retirement Dorothy continued her life's passion in education and reform. She spoke out openly against injustices faced by Native American communities.

Dorothy was a prolific author of educational materials, poetry, and historical research on the Stockbridge-Munsee Community. These works span decades and are still part of school curriculums. Her contributions are collected and archived at the Arvid E. Miller Library and Museum. Her legacy lives on in the community, in student's she educated, and her lessons they pass down. Aunt Dot aspired to make her community better for tomorrow saying, "When you go into the world, take your whole self with you-take your roots and plant them in your new world."

When COVID-19 vaccine comes, Veterans Administration will be ready

Planning is underway at VA to deliver a COVID-19 vaccine when one becomes available. VA is working with the Centers for Disease Control and Prevention (CDC) to develop a phased plan based on five core ethical pillars: safety, maximizing the benefit of the vaccine, equity, fairness and transparency.

Veteran and employee safety remain our #1 priority. The plan takes into consideration a number of risk factors, including risks of acquiring infection, severe illness and death if infected, and transmitting the disease, as well as the risk to essential workers, including health care personnel.

Offering the vaccine first to health care personnel and Veterans

Initially, we expect supplies to be limited. Based on these risk factors, VA will offer the vaccine first to high-risk health care personnel (HCP), as they are essential in continuing to care for patients throughout the pandemic. As more vaccines become available, VA will offer the vaccine to high-risk Veterans. VA's ultimate goal is to offer it to all Veterans and employees who want to be vaccinated.

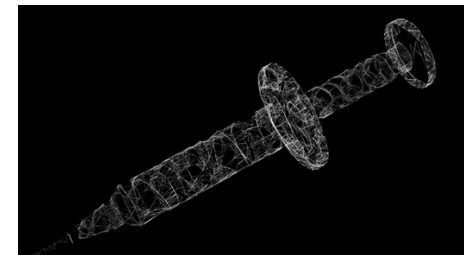
Preparing VA facilities

VA medical centers across the country performed planning exercises in late October to prepare for initial receipt of the vaccine. These exercises help sites determine how they will distribute immunizations. They based the decisions on the number of doses available and coordinated communications with Veterans to schedule their immunization.

They also addressed ordering, storage, handling, and administration of the vaccine.

Listening to Veterans

Additionally, VA has been conducting listening sessions and interviews with Veterans across the country to gauge their interest and determine the best methods for reaching out to our diverse



Veteran population. Your local medical facility will update you as vaccines become available.

The U.S. Department of Veterans Affairs (VA) announced today it is working with the Centers for Disease Control and Prevention (CDC) and other federal partners to develop a comprehensive COVID-19 vaccine plan to ensure VA safely and equitably distributes vaccines once authorized.

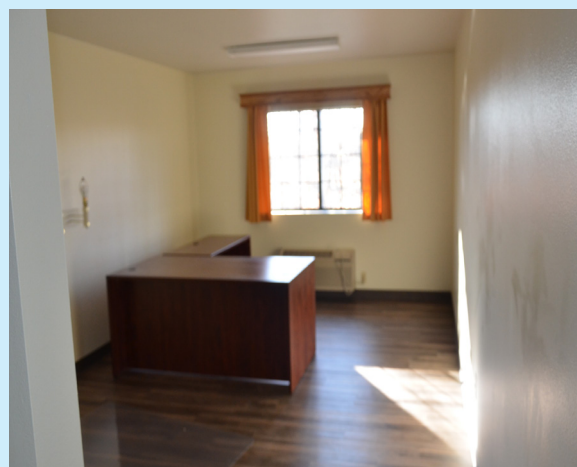
The plan will be a phased approach based on scientific and historical evidence, lessons learned from past pandemic vaccine plans and input from scientific experts both within and outside VA.

"In October, staff at VA medical facilities conducted important planning exercises in preparation for the vaccine," said VA Secretary Robert Wilkie. "These exercises help us to address vaccine distribution, allocation, safety monitoring and supply tracking."

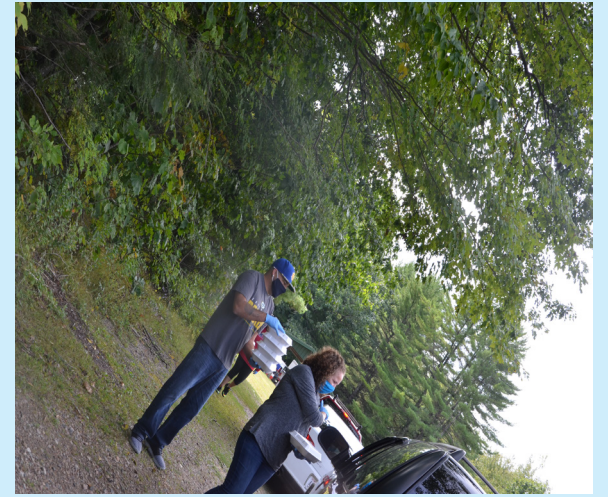
COVID-19 vaccine implementation will include an initial limited-supply phase followed by a general implementation phase, when large supplies of the vaccine will be available to Veterans who want to receive one.

VA experts in ethics, health equity, infectious disease, logistics, pandemic planning, pharmacy and public health as well as those in the areas of change management, clinicians from various disciplines, data, education, IT, safety and training, along with government partners, were sought for input to help develop the plan. VA also conducted Veteran listening sessions for valuable feedback in the planning process.

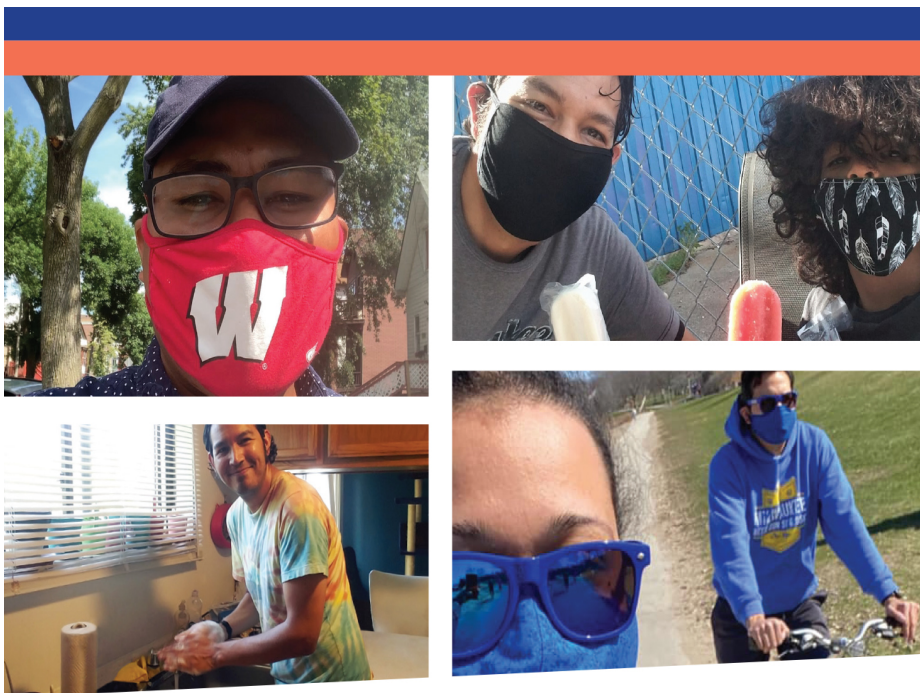

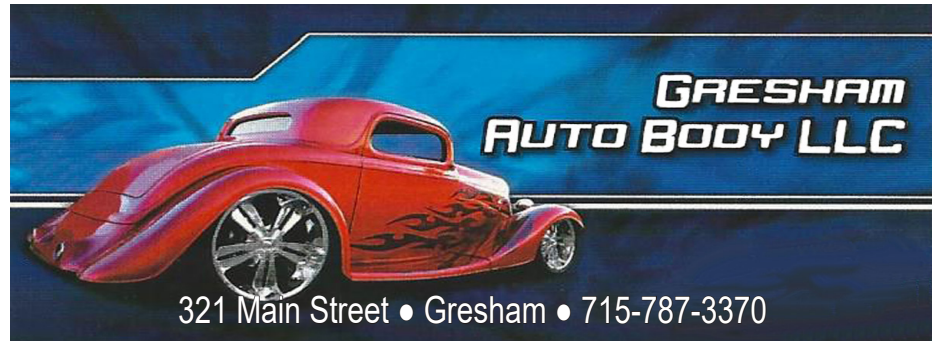
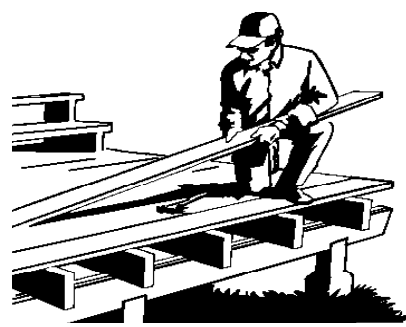
