Holsey also serves as President of the Great Lakes Inter-Tribal Council, representing the eleven member tribes in Wisconsin and as the Treasurer of the National Congress of American Indians, the oldest, largest and most representative American Indian and Alaskan Native organization. Holsey has been active in Democratic politics and was chosen as one of Wisconsin's electors to cast the state's Electoral College votes for President Joe Biden and Vice President Kamala Harris in 2020. "I could not be more excited to have the support of President Shannon Holsey," said Alex Lasry. "President Holsey has been a leader both in Wisconsin and nationally and has been a strong advocate for Wisconsin's tribal nations. I look forward to working with her and I'm extremely grateful to have her on our team as we continue to build the statewide coalition to start delivering real results for the people of Wisconsin."

Milwaukee - Alex Lasry today announced the endorsement of Shannon Holsey, President of the Stockbridge-Munsee Band of Mohican Indians. President Holsey is the latest addition to a growing list of people from across the state who are supporting Alex Lasry to be Wisconsin's next U.S. Senator.

Covid Statistics for Everyone



Thomas Kazik II - News reporter The Stockbridge Munsee Health and Wellness center has been utilizing Mohican North Star casino as a vaccination center for a couple of months now. Here are some of the COVID-19 testing statistics completed at the SMHWC through March 12 2021.

The total number of people tested is at 5,052. The total number of negative test results is at 4,779 which puts us at a 94.5% since Covid had started in March of 2020. There were 273 Total Positive Cases which comes to a percent-

age of 5.4%. The number of total positive cases who live in Shawano or Menominee counties that were tested by the Tribe's efforts are 251. Tallying the full amount of people ever hospitalized, we stand at 17. Of the Tribe's positive cases we have had 270 recovered cases but have suffered 3 deaths due to Covid-19.

Now, here are some of the Covid-19 Vaccination Statistics from the Stockbridge Munsee Health and Wellness Center. On March 10th and 11th, the Clinic

Pharmacy Update

March 1, 2021 marked the first day of a new program offered at the Stockbridge-Munsee Health and Wellness Center.

The pharmacy now offers services to assist with commercial tobacco and nicotine dependence with both in-person and telephone appointments.

Dr. Lindsey Janowski is certified as a Tobacco Treatment Specialist through the Mayo Clinic in Rochester, Minnesota.

Lindsey is passionate about smoking cessation and the potential to drastically improve the lives of her patients. She also is excited to incorporate native practices and traditions into the standard approaches to cessation as we remain mindful of the culture within our community.

In the Mohican teachings of Captain Hendrick Aupaumut on how to live a good life: "If a person neglects to live their life by the teachings of their ancestors, there are consequences per the natural

 order of things. Failing to be a good-minded person could cause the individual to bring illness upon themselves. Those illnesses could be mental, emotional, or physical. By not taking care of the mind, the body and spirit also become out of balance. This can lead to a hard and difficult life. In some cases, even a limited or shortened life."

For this reason, the team felt

it was worth putting great care into considering the physical, emotional, spiritual, and mental aspects of the patient's health and well-being when approaching treatment of commercial tobacco and nicotine dependence.

Current standard of care for smoking cessation is to provide both pharmacotherapy (prescription and over-the-counter medications) and behavioral therapy to any patient seeking treatment in an effort to improve the chances of abstinence.

The Stockbridge-Munsee community is equipped to provide our community with various support options in addition to one-on-one meetings with a pharmacist.

Patients will have optional support from behavioral health, community health, medical, and dental departments as well as a registered dietician, state or American Indian Quit lines, and native medicine and healing techniques as taught by members of our community.

Teaching Program

Al Betry, the Executive Director of the Cooperative Educational Services Agency (CESA) 9's Excellence in Teaching program would like to share a possible pathway to teacher licensure that could be shared within the community. DPI-approved teacher licensing program was created in 2017 to address Wisconsin's teacher shortage in schools and to provide a non-college pathway for people who wish to become teachers. They accept students with bachelor's degrees in various content areas and provide them with the necessary training to be effective, Wisconsin-licensed teachers. In the first three years of the program, they have trained 48 students in the areas of science, math, world languages, social studies, physics, English/language arts, art, theater, health, business, and special education. Their students are often second (or more) career people and, so far, range in age from their 20s to 50s. They are proud that they have been able to provide this opportunity for the students and provide quality teachers for our schools.

They are always looking for new students who have the desire to work with kids and who can bring

Markie earned her Associates degree in Early Childhood Education from the College of Menominee Nation on May 14, 2016. She has made CMN's Academic Deans List for two semesters and has participated in the Keshena 4-H events, CMN College Night, and STEM seminars. their diverse life experiences to the classroom. They are contacting all in effort to recruit people who would be interested in the program. The Wisconsin Policy Forum's 2020 report: A Teacher Who Looks Like Me, highlights current Wisconsin school data and the need for a diverse teaching population. Also, on 6/26/20, state school superintendent, Carolyn Stanford Taylor, released a statement which in part read, "...we must diversify Wisconsin's educator workforce. 98% of our teachers in Wisconsin are White. We know having teachers of color benefits all students, not just students of color." CESA could not agree more. Perhaps there are substitute teachers,

paraprofessionals, or parents currently in area schools, former students, or others who enjoy working with youth in the community, who would consider becoming teachers. Teachers are change agents and do in fact change lives and it is the hope that their program, in its small way, can help to increase the number of teachers from diverse backgrounds in Wisconsin's schools. CESA can certainly provide more details about the program (curriculum, format, duration, cost, etc.) and how you might fill teaching positions with our students while they are in the program. Some Tips Before You Get Started

First, obtain any burning permits that may be required before burning. In many areas, homeowners may be required to get a burn permit from your local DNR station if piles are larger than listed below. After obtaining any necessary permits, ensure that burning is not currently restricted in your area.

How to Safely Burn Landscape Debris

- Landscape debris piles must be in small 6 feet by 6 feet by 6 feet piles.
- Maximum pile size is 6 feet in diameter.
- Clear all flammable material and vegetation within 10 feet of the outer edge of pile.
- Keep a water supply and shovel close to the burning site.
- A responsible adult is required by law to be in attendance until the fire is out.
- No burning shall be undertaken unless weather conditions (particularly wind) are such that



burning can be considered safe. It is important for residents to stay mindful of current weather conditions when burning. If it is windy and the surrounding vegetation is very dry, it may be best to wait and burn landscape debris another day.

Stats cont from page One: successfully provided 682 doses of vaccine. 2,943 doses of Covid-19 vaccine have been administered by the Tribe through March 12, 2021. The number of people who received both doses of vaccination sits at 984. The number of people who received first dose and awaiting 2nd dose sits at 975. Of these vaccinations handed out the SMHWC gave area teachers an early opportunity to receive their vaccinations. Bowler School recorded 49 Staff members out of 69 received the Covid-19 Vaccination. Gresham School did not have specific numbers, but Superintendent Newell Haffner mentioned "We are very thankful to have the opportunity to have out staff vaccinated and almost 50% of staff were going to receive the Covid-19 vaccination". The clinic provided the Shawano School District with staff vaccination and, 180 of their 315 staff members received their vaccinations. The federal government allocates COVID-19 vaccines to Wisconsin based on population size. Once the vaccine is allocated, Wisconsin places an order with the federal government so they know exactly where to send the vaccine. The total number of co-

vid-19 vaccines administered in Shawano County is at 14,014 the week of March 14th. Shawano County's population is at 40,899 which gives a percentage of 34% receiving at least the first shot. This information was provided by (<https://covid.cdc.gov/covid-data-tracker>). From that website click on the vaccinations tab and it how the US as a whole is doing for vaccinations. Starting March 22, the Wisconsin Department of Health Services (DHS) announces that people age 16 and older with certain medical conditions associated with an increased risk of severe illness from COVID-19 are eligible for the vaccine. This newly eligible group adds approximately more than 2 million people into the population eligible for the vaccine. All groups now currently eligible for the COVID-19 vaccine include frontline health care personnel, residents and staff in skilled nursing and assisted living facilities, police and fire personnel, correctional staff, adults aged 65 and older, educators and childcare staff, individuals enrolled in Medicaid long-term care programs, some public-facing essential workers, and non-frontline essential health care personnel.

Safety cont from page One: She completed two years at UWSP before taking an extended break until 2008. In 2008 she enrolled in classes at College of Menominee Nation in the Criminal Justice field. In 2010, Officer Creapeau received her Certificate of Complete in Criminal Justice. She then transferred to Fox Valley Technical College and in 2012 she received her Associate's Degree in Criminal Justice. Mary continued her education with Marian University and received a Bachelor's Degree in Criminal Justice in 2015. She has sporadically taken classes for her Master's Degree in Criminal Justice but has taken some time away from studies to focus on her family and career. Lieutenant Creapeau said that she intends to continue the pursuit of her Master's Degree soon.

After graduating high school in 1992, Mary worked the summer at Marion Plywood Corp. In 1994, she started working for Mohican North Star Casino and remained employed there for 18 ½ years until April 2013. In February of 2013 she began working part-time as a deputy sheriff for Menominee County. In April of 2013, Officer Creapeau began working as a

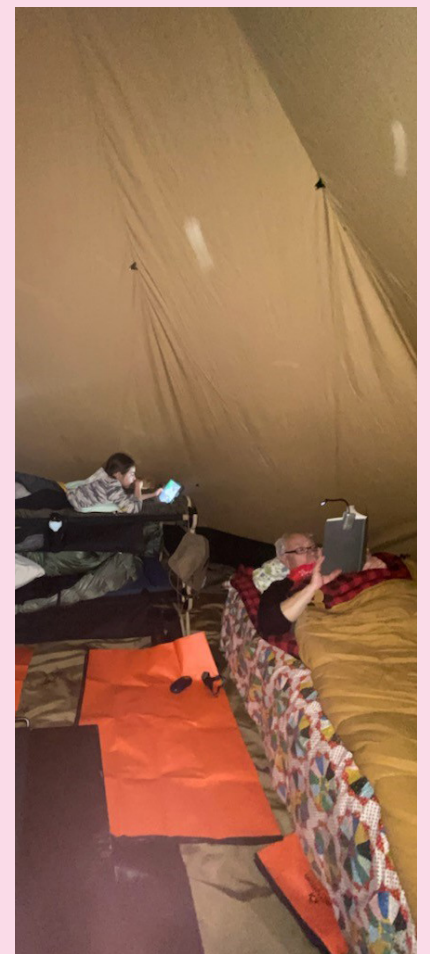

Be Fire Smart: Get A Free Burning Permit Now

Fire Danger Remains High For Parts Of Wisconsin

MADISON, Wis. – Now more than ever, our favorite outdoor spaces are playing an important role in our lives. Together, we can keep these safe places safe. Whether we are out in nature or home in our backyards, remember that it's our role to protect the lands we love by preventing wildfires and recreating responsibly.

With weekend forecasts predicting warm temperatures, fairly low humidity and high winds, the Wisconsin Department of Natural Resources (DNR) expects fire danger to be high across the state this weekend.

With Wisconsin wildfire season underway, the DNR reminds Wisconsinites to be fire smart this spring and get their free annual burning permit. Unlike out west, the spring is the most dangerous time for wildfires in Wisconsin. After the snow melts and before plants, trees and grass turn green, fires can spread quickly.

"Weather is the single most important factor influencing how fires start and spread," said Ron Weber, DNR Forester, adding seasonal warm and dry weather conditions increase wildfire activity. "Temperature, wind, humidity and precipitation are the key weather components that determine the daily fire danger."

Fire danger is high today across much of the state including the following counties: Adams, Ashland, Barron, Bayfield, Brown, Buffalo, Burnett, Calumet, Chippewa, Clark, Door, Douglas, Dunn, Eau Claire, Fond du Lac, Green Lake, Iron, Jackson, Juneau, Kewaunee, La Crosse, Lincoln, Manitowoc, Marathon, Marquette, Monroe, Oneida, Outagamie, Pepin, Pierce, Polk, Portage, Price, Rusk, Sawyer, Sheboygan, St. Croix, Taylor, Trempealeau, Washburn, Waupaca, Waushara, Winnebago and Wood counties.

The DNR requires burning permits in many parts of the state to conduct legal and responsible burning outdoors. Burning permits are free and easy to obtain and protect lives, property and natural resources from the damages of wildfires.

Debris burning is the leading cause of Wisconsin's wildfires. Fires caused by careless burning become more frequent this time of year. The 2021 fire season follows a winter with below-normal snow depths. Fire control officials are focusing on the potential for statewide fire activity as the snow is rapidly melting at the same time. Wildfires can happen just about any time of the year, but historically, 60% of all annual wildfires in Wisconsin occur in March, April and May alone.

"Many people are eager to get

outside to clean-up their properties by raking leaf litter, brush and needles, so it looks good and is ready for new growth," Weber said. "Then, they choose to burn their debris pile. Consider composting yard waste or hauling it to an approved disposal site. Burning debris should always be the last alternative."

Burning Permit Suspensions Are Based On Wildfire Risk

The DNR suspended all burning permits throughout spring 2020, Wisconsin's peak for wildfires, due to increased safety concerns resulting from COVID-19. This year, the DNR plans to suspend burning based on wildfire risk. However, to promote social distancing, burning permits are not being issued in-person by Emergency Fire Wardens or at DNR service centers.

"Wildfires on the landscape will continue to occur despite the COVID-19 outbreak," Weber said. "In an effort to increase public and firefighter safety and reduce human-caused ignitions or escapes, the department will take appropriate steps to prevent wildfires and minimize in-person contact both with the public and among fire personnel."

Burning permits are required in DNR Protection Areas once the snow cover is gone. Permit holders are authorized to burn vegetative

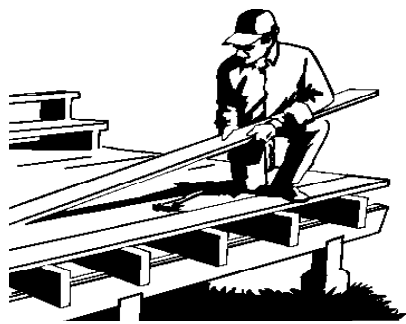

materials, such as leaves, brush
and needles so that burning is
done safely with minimal wildfire
risk.

Permits are free and can be
obtained online and instantly
emailed or issued over the phone
and delivered by the Postal Service
within three to five business days.
Get your annual DNR burning
permit by completing the online
application here or by calling
1-888-WIS-BURN (947-2876).

Once an individual has a burning
permit, remember to check the fire
restrictions in the appropriate
county after 11 a.m. each day
before burning, including the legal
burning hours, size limitations or if
burning is suspended for the day.

Small campfires for warming or
cooking do not require a burning
permit.

"It's important to check the daily
fire restrictions each day before
you burn," Weber said. "With a little
planning and dedication to getting
your burn permit and following the
rules, we can all work together to
prevent wildfires."

Because the DNR does not
regulate all areas across state,
it's essential to check with local
municipal or fire department
officials for any ordinances or
other burning restrictions.
