Internship Summary and Description

This is an advanced position for an experienced student to evaluate the climate change concerns of Tribal members who harvest maple sugar via interviews. This will be done under the guidelines determined by the IRB and MLCC and the guidance of the SDI team. The intern will also work on a presentation for our Report Out event to explain the findings and their significance to members of the Menominee Nation.

Internship Learning Objectives and Responsibilities

- Participate in orientation and team building activities with other interns to facilitate learning and growing together.
- Finish MLCC approval process for survey instrument and plan.
- Respectfully interview maple harvesters according to the survey plan, IRB, and MLCC guidance.
- Record and evaluate survey data, often independently, to generate a new understanding of how climate change might impact Menominee Maple Sugar Harvesters.
- Attend NECASC meetings through March as the designated CMN student intern.
- Present an overview of your findings to CMN and the broader community according to IRB and MLCC guidance.
- Have fun!

Program Requirements/Qualifications:

- Must be registered or currently enrolled in six (6) or more credits
- Must be a degree seeking student enrolled at the College of Menominee Nation or other accredited College or University. (Certain documentation may be required to confirm enrollment status.)
- Must have completed at least one (1) year of study
- Student must be 18 years of age or older.
- Must have a cumulative GPA of 2.5 or better on a 4.0 scale.
- Internship must be related to students' academic degree program.
- Familiarity with IRB and MLCC approval processes.
