Summer 2021 Archaeological Excavation in Mohican Homelands

The Historic Preservation Office (THPO) in Williamstown, Mass. would like to provide a community update on the Cultural Affairs Department's archaeological excavation that began in early July. The excavation focused on identifying the 1739 Meetinghouse and the 1783 Ox Roast sites in Stockbridge, Mass., a town established for the Stockbridge-Munsee Community's ancestors as an experimental missionary town, co-governed by Mohicans and English colonists during the eighteenth century.

Despite the Stockbridge-Munsee Community's history in the homelands since time immemorial, few monuments, signs, or references to the Mohican Nation's history are visible in Stockbridge. THPO intends to identify and protect the 1739 Meetinghouse and 1783 Ox Roast sites from future disturbance and to designate both locations as historic sites on the National Register.

Through the investigation in July, a Stockbridge-Munsee Community-contracted archaeological firm identified the 1739 Stockbridge Mohican Meetinghouse's probable location and, surprisingly, possibly the first evidence of two pre-contact Mohican home sites in Berkshire County, Mass.

The 1739 Meetinghouse Site

The 1739 Meetinghouse site served as Stockbridge's political and religious center in the eighteenth century. Mohican sachems and community leaders advocated for the Stockbridge Mohicans and community members worshiped in the building.

In 2019, THPO applied to the National Park Services for an Underrepresented Communities Grant. Hartley said she received the support of Rick Wilcox, a former Stockbridge Police Chief and a local historian, in preparing **Lands continued on page Five:**

Mohican Miles: Celebrating Mohican History and Culture in the Original Homelands

Bowler, Wisconsin—The Stockbridge-Munsee Mohican Nation, a federally recognized Tribal Nation in Wisconsin with origins in the Hudson and Housatonic River Valleys, recently announced the planned opening of a new exhibit on Mohican history and culture at the Mission House Museum in Stockbridge, MA.

The exhibit, Mohican Miles, was created through collaboration between the Stockbridge Munsee's Cultural Affairs Department and The Trustees of Reservations. Opened to the public on July 2nd, 2021, the exhibit will be accessible to visitors during the hours of the Mission House museum from Thursday-Monday from 10AM to 4PM.

Founded by landscape architect Charles Eliot in 1891, The Trustees



has, for 130 years, been a catalyst for important ideas, endeavors, and progress in Massachusetts. As a steward of distinctive and dynamic places of both historic and cultural value, The Trustees is the nation's first preservation **Miles continued on page Six:**

Cleaning Our Lands For A Healthier Future



Illegal dumping is a burden to residents and is an eye-sore to our beautiful community. Every year, the Tribe hosts two large item pick up and electronic/appliance recycling events and yet, illegal dumping occurs throughout the reservation. Not only is it unlawful to discard garbage, furniture and other unwanted debris on the landscape, it can also contaminate our fragile natural resources. Certain products and goods, such as batteries, can contain corrosive chemicals, oils and other contaminants which pollute the water and soil if not properly disposed of.

Recently, the Environmental Department coordinated with the Public Works, Facilities, Ecology and Forestry departments to clean up a large dump pile that formed near the Public Works

Department building. A brush pile only intended for the Tribe's departments to use quickly turned into a dump site which included furniture, carpet scraps, tires and other household debris. Cleaning up these illegal dump piles costs the Tribe thousands of dollars annually. Keeping our lands and our water clean and contaminate-free is our highest priority, but protecting our resources requires everyone's help to ensure they last for generations to come.

So, how can YOU help preserve our resources for future generations to enjoy?

Many of the items found in the dump pile consisted of household items, such as couches, TV stands, coils of old wire, etc, that could have been repurposed or recycled. With a growing population, our landfills have been reaching capacity

quicker than ever. Repurposing or recycling unwanted items helps prevent our landfills reaching capacity, lowers carbon emissions created by landfills, and helps create a "greener" environment which we live in. Repurposing household items can also generate a little extra cash for your penny bank. With social media easily accessible, there are many quick and easy ways to post goods for sale. Although, if an item must be thrown away, then properly discard it in the garbage, and not on the landscape. The Tribe puts

on two large item pick up events every year (spring and fall) for these specific items. If an item, or items, needs to be discarded prior to the event occurring and it does not fit in your garbage bin, then call to have a dumpster delivered. If we all work together, we can achieve a greener, healthier and more beautiful community for generations to come.

Stockbridge-Munsee Food Distribution Program

The food distribution program will open to the public July 1, 2021, with changes according to the "Public Health Order". To keep in compliance, you will need to wear a face mask covering both nose and mouth if you have not had the COVID vaccination. The face mask will be optional if you have been vaccinated and it has been 2 weeks since your last shot.

The hours of operation will be Monday-Friday 8:00-4:30, unless we must close for some reason. The closing dates will be posted on the door of the building.

Please be honest, if did not receive your COVID Vaccination wear your mask for everyone's protection!

The Food Distribution Program is an alternative to Food Shares. You cannot receive Food Shares and Commodities in the same month.

the historical research for the application.

“As it was not my story to tell, I would provide the raw data to Bonney [Hartley], who would write about the Mohican people on Main Street in Stockbridge in 1750, breathing life into a long-buried history,” said Wilcox.

THPO received the grant and worked with the Township of Stockbridge to prepare for the excavation.

The 1783 Ox Roast Site

George Washington sponsored the 1783 Ox Roast to honor the Stockbridge Mohicans’ service in the American Revolutionary War, only a few months before the colonists displaced them from Stockbridge. According to historical documentation, the Ox Roast took place on land belonging to King Solomon Uhaunaunauwaunmut.

THPO first submitted a grant to investigate the 1783 Ox Roast site in 2018. Wilcox provided his extensive knowledge of Stockbridge history and ecological changes to the landscape to help identify the Ox Roast’s probable location.

Hartley and Wilcox attended Town of Stockbridge Select Board Meetings to obtain approval and also coordinated with the Stockbridge Historical Commission.

According to Hartley, “It’s been a good experience to see the interest build in the Town for collaborating with our Nation regarding our shared history here.”

An earlier excavation took place in summer 2019. Although Hartley said the archaeological investigation did not reveal many artifacts, THPO wanted to continue to look for the site.

The July 2021 Archaeological Excavation

In 2020, THPO hired Morton Archaeological Research Services to conduct an archaeological investigation with community support. Ann Morton, Principal Investigator, prepared a technical report for the Massachusetts Historical Commission and received permission from the State’s Archaeologist to excavate.

Before the archaeological dig, Ohio Valley Archaeology, Inc. surveyed the land to locate soil anomalies. THPO focused on areas with significant soil anomalies to respect the Stockbridge-Munsee Community’s homelands and

ancestral sites.

On July 6, 2021, the archaeological excavation began.

Reconciling History

Three centuries after the Williams family played a pivotal role in displacing and forcing out the Stockbridge-Munsee Community’s ancestors from Stockbridge, Williams College—established in Ephraim Williams, Jr.’s will—provided support throughout the excavation.

Thanks to a partnership agreement with Williams College where the THPO office is now based, the Stockbridge-Munsee THPO recruited over 28 Williams College community members, including students, faculty, and staff, to volunteer at the excavation site. Several community members from other places in the homelands joined as well.

According to Williams College Associate Professor of History Christine DeLucia, “Involving many people in the dig is a powerful way of tangibly conveying the importance of this place . . . Students and colleagues at Williams and in Williamstown are seeking ways to learn more about these places and stories, and it’s so important to do this through tribally led projects, where Mohican expertise and guidance is at the forefront.”

Margaux Kristjansson, a postdoctoral fellow in Native American and Indigenous Studies at Williams College, said she volunteered because she believes the excavation is critical in interrupting colonial mythologies.

“There is a substantial significance in the way this archaeological project linked the past and future jurisdiction of the Mohican Nation on these lands, and the way it called people into responsibility to the Mohican peoples’ continued jurisdiction and rights to their land in this region that has never been ceded by treaty to the US or colonists,” said Kristjansson.

Historic Preservation Assistant Meadhbh Ginnane, and Sacha Yanow, a performance artist and a volunteer for THPO, also staffed an information table at the archaeological site to inform residents about the Stockbridge-Munsee Community’s work.

Looking Forward

Morton said that now that the Stockbridge-Munsee Community has identified the Meetinghouse’s probable location, THPO can prepare to put the Meetinghouse

on the National Register. Soon, Morton said she would send a full report to the Massachusetts Historical Commission.

After the initial cleaning of artifacts, Morton said she would have more to report.

“The findings situate precolonial Mohican homes in present-day Stockbridge, affirming Mohican oral histories as well as written histories from Hendrick Aupaumut onwards irrefutably,” said Kristjansson.

According to Ginnane, the findings are vital in providing a sense of place and protecting Mohican cultural heritage. “No one can erase [the history] because it is here, no matter what anyone has said or done in the intervening time.”

“There are many ways to try and help heal the wounds of history,” said Wilcox. “Research is a small step in that direction by erasing the [colonial] myth of Stockbridge and providing the real story no matter how painful.”

“I hope that soon will come the day

when the youth of the Stockbridge-Munsee Community can come to the homelands as interns and build on the research that has been done to date,” said Wilcox.

According to Trevor Totman, an archaeologist for Morton’s company and University of Buffalo graduate student, the excavation has been a challenging yet rewarding project.

«This was the most gratifying and emotionally exhausting project that I’ve ever been on, but the absolute most fulfilling,» said Totman. “What I am trying to do . . . is give an example of how archaeology can be used to help and to heal and benefit communities instead of just to take.”

In August, the archaeological excavation will continue at the 1783 Ox Roast site. Continue to follow Mohican News for more updates as well as the Arvid E. area, and he recruited Kellie Zahn in Ag department and her team to help with preparing the area for a garden. Erin said that Wally and Willy from the Roads Department came over and pulled out two large stumps that were in that space. Then Twila Shawano and Erin came in on a Saturday to get most of the plants planted. According to Lewis, Joe Miller, Kellie Zahn and her team, then came back over to help with laying the rocks in the garden. Residents from the Ella Besaw Center helped with small tasks, such

as giving their opinion on which plants should go where and helping set up the lights. Lewis ended by saying, "I would like to thank Joe, Kellie and her team, Wally and Willy, Twila, and everyone else who has helped to make this possible. The residents love it, and it makes Ella B look more welcoming, while creating a space for families to sit and remember their loved ones". Memorial Stones can still be purchased to be placed in the garden, and if anyone is interested, they can contact Erin at Ella B.

and conservation organization, and its landscapes and landmarks continue to inspire discussion, innovation, and action today as they did in the past. We are a nonprofit, supported by members, friends and donors and our 120 sites are destinations for residents, members, and visitors alike, welcoming millions of guests annually.

The exhibit covers a wide range of topics including an overview of Mohican History, the Tribe's historic relationship with The Trustees, information about the community today, the work of the Historic Preservation Office in the homelands, and displays of historic objects belonging to the Tribe. "We are excited that we have a place to call ours to tell our history, our way. The history that Mohican Nation has in Stockbridge is significant and we are grateful to be able to tell it," said Heather Bruegl, Cultural Affairs Director for Stockbridge-Munsee Community.

The Tribe curated and designed the exhibit from the archives of the Arvid E. Miller Memorial Library Museum, which houses the largest collection of Mohican documents and artifacts in the world. Trudy Fadding of Stockbridge, through a fellowship at Williams College where the Tribe maintains a Tribal Historic Preservation Extension Office, worked locally with the Tribe's office to de-

velop the exhibit content.

As a result of an agreement with the Trustees, the Stockbridge-Munsee Community will maintain exhibit materials in the Carriage House, the separate exhibit room behind the Mission House, for the next 4 years. This space formerly held many objects belonging to the Mohican people which were purchased by Mabel Choate, the founder of the Mission House. Recently, many of these same objects have been repatriated back to the Tribe after nearly a century of separation.

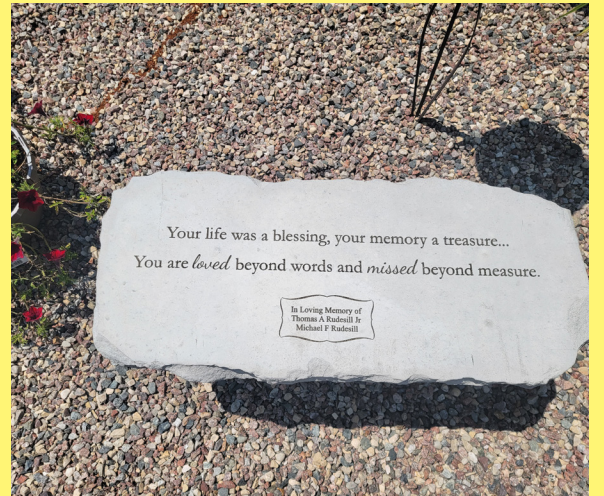
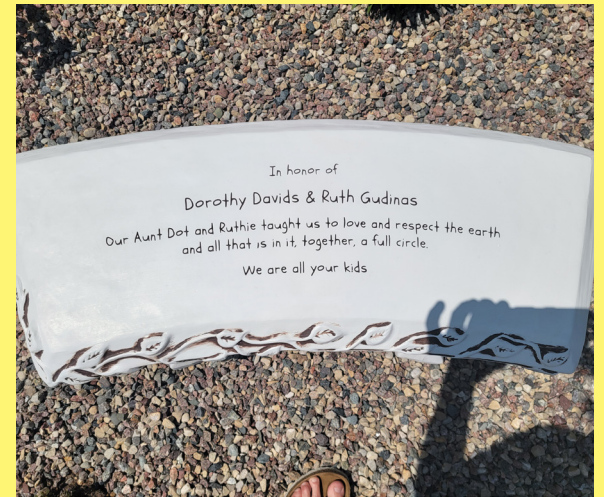
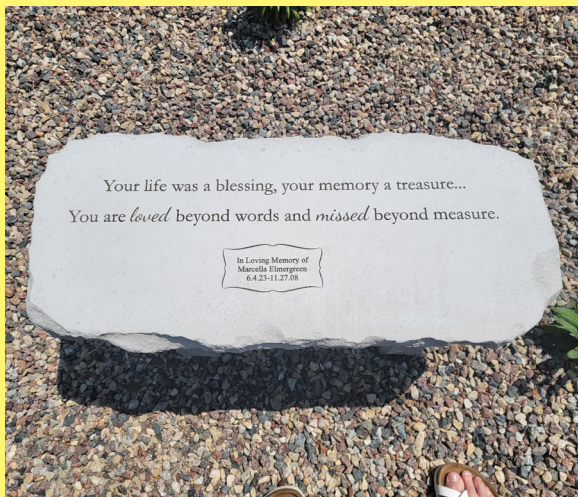
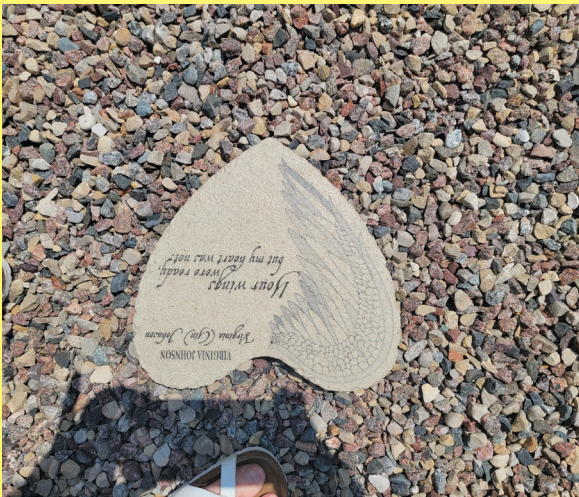
