Community Garden Growing

Kellie Zahn and her helpers have been very busy out in the community garden. They have applied for Grants and looking into new ways off expanding what they have. This year alone the garden has produced over 8,500 pounds of fruits and vegetables. The tribe was awarded a 14 million dollar grant for serving native producers. With this grant Kellie and the tribe aim to grow the garden is many ways. More land for planting and growing was added this year. One big thing Kellie and her team are looking into is the possibility of a food hub space with a commercial kitchen. This would allow not only for more growth of native produce, but also for a way to demonstrate how to prepare and different ways to cook it.

Stockbridge-Munsee The aims to increase Community

access to capital for Native producers by creating economic opportunities and building food resources within the community. With NAAF funding they will create a Native led food hub that will increase economic opportunities for Native producers and increase local food availability within the community.

Wisconsin Governor Tony Evers Signs Executive Order on a Formal Apology for Wisconsin's Boarding Schools and A Declaration of Support for Federal Investigations



September 30th marked a day of remembrance for Indian Boarding Schools. Our own Tribal Courts were out at the Mohican Immanuel Lutheran Indian Mission School and Church promoting the Stockbridge Wellness Court. This day of remembrance came just a couple weeks before the Governor enacted an Executive Order. On Monday October 11th Governor Evers signed an Executive Order at the Oneida Tribe's Norbert Hill Center in Oneida.

The following is the verbatim text of the Executive Order enacted October 11, 2021 by Governor Evers.

EXECUTIVE ORDER

Relating to a Formal Apology for Wisconsin's History of Indian Boarding Schools and a Declaration of Support for Federal Investigations into the Same

WHEREAS, Wisconsin is home to eleven federally-recognized Native Nations and one federally unrecognized nation, including Bad River Band of Lake Superior Chippewa, Forest County Potawatomi, Ho-Chunk Nation, Lac Courte Oreilles Band of Lake Superior Chippewa, Lac du Flambeau Band of Lake Superior Chippewa Indians, Menominee Indian Tribe of Wisconsin, Oneida Nation of Wisconsin, Red Cliff Band of

Lake Superior Chippewa; Sokaogon Chippewa Community Mole Lake Band of Lake Superior Chippewa; St Croix Chippewa Tribe of Wisconsin, Stockbridge-Munsee Mohican Tribe, and Brothertown Indian Nation;

WHEREAS, the state of Wisconsin, through this Order and Executive Orders 18 and 50, reaffirms and recognizes the sovereignty of Wisconsin's Native Nations and the culturally and historically significant contributions of Indigenous peoples;

WHEREAS, for over a century, between the 1860s and 1970s, the United States government induced and coerced thousands of Native American children from their families and their homes and placed them into boarding schools operated by the federal government and religious organizations; WHEREAS, Indian schools sought to force assimilation of Native American children by isolating them from their cultural identities, punishing them for speaking their native language or practicing their traditions, prohibiting them from wearing traditional clothing, and requiring children to cut their hair;

WHEREAS, lack of documentation presents challenges for understanding the full scope and effects of boarding schools in Wisconsin and across our country, but identifying and collecting relevant, available information is an essential step in acknowledging this history and moving forward with truth and healing;

WHEREAS, records indicate that, in Wisconsin, at least ten day and boarding schools were operated by the federal government and religious organizations, and thousands of Indian children are estimated to have been forced to attend day and boarding schools;

WHEREAS, it is also estimated hundreds of Indian children from Wisconsin were also forced to attend out-of-state boarding schools in places like Pennsylvania, South Dakota, and Virginia;

WHEREAS, conditions in Indian boarding schools were condemned by investigators even in 1928 as "grossly inadequate" and in 1969 as "sterile, impersonal and rigid, with a major focus on discipline and punishment":

WHEREAS, by 1926, nearly 83% of Indian school-age children were attending boarding schools in the United States but because the majority of the schools' records have been lost or destroyed, a full understanding of the Indian boarding school policy and its impact is un



WHEREAS, through independent research, the National Native American Boarding School Healing Coalition has located records for only 38% of the 367 Indian boarding schools they found to operate between 1870-1970;

WHEREAS, on June 22, 2021, U.S. Department of the Interior Secretary Deb Haaland announced a Federal Indian Boarding School Initiative consisting of "a comprehensive review of the troubled legacy of federal boarding school policies";

WHEREAS, the historical trauma inflicted upon Native American children, families, and communities by the federal government via Indian boarding schools resulted in a loss of language, culture, and identity, the effects of which have likely contributed to disparities in health, education, and economic well-being;

WHEREAS, despite the trauma Indian boarding school policies had on Native American communities, along with other acts of assimilation and systemic racism, Wisconsin's Native Nations are still rich in culture and essential to the sucsister; Jyles (Joan) Bowman, and Donna (Brian) Coyhis, nieces and nephews, Paul (Crissy), Reyna, Morning Star, Sharae, Christine, Eva "Baby", and Rose Ann (Nathan), great nieces and nephews; Robby, Joseph, Kimberly, Devon, Sloane (Kasha), Mark, Xavier (Mandy), Derek, Paul (Heavenlee), great-great nieces and nephews, Avery, Ella, Aurora, Carter and Paul, special cousin, Oleyna, and special friend Debbie (John).

cess of the state; and

WHEREAS, while it was the federal government who implemented, directed, or operated these boarding school initiatives and policies, we all bear responsibility for acknowledging the atrocities inflicted on Tribal Nations, and in pursuit of a more just and equitable coexistence, have a moral responsibility to reflect on our nation's history, particularly circumstances where we failed to live up to our highest ideals.

NOW, THEREFORE, I, TONY EVERS, Governor of the State of Wisconsin, by the authority vested in me by the Constitution and the Laws of the State, hereby:

- 1. Formally recognize and apologize for the tragedies inflicted upon Native American communities as part of the federal Indian boarding school initiatives.
- 2. Commit to supporting the Federal Indian Boarding School Initiative by welcoming the U.S. Department of Interior to conduct research and investigate the boarding schools that once operated in Wisconsin.



This marks the third year of grantmaking from the Native American Agriculture Fund in addition to 'fast track' grants distributed in 2018 to organizations following the Keepseagle v. Vilsack class action settlement. Grants awarded increase access to capital and diversify Native American agriculture economies through business assistance, agricultural education, technical support, and advocacy services to support Native farmers and ranchers.

Today's investment will dedicate: \$4.6 million to Community Development Financial Institutions - \$2.2 million to 501(c)3 Organizations - \$1.5 million to Tribal Governments - \$1 million to Educational Organizations - \$1 million to Agricultural Infrastructure - \$2.7 million to Beginning Farmers and Ranchers - \$1 million to Climate Resilience and Conservation.

"Our top priority at NAAF is advancing Native American Agriculture. The 2021 funding announcement provides an additional \$14 million directly invested within Indian Country. Through COVID-19, we have seen the essential need to build and invest in resilient food economies and enhance the work Native producers have been cultivating for generations. Our third round of funding is another step forward improving livelihoods, the land, and the health of our people." said Toni Stanger-McLaughlin, CEO of the Native American Agriculture Fund.

The Native American Agriculture Fund (NAAF) is a private, charitable trust serving Native farmers and ranchers through strategic grantmaking in the areas of business assistance, agricultural education, technical support, and advocacy services. The charitable trust was created by the settlement of the landmark Keepseagle v. Vilsack class-action lawsuit. prepares to introduce her. Half a year ago, in the Spring of

2021, members of the College of Menominee Nation's Sustainable Development Institute held a discussion with CMN Faculty during their in-service. In the meeting, a few faculty members shared the observation that some female students were struggling in their coursework due to the responsibilities that they had outside of school. These responsibilities, like parenthood, housework, etc., were seen to mainly affect them and not most of their male counterparts. With academics becoming another point of stress and a major responsibility in the female students' life, the faculty identified the need to "empower and support women in different areas of life" to help them succeed in their academic, personal, and professional careers.

This notion led to the creation of the Women's Empowerment Summit and Training Conference. W.E.S.T. was developed with the intent of "Empowering women through knowledge sharing, professional development, wellness, and personal growth," as per the mission statement of the planning committee. Through this lens, the committee sought out local, female speakers whose experiences and backgrounds could help empower the women of the community. As a result, the conference invited speakers from all walks of life to share their knowledge with attendees.

Speakers like Menominee Tribal Legislator Rachel Fernandez and Former College of Menominee Nation President Dr. S. Verna Fowler discuss their experiences as women in leadership positions and the path that led them there. Other speakers including Dr. Beatriz Aguilar, a music professor at Edgewood College, and Pilar Gauthier, a doctoral student in UW-Madison's Counseling Psychology program, explore the experiences and patriarchal expectations of women established in music and in the workplace. There are also informative presentations about Missing and Murdered Indigenous Women, presented by Waking Women Healing Institute Director and Founder Kristin Welch, and LGTBQ+ Awareness, presented by Diverse and Resilient's Katie Hamm.

W.E.S.T. also featured presentations that shared techniques to achieve wellness and alleviate stress. Presenters Dulce Moeller and Kimberley Hoffman demonstrate the healing arts of Aztec Reflexology and Reiki Energy Healing as everyday techniques to relieve anxiety and stress. The conference showcased traditional indigenous knowledge and practices such as Iroquois raised bead-

work and medicinal teas based on

the change of seasons by presenters Sandra Wescott-Gauthier and Bonnie McKiernan, respectively. The conference ended with the final presentation from the Stockbridge-Munsee Band of Mohican's President Shannon Holsey. Speaking on the topic of women's evolving role in leadership, President Holsey discussed the challenges that women face when taking on roles of power in their communities; especially in the realm of politics, where every action has a reaction. The rousing speech from President Holsey ended the event on a high note. Anonymous survey results were positive and overall stated that W.E.S.T. was a great opportunity for education, wellness, and self-reflection. One attendee wrote that the conference was "very great, would love to see more positive things like this in the community." Another, who attended with her sister, commented that the event was a great opportunity to "...connect with other women and engage in self-love and to manage time to balance life". Another woman requested that there would be another W.E.S.T., "Please do this again! I really enjoyed today and learned a lot more about myself and others." Yet another attendee suggested that there be "more women in power positions. Their stories/journeys are awesome."

With the speeches over, the raffles drawn, and the vendors vacating their tables, the first Women's Empowerment Summit and Training came to a close. The conference hall, once filled with the energized voices of dozens of women, had settled. A lingering energy hovered over the conference hall, which is summed up best by the words of SDI Director Rebecca Edler. "As women, we are given many responsibilities in the role of mother, sister, grandmother, auntie, daughter, granddaughter, niece, and so forth. We often sacrifice so others do not have to. Today, I challenge you to make a new friend, share an idea, and bask in the wonderment of being a woman."






