### Zahn Wins Farm Bureau's Excellence in Agriculture Award



Kellie Zahn was selected as the winner of the Wisconsin Farm Bureau's Young Farmer and Agriculturist Excellence in Agriculture Award at the organization's 102<sup>nd</sup> Annual Meeting on Dec. 5th.

Zahn is the agriculture agent for the Stockbridge-Munsee Community where she manages the community gardens, teaches classes on gardening and food preservation and oversees the tribe's agriculture lands. She is a Certified Crop Advisor and earned a bachelor's degree in agricultural business from UW-River Falls.

Zahn also enjoys working on her family farm and volunteering in the community.

"This contest highlights individuals who have positively impacted Wisconsin agriculture, Farm Bureau and their communities while motivating others to do the same," said WFBF President Kevin Krentz. "Kellie is an incredible advocate for agriculture and Farm Bureau member."

The Excellence in Agriculture Award is presented to a Farm Bu-

reau member between the ages of 18 and 35 who is actively engaged in agriculture but derives the majority of his or her income from an off-farm agricultural career. The winner is selected based on his or her knowledge of agriculture, leadership in Farm Bureau and other civic organizations.

Zahn has been a Farm Bureau member since 2012 and serves as a board member and YFA Chair for the Shawano County Farm Bu-

Zahn will compete at the American Farm Bureau Federation's Annual Convention in Atlanta, Georgia in January and receive \$1,500 from GROWMARK, Inc. All finalists in the Excellence in Ag competition will receive a jacket courtesy of GROWMARK, Inc.

Tribal Council Makes Changes to the

proved changes to the Mohican Loan Program. Several important changes were made that open the home loan program to a greater number of Tribal members.

Loan Program

Those changes include the following: increase loan application fee to \$25 (previous fee was \$20); increase maximum purchase amount to \$150,000 (previous maximum was \$130,000); home purchases or home improvements loans will be available to tribal members who reside in Shawano, Langlade, or Waupaca counties; clients will be able to refinance their current loans to take advantage of lower interest rates: consolidate Home and Home Improvement Mohican Loans for one monthly payment; all marital income and debt will be calculated for debt ratio purposes;

home loans will accrue interest at the fixed rate plus. 10 basis points (.10%) above the current monthly Applicable Federal Rate (AFR); and, Credit Bureau Reporting will be done on all applicants.

The purpose of the Stockbridge-Munsee Community home loan program is to remediate historical barriers to home ownership by tribal members through a governmental program that provides home loans to members on favorable terms.

The Mohican Loan Program is a revolving loan fund, not guaranteed funding by the Stockbridge-Munsee Community. This means the Tribe has a limited percentage of the loan fund capital that is considered to be cash available for home loan lending. The cash available for lending each fiscal vear is 25% of the balance in the

Kori Price started the program in 2000. Price Stated "So it all started when we decided to decorate our doors for Christmas, we made big stockings and put things that we wanted in there. So, I had a new car picture and \$100 bills, and my boss had a diamond ring and money to, we filled our stockings with our Christmas list. At the time I was the General Assistance, Tribal Tanf and Income Maintenance worker. So, I took care of all the clients that needed assistance. The Giving tree idea came about,

when clients were requesting help or other resources for gifts for Christmas and I didn't know of the Toys for Tots program, So I came up with the giving tree. I made a big tree out of paper and mailed out Christmas bulbs for the kids to color and put some gift ideas. I then sent out flyers to departments and community members. They would come into the Economic Support building and pick a bulb. We would collect the gifts, wrap them, and deliver them to the

revolving loan fund as of October 1st of that same fiscal year. The balance in the revolving loan fund excludes outstanding funded loans as well as loans that have been committed or approved but have not yet been funded.

One of the important factors Tribal Council is including in the process is that the loans are for a member's principal residence. This term means the home that a person occupies and maintains as his or her permanent place of residence. According to the policy, a person may have only one principal residence at a time. The policy also states that a person's principal residence will not be affected by the member's temporary absence from the home because of military service, education, temporary relocation for employment or health reasons, incarceration, or other similar reasons. It is specifically meant to not include residences used primarily as a second home, vacation home, or rental property.

Requirements for being eligible for the home loan program include that the applicant must be an enrolled member of the Stockbridge-Munsee Community who is at least 18 years of age. Applicant must be employed for a minimum of one year or have other countable income for a minimum of one

year or a combination of the employment/other allowable income for a minimum of one year. The Tribe will verify income through the following information: applicant must have a Debt Ratio of forty percent (40%) or less; applicant's mortgage payment amount cannot exceed twenty-five percent (25%) of verified income; applicant must demonstrate the ability to repay the loan. Notwithstanding any other provision of these policies, the Tribe will not approve a loan unless it has determined that the borrower will repay the loan.

them to the parents so they could use them as gifts for Christmas. As the program continued, I would ask the kids to color a picture, make a card or a craft and we would send it to the person that purchased a gift for them as a thank you".

Rolanda Bierman came on board at Economic Support back in 2007 and continued on with the program. They have served anywhere from 15-89 children a year. the highest year being 89 children served back in 2011. Rose came on board in 2014. Crystal Malone doesn't remember how long ago she has been a part of the program.

Each child is given a "bulb" or 2 to decorate and put a gift idea on the bulb for the "giving tree". Each year employees and community members come and choose a bulb or a few to shop for. The bulbs that were not chosen, we would raise funds for and shop for those gifts for the children. Once gifts are all collected our department would make sure each family got their gifts. Some years we would collection donation and raffled them off to raise the funds. Some people would just donate \$\$ to the program. We even had a "change war" 1 year to raise funds.

The program is still running strong today, thanks to all of our loving employees and community members who take the time to choose a bulb or two and shop for the children every year to ensure that they have a Christmas.

# End of Year Covid Update Thomas Kazik II- News Reporter and

This is the Most recent Covid Update from Our Tribal Health Department. COVID-19 testing statistics completed at the SMHWC through 12/17/2021. The Total Number of people tested is 7,813 that 191 more since last reporting period. The number of Total Negative Counts is now at 7,328and there are 11 tests pending. the Total Number of Positive Cases is 474, that's 11 more since last reporting period. The Total Positive Cases who live in Shawano or Menominee counties is 433. Our community has had 21 people hospitalized during Covid. We Currently have 11 positive cases, 460 recovered cases and have lost 4 people due to Covid, 3 of which were tested at the Clinic.

The most recent Vaccination Data is as follows. 6,671 doses of Covid-19 vaccines have been administered by the Tribe as of 12/17/2021. Our Count of fully vaccinated people is now up to 2,771. The number of people who received both doses of vaccination (Pfizer or Moderna) is 2,631. Count of people who received first dose of vaccination and are awaiting 2nd dose (Pfizer or Moderna) is at 258. Count of people who received a 3<sup>rd</sup>/booster dose (Pfizer or Moderna) is 1,011. Count of people who received single dose (Johnson & Johnson) is at 140.

Wisconsin is still seeing increases in Covid-19. Wisconsin's 7-day average percent positive is 11.6%. Shawano County had 242 new cases in the last reporting cycle

and continues to experience a high rate in covid-19 transmissions https://covid.cdc.gov/covid-datatracker/#county-view Wisconsin is currently ranked as the 5th highest rate of transmission in the United States.

The Omicron variant has shown to be more contagious than previous variants. Some studies are showing the Omicron variant can infect 70 times faster than the Delta variant. Please wear a mask and consider getting a booster dose. The SMHWC is offering booster doses to anyone age 16 or older. To be eligible, you must have completed either a Pfizer or Moderna vaccination series at least 6 months ago; or received a Janssen vaccine at least 2 months ago. Please call the clinic to schedule your booster dose 715-793-5000.

On December 16th, 2020, a little over one year ago, we gave out our first dose of Covid-19 vaccine. Since that date, the clinic staff have given more than 6,600 shots! As we enter the third year of the Covid-19 pandemic, I (Andrew Miller) want to thank all the clinic staff and all the other employees who have worked diligently to address the everchanging COVID-19 pandemic. Please do us a favor by getting your vaccine including your booster dose and wear a mask. Please stay strong in our fight against Covid!

- A lab technician will have you enter the building
- The lab technician will confirm your information and collect a nasal swab






