#### **Positive Counts**

COVID-19 testing statistics completed at the SMHWC through 4/22/2022.

Total tested = 9,297 (+ 34 since last reporting period) Total Negative Counts = 8,596 Total pending = 0 Total Positive Cases = 701 (+1 since last reporting period) Total ever hospitalized = 24 Active cases = 1 Recovered Cases = 700 Deaths (tested at clinic) = 3 Total deaths = 4

#### **Vaccination Data**

7,083 doses of Covid-19 vaccine have been administered by the Tribe as of 4/22/2022.

- Count of fully vaccinated people: 2,868
- Count of people who received both doses of vaccination (Pfizer or Moderna): 2,711
- Count of people who received first dose of vaccination and are awaiting 2nd dose (Pfizer or Moderna): 212
- Count of booster doses given: 1,292
- Count of people who received single dose (Johnson & Johnson): 157

#### **State and County Counts**

Coming out of high school, I decided that I wanted to follow in my mother's footsteps and pursue a career in accounting and finance. I always had a love of numbers and mathematics. Doctor Lundin of the Stockbridge-Munsee Health and Wellness Center spoke to the those in attendance on the negative impact drugs and addiction can have on people. How drug use and addiction can affect the health of not only an individual but also an entire community.

Stockbridge Munsee Lieutenant Creapeau spoke to the assembly on potential fine cost if you are caught vaping underage. Federal law changed in 2019, in compliance with federal law the state raised the minimum age for purchasing tobacco and vaping products from 18 to 21.

# R CULTURAL LANDSCAPE

Culturally Responsive Education Conference



On February 26, 2022, Sandee Barton, the Training Coordinator Stockbridge-Munsee for the Community, presented at the Culturally Responsive Literacy Education Conference cohosted by the University of Alaska Southeast School of Education and Sealaska Heritage Institute.

The presentation titled, Utilizing Indigenous Instruction Design to Support Culturally Responsive Literacy Practices in the Classroom, was presented via ZOOM. The conference for educators, policy makers and support staff at educational institutions stressed importance of culturally responsive teaching.

This is extremely important as the majority of students are of Indigenous background and the educational system must start recognizing the necessity culturally responsive practices.

Each of the presentations had a storytelling or literacy-focus thereby connecting with literacy practices. Other participants could then include the lessons in their classrooms or educational

environments to help students with literacy strategies for learning.

Dr. Barton was asked by Katie Olson, an Associate Professor at Alaska Christian College, to discuss her Standard Model of Indigenous Learning (SMIL for short). Katie is using the SMIL in her classes with significant results and decided to submit a proposal.

discussed development of the SMIL, the five threads of the model, and the template Katie developed showing how to incorporate the threads of the SMIL into lesson plans. In addition, Sandee explained the different strategies Katie uses in her courses to support the learning and literacy of her students, the majority of them being Indigenous to Alaska and living on their Homelands.







He was a member of the Stockbridge Bible Church.



#### **At home Covid Tests**

The Clinic is offering free at home covid-19 test kits at our front desk. If you test positive on an at home test, please notify contact tracing at 715-881-0872. If you are an employee, please also inform your supervisor.

#### Covid-19 Second Booster Shots

FDA and CDC approved a second booster (4th dose) for certain eligible people.

#### Who is eligible?

- Anyone over 50 years old is eligible if you received a first booster (3<sup>rd</sup> dose) more than 4 months ago.
- Immunocompromised people may be eligible for up to a 5th dose, please consult with your primary care provider.

#### How can I get my booster?

The SMHWC is offering booster doses to anyone who meets eligibility requirements. You can schedule a booster at the SMHWC by calling 715-793-5000.

#### Can I call to see if I am eligible for a booster?

If you have questions about eligibility for a second booster (4th dose), you can call the SMHWC triage line 715-793-5087 to see if you are eligible.

#### What vaccine were approved as a second booster (4th dose)?

FDA approved both Moderna and Pfizer as a second booster (4th

#### If I received Jansen vaccine in the past, am I able to get the second booster?

If you are over 50 or meet the immunocompromised conditions and received Janssen for your primary and booster dose more than 4 month ago, you are eligible for a Moderna or Pfizer as the second booster. Please let the medical team know that you received Janssen vaccine in the past.

Much of the doings that took place happened outside of the public eye and days before the reinternment. At 9:30am on that morning a work detail moved a box to the burial site. At 10:00am a burial Ceremony began with tribal delegations in attendance. Tribal leaders in attendance provided greetings, welcome, and statement of purpose which is provided here:

Chief Brad Killscrow – Delaware Tribe said, "This Historical Event for our People and what has taken place the last few days to our ancestors, we want to reassure that this never happens to them again. That they are not unearthed or disturbed so they can continue their journey to the spirit world and be free. Our Ancestors paved the way for us to be here today. Therefore, we're still here with Lenape blood still running through our veins. It's very important that we honor our ancestors and remember them. It has been a very emotional day, especially for our tribal members who came up here from Oklahoma and wrapped the remains of our ancestors. It's been emotionally, physically and spiritually draining. We got through it, our ancestors are ready to continue their journey, and not sit in a museum anymore to be looked at as a novelty museum collection. I feel good today what we have accomplished and on behalf of the Delaware Tribe of Indians I want to say Wanishi (Thank You)".

President Deborah Dotson - Delaware Nation of Oklahoma, said, "I want to say thank you to everyone for being here on this momentous day. It's a happy day and a sad day, a happy day because we're getting to put them back and it's a sad day that we must do it. I want to say to the ancestors, we are resilient, we are still here, we are many, we are prospering and rest easy".

Chief Denise Stonefish

Delaware Nation said, Eelunaapeewi behalf of Lahkeewiit (Delaware Nation) from Moraviantown in Canada, we give thanks for this day too. The ancestors have not only brought us together again, as the five Lenape Nations. As it is an honor to be here with everyone, I want to say yes, we are here, too. I met a young New Jersey history teacher, yesterday at the Bushkill Falls (Pocono) who asked if there is one thing you want to tell these students, "What would it be?". I said that "The Lenape are Still Here". For the ancestors, we give you thanks and may you rest peacefully once again, ...in our homelands. Anushiik Kiisheelumukweengw (Thank you Creator)".

President Shannon Holsey Stockbridge-Munsee Community said, "Today represents an opportunity to come together with our Lenape brothers and sisters and unify and honor the return our relatives and share in something that is so important and sacred to our Nations, it also allows us to bring light to the invisibility of our people and lack of value that we still face centuries later. We stand on the shoulders of our ancestors who sacrificed so much for us to be here and survive. I just want to say annishuk to our relatives and to tell them that we will never forget, and that we will continue to do what we have to do until they all find their rightful and peaceful resting place. The work is never done when it comes to NAGPRA this scared endeavor it is not just a utilitarian endeavor but an emotional and intimate one as well. To reclaim artifacts, tribes currently undergo an expensive process overseen by the museums and universities they are petitioning. Repatriation requests are processed through guidelines created by the institutions, which also decide if the evidence presented satisfies their own criteria.

Some institutions have yet to inventory all the human remains and burial objects in their care as mandated by the law. The

original deadline to complete inventories was 1995. been Enforcement has also inconsistent, carrying little penalty or support to prosecute institutions that flout the rules. Our country is at a precipice at thinking about how to come to terms with the horrendous ways it has treated our people, how to address that history, and how to ensure that it never happens again. We must continue honor our people and uphold our sovereign authorities as the indigenous people of this land, and to most importantly uphold the sanctity and duty we carry as tribal nations to find respectful ways to honor our relatives through repatriation".

Chief Roger Thomas - Munsee Delaware Nation of Canada said through another council member, "Welcome to everybody and it's good to see everybody here today, and to be back in the lands of our ancestors. It must have been very hard to leave the villages and locations of the land we lived and prospered in for thousands of years. To have to leave the graves our ancestors behind as well it must have been a very traumatic experience. I want to thank those who have been involved over the past year or two to put everything together and bring us here today to honor the graves of our ancestors and to be here with them now to say we aren't gone; we are still here again Anushiik".

A Council Member of the Delaware Tribe of Indians said, "It's good to see everybody here, meet new people; we'll go away friends. These guys will have a good journey home. I wore my moccasins today so I could walk on the same land that our ancestors were on, remember that as you walk across this ground, and as we take our journey back to our home wherever we may live, by the time we get home our

ancestors will be home".

Joe Brooks Delaware Tribal Council of Oklahoma said, "First of all I want to say thank you to the Creator. It's a sad day but it's a happy day that our ancestor gets to go home, this is the fourth time that I've done this. I don't enjoy it but it's a happy day to see it. I also want to think the tribes for being here. It's a good day and I know our ancestors will all join back together, the ones in Ohio, Ellis Island, wherever they might be that they will all be together in the spirit world. And that's a happy day. One day we will join them also".

Chief Jeremy Johnson Delaware Tribe of Indians ended the speeches eloquently by saying, "I just want to say Anishuk to everyone. It's been a long journey to get to this point. I thank everyone for all your help, the young ones here, without our relatives we are nothing. This is what it means to be Lenape right here, to gather in times that are hard, to come out in a celebratory manor with happiness in our hearts, because we know we've done a good job. That's why I stand right now with tears of happiness and relief that my ancestors have been taken care in the best way we know how, and we were taught. We can pass this down to the generations standing here witnessing this now. For that I am thankful, I am not happy about the reason, but I am thankful the result".

A prayer was offered and those in attendance were afforded the opportunity to place some tobacco on the last box to be buried. Other invited guests and representatives from partner institutions arrived the proceedings moved and the Pennsbury into Manor. reinternment took place The at Pennsbury Manor to protect the burial site from any further intrusion.



The Public Health Order ended on April 8, 2022 which means Elderly Services is now fully open! We continue to ask that you sign up twenty-four hours in advance (if possible). You can come in and sign up or just give us a call (please leave a message) and we will sign you up for the day of your choice. This ensures that Rides are provided daily to there is enough food cooked for all and that a place is set for you at the table.

Non-elders <u>also</u> are welcoming to join us at a Charge of \$2.00 per meal, please sign up 24 hours in advance. Elders are our priority. No Elder will be turned away.

A Birthday meal celebration is held on the last Thursday Some of each month. holidays are celebrated at the birthday meal; our favorites are Valentine's Day, St. Patrick's Day, Halloween, Thanksgiving and Christmas.

We deliver hot meals to over thirty+ homebound recipients who reside in our service area which encompasses the townships of Bartelme and Red Springs. To be eligible for a home delivered meal an elder will be visited by Aging & Disabled Services staff, who will do an assessment, which basically measures how well the elder can care for themselves, ADL's (Activities ofdaily living skills) and IADL's (Instrumental Activities of Daily Living, such as paying their bills, able to ambulate,) what areas they need assistance and is made from this decisionmaking tool. If a recipient is not home at the time of delivery a meal is not left at the home. Information about the assessment visit.

Meals be set up can be delivered to on а basis permanent with annual assessments or on a temporary basis as needed. Requests/referrals can be made by anyone, just call the Elderly Services Manager at 715-793-4236, or talk to your medical provider and let them know if you feel you have a need for a home-delivered meal.



#### **Facts About Falls**

# Per CDC fall death rates in the US increased by 30% from 2007 to 2016

"Each year, millions of older people-those 65 and older-fall. In fact, more than 1 out of 4 older people fall each year, but less than half tell their doctor. Falling once doubles your chances of falling again. American Indian/Alaska Native elders report the greatest percentage of falls (34.2%) of all races/ethnicities".

#### Falls can be serious and costly

- Falls are the most common cause of tramatic brain injury (TBI)
- More than 95% of hip fractures are caused by falling, usually by falling sideways
- 1 out of 5 falls causes serious injury such as broken bones or a head injury

#### Side effects of a fall

- After a fall, even if no injuries occur, many people may become fearful of falling and decrease their daily activities. When a person is less active, they become weaker and this increases their chances of falling
- May have broken bones or may cause head injury

#### What can make you more likely to fall?

- Lower body weakness
- Medication side effects
- Vision problems
- Foot pain/soreness and poor footwear
- Home hazards (e.g. throw rugs, uneven/broken steps, clutter can be tripped over)

## What are some things you can do to prevent a fall?


