I would like to share a small portion of Mohican/Munsee culture and tradition. I want to share a little about the "Celestial Bear" ceremony and time of year it represented. I will not share all details of this story as it is not always a good thing to share everything about Native ceremonies and their intricate details just to anyone especially online. I will share what I think is enough to explain the time of year and give a short description of the last Bear Sacrifice ceremony.

The Celestial Bear coming to earth marks a time of the year. It is the new moon of January. We as Natives mapped the skies as well as did other cultures around the world. We held celebration times Solar/ during certain such universal events as Solstice, Equinox etc. Many of Worldwide Native celebrations had much to do with certain events for they marked a passage of time. Even as Indigenous people we were obsessed with keeping time. Keeping an eye on the heavens helped us plan the near future.





how historic trauma has affected the attachment patterns of Native American adults. This theoretical relationship has never been quantitatively examined regards to Native American historical trauma. His study aims to elucidate some of the relationships between historical trauma and how it is transmitted intergenerationally. "It's an honor to participate inselecting Indian Country's best and brightest minds that are working toward the advancement Indigenous communities through science preservation of traditional culture and art," Posselt says. Moon cont from pg One: are around the world, the new moon of January was followed by 12 new moons of the year. Each moon or "Month" was approx. 28 days until the next (13 total). The New Moon of January marked the "New Year." At this time, it is said by our Mohican/Munsee that "The ancestors Celestial Bear" returns to earth. The "Celestial Bear" is exactly "The big Dipper" constellation. It is at this time that the Big Dipper is closest to the Northern horizon and earth than it is at any other time of the 13-month year.

Just as other ancients, we referred to this constellation as "The great Bear, The Celestial Bear, the Big Bear (There's also a "Little bear" which is the Little Dipper)." Anyway, this constellation wields great energies.

In Many Native cultures, the Bear is a wise and most importantly a healing Its body, fur, bones, fat, meat, all used in medicinal healings. The belief is that the great power of the Spirit Bear/ Celestial Bear is very strong at this point being so close to the earth. It is at this time our Mohican/Munsee celebrated the Spirit Bear and all its healing qualities.

In the early 1900s a Mohican Munsee by the name of "Nekatcit" (Molly Miller I may have spelled that wrong please correct if I did.) Who sat down with a writer to document his knowledge of the Bear Sacrifice ceremony and his knowledge of the very last one to have been performed in the mid-1800s. He was a very young but learned from the elders who used to perform this ceremony. I am about to share based only on my memory of his story, but I am leaving out many intricate details. For those seeking the

intricacies of this story, you will have to personally find someone who can sit down and share them with you. There are too many for me to type all out, plus some things aren't for internet.

In the not too far off past, there was in the midst of the joined Mohican/ Munsee nation; a yearly celebration that took place among the peoples. It was called the "Celestial Bear Ceremony" which was held at the beginning of the New Moon of Jan and lasted for 12-14 days until the full moon arrived.

The beginning of this ceremony called for the sacrifice of a bear, and its body to be consumed during this 2-week celebration. It would begin with a woman from the people who had the gift of vision. She would dream of where the right kind of bear would be found.

During the last known ceremony, a woman from the village had such a vision in where to find this bear. She did relay her vision to the Chief of the ceremony where it could be found. The Chief then instructed 12 men to go and find this bear. Once the bear was found in its hibernating spot, they would awaken it and lead it back to the Big House where the Chief would be waiting.

I believe the Chief and the 12 men's number reflects the 13 months of the year. The chief was to await the bear to be led to the Big House where only the Chief was to make the kill. The killing of the bear was very humane and painless. They used a strong club with a ball on the end to strike the bear with one death blow to the head.

So, in following the vision of the Woman who had that gift of sight, the 12 men followed her directions and came upon a tree where the bear lay hidden

up inside. The lead man would pound on the tree 3-4 times and say "Bear! Wake up! We need your body for the ceremony!" When they heard nothing the lead man would repeat the pounding and telling the bear to awaken.

Finally, the bear awoke and climbed down. Sitting on the ground still groggy from his slumber he held his head low to the ground. The lead man said "Come bear! Follow us to the Big House! The old man (Chief) is waiting for you!" So the bear followed the men with absolutely no problems. But so far along the trail the bear sat down and did not move anymore. The lead man said "Bear! Get up! The old man is waiting for you at the Big House!" But the bear just sat there with his head hung low.

Finally, the lead man said "Bear! If you don't follow us to the Big House, we shall have to sacrifice you right here!" But the bear still did not move. So the lead man told one of the other men to go to the Big house and tell the Chief that the bear will not come.

After some time, the Chief arrived with the messenger back to the spot where the bear was sitting. The Chief said "Bear! Get up and follow us to the Big House! We need your body for the ceremony!" But the bear still sat there with his head hanging low. The Chief then said "Bear! If you do not come, we will have to sacrifice you here!" Still the bear remained..... So, with one precise swing, the Chief killed the bear instantly.

Then, the men carried the bear back to the Big House. There were women waiting to cut up the bear and begin processing it for the 2-week ceremony. One young man was left with them to assist in any way they needed.


After the Bear was skinned, the Chief took the hide into the Big house. In the middle of the Big House there was a center pole. On this pole wrapped and tied was the hide from the bear that was sacrificed the previous year. He would untie the old hide, and re-tie the new one to the post.

This was the beginning of the 2-week celebration in honor of the Spirit of the bear and all its qualities. Each night there was a feast, dancing, sharing of visions of the previous year and of the year to come. Many ceremonies happening in celebration of the New Year, and the Celestial spirit Bears return to earth.

the Αt end of the celebrations Chief the would give a speech. He would give advice to all who came about making good decisions and living life in the right way. He would talk of the importance of family and community and our responsibilities to each other, telling us not to argue and fight, not to take our brothers wife home (That was really said lol).

This was a new year, and a time of healing, growing, and sharing in respect to the Spirit/Celestial Bear. A time of New Year resolutions, chasing your visions, healing broken relationships and growing as a community.

This story is known by many in our community; some people do still recognize this time of year and do our own modern respecting of this time. At the time of the 1800s, this ceremony was only being done by very few traditionals. Eventually stopped. it This man Nekatcit knew of its importance and had allowed his knowledge to be document in its entirety. # What to do if you fall





If you think you can get up safely without help, roll onto your side, and into a sitting position slowly so your body and blood pressure can adjust.

> Slowly get up on your hands and knees, and crawl to a sturdy chair. Slowly place your hands on the chair, so you are in a kneeling position. From the kneeling position, keep one leg bent with your knee on the floor and slide the other leg forward so your foot is flat on the floor. Slowly rise and turn your body to sit in the chair.

Keep yourself prepared for a fall by keeping a well-charged mobile phone or cordless phone with you at all times, and/or have an emergency response system (e.g. Lifeline) ready.




